Appellant originally filed with PTAB on 7-25-08. A requested extension of time was granted and expired on 4-18-09. The appeal was dismissed on 11-12-09 for lack of evidence. Upon review, additional evidence was not submitted per original request. Per correspondence dated, 11-18-09, appellant is requesting that PTAB reinstate the above appeal. Request states that three copies of the appeal form and two copies of an appraisal were mailed to our office on 3-27-09. Appellant enclosed a cover letter and a U.S. Postal Service certified mail receipt with postmark stamped 3-27-09 but neither article references a docket number. PTAB's mail log does not indicate that evidence was received during this time frame containing the above docket number.

Appellant originally filed with PTAB on 6-4-08. A total of 90 days was granted for the submission of evidence with the latest extension expiring on 6-20-09. Appeal was dismissed for lack of evidence on 9-22-09. A review indicated that additional evidence was not submitted within this time frame. Appellant is requesting that PTAB reinstate the appeal and included evidence with the request. Appellant, by letter in an affidavit, states that the last extension granted by PTAB was not received. A copy of the granted extension is in the file and the original was not returned to PTAB.

- t. Mohammed Iftikhar: #07-27784-R-1 (Cook – Hyde Park)

Appellant originally filed with PTAB on 7-24-08. Appellant states on original filing that an extension of time to submit evidence is requested. A total of 60 days was granted to appellant per original request. Appellant submitted evidence within the time frame given by PTAB. A review of the evidence indicated that it was not sufficient to go forward and the appeal was dismissed on 10-1-09. Appellant is requesting that PTAB reinstate the appeal and states that PTAB should have returned the appeal and treated it as an incomplete if the evidence submitted was not sufficient. Basis of appeal is recent sale. In support of this argument taxpayer submitted a copy of a deed with transfer stamps that counsel indicates reflects a purchase price of \$210,000. Appellant failed to submit closing statement, Illinois transfer declaration "green sheet", or sales contract documenting sale. Additionally, appellant did not complete the Residential Appeal form providing a description of the subject property nor did the appellant complete that portion of the Residential Appeal form documenting the sale of the subject property.
