Appellant originally filed with PTAB on 9-14-10. PTAB granted a 90-day extension expiring 7-13-11 per a request from the Appellant. The above appeal was dismissed on 12-23-11 with no evidence in file. Per request dated, 12-31-11, Appellant is requesting PTAB reinstate the appeal and have included a 2010 appraisal report. Appellant determined it would not obtain a new appraisal for 2009 but would submit the appraisal report prepared in conjunction with the 2010 assessment year. However, the Appellant failed to forward the documentary evidence in accordance with the evidence extension deadline.

ccc. Brian Friedman: #09-23644-R-1 (Cook - Niles)

Appellant originally filed with PTAB on 7-14-10. A total of 120-days has been granted for the submission of evidence with the latest being a Final Extension. Appeal was dismissed on 1-11-12 after a review indicated that evidence from the Appellant was never received. Per request dated, 1-31-12, Appellant asks PTAB to reinstate the appeal and has provided evidence. Appellant states that the Final Extension letter from PTAB was never received.

ddd. Lawrence J. Trapani, Sr.: #09-05293-R-1 (Sangamon)

Appellant originally filed with PTAB on 5-4-10. A review of the appeal indicated that the 2009 BOR decision was missing from the filing. Appellant was notified with an Incomplete Letter and checklist with a 30-day extension to return information requested. Information requested by PTAB was not returned and appeal was dismissed on 1-24-12. Per request dated, 1-30-12, Appellant is requesting PTAB reinstate the appeal and states that all required information was sent with original filing according to the township assessor. The requested information, BOR decision, is not included with reinstatement request.

eee. 3701 Algonquin Road LLC: #09-25997-C-3 (Cook – Elk Grove)

The appellant has filed a Motion to Withdraw the Appeal.

The intervening school districts filed a Response Objecting to the Motion to Withdraw. The response mentions the efforts of the school districts to complete an appraisal and also asserted that the taxpayer has filed a Certificate of Error with the BOR, which is still pending. The school districts are concerned that they will not be able to pursue their undervaluation claim.

PTAB Rules under Section 1910.50(j) states as follows:

The contesting party may, at any time before the hearing begins, move to withdraw or voluntarily dismiss the appeal, by written request filed with the Board and all other parties to the appeal. Motions to withdraw or voluntarily dismiss an appeal are favored by the Board and will be denied only in the most extreme or compelling circumstances.

In construing this rule, the court in *Minooka Comm. High School Dist. No. 111 v. PTAB*, 397 Ill.App.3d 823 (3<sup>rd</sup> Dist. 2010), held that extreme and compelling circumstances precluded the taxpayer from taking the voluntary dismissal without giving the school district an opportunity to present their evidence. In reaching this decision the court considered the efforts and expenditures on the part of the school districts to gather evidence supporting their claim, together with the PTAB's own rule giving taxing bodies the right to intervene. Minooka at 829.

While the Motion to Withdraw has been pending intervening school districts have submitted an appraisal estimating the subject property had a market value of \$15,650,000 as of January 1, 2009. The subject has a total assessment of 25%.

fff. Kyun Se Seok: #08-23126-R-2 (Cook – Oak Park)

Appellant originally filed with PTAB on 4-9-09. An initial review of the appeal revealed an incomplete filing. An Incomplete Letter and Return Checklist were mailed to Appellant on 2-4-10 with a 30-day extension to return required information to PTAB. Information was not returned to PTAB and the appeal was dismissed on 8-18-10. Per information received 3-2-12, Appellant is requesting a Motion to Vacate the Dismissal/Closure of file 08-23126-R-2. Motion states Taxpayer's counsel and Cook County Board of Review met on 1-21-10 and settled the 2009 BOR appeal and pending 2008 tax year (08-23126). Motion further states Counsel for Taxpayer recently learned "by chance" that this case was closed when viewing the computer's Case History screen. Upon further investigation, counsel learned that a request for further documents was sent by PTAB but has no record of receiving this notice.

ggg. Cathay Bank: #08-23844-C-3 (Cook – S. Chicago)

Taxpayer, Cathay Bank moves for a Default of Intervenor, Board of Education of the City of Chicago. Taxpayer believes that Intervenor has not submitted evidence and/or a timely request for an extension of time. A review of this appeal finds the Intervenor adopted the evidence filed by the Cook County Board of Review in a timely manner.
