On 1-26-12, PTAB defaulted the Intervenor for lack of evidence/second extension request. Per correspondence dated, 2-2-12, Intervenor is requesting a Motion to Rescind Default. Motion states that on 12-16-11, a timely request for an additional extension of time was filed with the PTAB. A copy of the extension letter is included with the Motion. Intervenor respectfully requests that the PTAB rescind its order of default and grant the request for additional time to file evidence forthwith.

- yy. One Earth Energy LLC: #09-00838-C-3 (Ford)

The Intervenor has filed this Motion to Reconsider Final Extension and Issuance of Formal Discovery Subpoena.

This appeal is from Ford County and involves a 183 acre tract improved with a 100,000,000 gallon per year ethanol manufacturing plant. The appellant filed the complaint alleging overvaluation as well as the fact the Ford County Assessing Officials are improperly classifying certain items of machinery and equipment as real estate for assessment purposes.

The intervening school district has been granted 180 days in extensions (two-90 day extensions) with the last extension being a Final Extension set to expire April 17, 2012.

The School District intervened in the appeal on 6-27-11, which was acknowledged by the PTAB on 9-15-11. PTAB granted the School District a 90-day extension on 9-15-11 and again on 1-18-12, which was a Final Extension. By letters dated, 6-21-11 and 2-6-12, the School District requested information from the Appellant's counsel regarding documents provided to Appellant's appraiser and detailed information regarding items claimed as personal property, etc. The School District states the taxpayer has failed to provide documents. On 3-23-12, School District's expert witnesses visually inspected property.

By way of background, with respect to the real property v. personal property issue, the PTAB has previously issued a decision from a Ford County appeal which was affirmed in Board of Education of Gibson City-Melvin-Sibley Community Unit School Dist. No.5 v. Property Tax Appeal Board, 354 Ill.App.3d 812 (4th Dist.), wherein the court agreed with the PTAB's interpretation of the Freeze Act (35 ILCS 200/24-5) that focuses first on whether a pre-1979 practice for assessing equipment existed. In that appeal the court stated that the PTAB's finding that a pre-1979 Ford County practice existed **not to assess** machinery and equipment was not against the manifest. 354 Ill.App.3d at 818. That appeal involved power generation equipment at a peaker plant. The evidence in that appeal did indicate that Ford County had prior to 1979 assessed certain grain handling equipment at grain elevators, which was not similar to any of the equipment at the peaker plant.

School District requests the PTAB:

- (1) Reconsider the final nature of the 4-17-12 deadline.
- (2) Issue a subpoena ordering One Earth Energy to respond to discovery requests made by School District on 6-21-11 and 2-6-12.
- (3) Allow School District 30-days thereafter to submit evidence to the PTAB.

Recommendation: Deny request to Reconsider Final Extension.
