Appellant failed to show and the appeal was dismissed for failure to appear on 8-13-12. Per correspondence dated 8-22-12, Appellant claims hearing notification letter from PTAB was not received. Appellant further claims that there is a history of other important documents not received at their present address. Appellant is requesting the PTAB reinstate the appeal and reschedule a new hearing.

- qq. North Star Trust Company: #09-28088-R-1 (Cook – N. Trier)

By letter dated 6-29-12, the above appeal was rescheduled for hearing on 7-20-12. The Appellant failed to appear and the appeal was subsequently dismissed by letter dated 7-27-12 for failure to appear. Appellant asserts that he did not receive notice of the rescheduled hearing until on or about 8-15-12, after the hearing date. Additionally, on 9-7-12, Raymond C. Gerard, Attorney at Law, entered his appearance on behalf of the Taxpayer asserting that the notice of hearing was not received until the hearing date had passed. He requests the matter be reinstated and set for hearing.

rr. Tom Fotsis: #09-32854-C-1 (Cook – Worth)

Appellant originally filed with PTAB on 10-8-10. An initial review of the file indicated there was an extension request from the Appellant. The PTAB granted a 90-day extension to the Appellant expiring on 1-12-12. The appeal was dismissed for lack of evidence on 3-12-12. On 8-27-12, the Appellant submitted evidence under this docket number along with a request to reinstate the appeal. Appellant claims no correspondence disclosing the status of this appeal was received. On 8-28-12, Counsel faxed a stipulation signed by Appellant and the Cook County Board of Review.

ss. Maurice Weiss: #07-27298-C-3 (Cook – Worth)

Appellant filed a Motion to Submit New Evidence. An appraisal was previously submitted that had been prepared by Robert W. Schlitz, M.A.I., and Michael T. Gilligan. Mr. Schlitz died on 5-9-12 and Gilligan is not an M.A.I. appraiser. The Appellant requests an Order to allow for the submission of a new appraisal prepared by an M.A.I. appraiser.
