Furthermore, the Intervener has submitted no additional evidence and has adopted the evidence submitted by the BOR. Taxpayer contends it is seeking to restore for 2009 the 2008 fair market value established by the BOR for the property because both years are within the same triennial assessment cycle. The taxpayer contends the parties are not prejudiced by granting the Motion to Amend Petition and allowing the substitution of the correct appraisal report. (PTAB did not catch

the fact that the appraisal was not for the subject property when reviewing the file for completeness).
