The BOR issued its decision reducing the assessment to the stipulated amount stating the reason as a "Stipulation agreement between the Supervisor of Assessments/Township Assessor and the Appellant." In its submission the BOR requested the values on the stipulation signed and executed at the 2011 Board of Review level be sustained. Other than printouts from the Will County Real Estate Tax Inquiry Screen showing the execution of the stipulated values, no other evidence or extension requests were submitted by the BOR. The BOR time to submit evidence expired on May 14, 2013.

Three taxing districts intervened (Bolingbrook Park Dist., Fountaindale Public Library Dist. & Valley View C.U.S.D. #365U) but were defaulted on August 28, 2013 due to the failure to submit evidence.

By letter dated September 3, 2013, the Will County BOR asserted it had joined with the Village of Bolingbrook and others to obtain an appraisal and requested a 30-day extension to submit the report. It asserted that in 2011 a stipulation was signed by the BOR and the Intervenor as a negotiated settlement and were of the opinion there would be no further action. However, according to the BOR, appellant's counsel has taken the position that the stipulation does not preclude him from pursuing further relief from the PTAB. The BOR requested that the PTAB give no weight to the stipulated document because there was no meeting of the minds due to the Appellant's interpretation of the stipulation not being the same as the BOR and Intervenor.

The Appellant, through counsel, filed a letter objecting to the request of the Will County BOR for an extension of time to submit evidence. The Appellant asserted that the BOR's time for submission of evidence or request for an extension has expired pursuant to section 1910.40 of the rules of the PTAB.

- pp. Exeter 117 119 Industrial LLC: #11-02096-C-2 (Madison)
Lanter Company: #11-02097-C-3 (Madison)

In each of the appeals listed above, counsel for the Appellant submitted separate appeal forms on 4-9-12. A 90-day extension was granted to each appeal with a due date of 4-7-13. A timely filed appraisal (4-5-13) was received for docket 11-02097-C-3 and the Madison County Board of Review was notified of this filing. Evidence was not found for 11-02096-C-2 and the file was dismissed on 9-11-13. Per correspondence received 9-26-13, Appellant is requesting the PTAB reinstate 11-02096-C-2 stating the evidence submitted for 11-02097-C-3 contained two parcel numbers, the second being for 11-02096-C-3.

- qq. Edward & Daniel Szkirpan: #10-26825-R-1 (Cook – Hyde Park)

Appellant originally filed with PTAB on 7-18-11 and requested an oral hearing. A hearing date was set for 7-17-13 and this notice was mailed from PTAB to the Appellant on 5-29-13. Appellant was dismissed on 8-14-13 for failure to appear at the scheduled hearing. Per correspondence dated 8-28-13, Appellant is requesting the PTAB to reinstate the appeal and reschedule a hearing at the Orland Park location. Appellant states that a request to reschedule was sent in writing on 6-4-13 to PTAB. Appellant's file contains a Hearing Date Change Request stamped received in the DPO Office 6-7-13. Request states the Appellant will be out of town for a family vacation and asks the PTAB to reschedule the hearing after 9-1-13.

- rr. 6201 Ogden LLC: #11-20421-C-1 (Cook – Berwyn)

Appellant filed with PTAB on 1-16-12. A review of the file prompted an incomplete checklist and a notification letter was mailed on 3-12-13 with a due date of 4-11-13. On 4-11-13, Appellant mailed the return checklist with a cover sheet explaining they are unable to obtain a copy of the BOR decision as required by PTAB but, instead, provided a printout from the Board of Appeals Complaint Review System, which indicates a complaint was filed for tax year 2011. A hearing officer review indicated the file should be dismissed. A dismissal letter was mailed 6-12-13. Per correspondence received 7-15-13, Appellant is requesting PTAB reinstate the appeal explaining that the original decision is not in the Appellant's possession or control.

- ss. KTR Capital Partners, LLC: #11-20423-I-3 (Cook – Cicero)

Appellant filed with PTAB on 1-16-12. A review of the file prompted an incomplete checklist and a notification letter was mailed on 3-12-13 with a due date of 4-11-13. On 4-11-13, Appellant mailed the return checklist with evidence, the required BOR decision, but without the requested addendum listing claim amounts for each of the 8 parcels. Appeal was dismissed on 6-12-13 for not meeting the burden of going forward. Per correspondence postmarked 7-11-13, Appellant is requesting the PTAB reinstate the appeal and believes they have satisfied the requirement of going forward by providing 3 comparable sales.

- tt. Cindy Mayer: #11-20374-R-1 (Cook – Berwyn)

Appellant originally filed with PTAB on 1-3-12. An initial review of the file indicated evidence/appeal form was insufficient to move forward. An incomplete checklist and notification letter was mailed to the Appellant on 3-5-13 with a 30-day extension expiring 4-4-13. Appeal was dismissed on 6-12-13 when a second review of the file indicated sufficient evidence was not received. Per correspondence dated, 6-27-13, Appellant is seeking a reinstatement and has submitted an appraisal report that was purportedly mailed to PTAB on 4-4-13. Mail log does not indicate evidence was received by the PTAB.
