Appellant originally filed with PTAB on 8-4-11 based on a recent sale of \$735,000 on 10-20-10 and requesting an oral hearing. The Cook County Board of Review was found in default on 4-24-13 and a decision rendered based on the evidence contained in the file on 4-18-14 as a “No Change”. Per correspondence received 4-25-14, Appellant has submitted a Motion for Reconsideration and is seeking reconsideration of the Board’s decision to deny any relief to the Appellant. Motion states the Appellant’s evidence is weighed against the BOR’s

failure to refute, contest or otherwise submit independent evidence in support of its own value and contends that its evidence is sufficient to meet its burden of proof under that standard.

In each of the appeals listed above, Appellant has filed a Motion for Continuance and for Leave to File a New Appraisal or for Decisions to be Written on the Evidence Without a Hearing. Motion states the Appellant hired an appraiser for the year 2011 and the appraisal was completed and submitted for the years 2011, 2012 and 2013 under the above docket numbers. On 4-16-14, Appellant was notified by the PTAB that the 2011 and 2012 cases would be heard on their merits on 6-4-14. The appraiser cannot be located for the purpose of providing testimony for the 2011 and 2012 PTAB hearings. Appraiser's phone number has been disconnected and his place of business vacated. A private detective was also hired to determine the whereabouts of the appraiser but was unable to locate. Appellant requests a continuance of the 2011 and 2012 dockets due to the witness's unavoidable absence that is beyond the control of either party, and the filing period reopened for the purpose of hiring a different appraiser to submit a new appraisal. In the alternative, Appellant requests that the 2011, 2012, and 2013 cases be written on the evidence that is already in the record without having a full administrative hearing.

- pp. S. Chicago SLF Associates: #10-26146-C-3 (Cook – Hyde Park)

Intervenor, City of Chicago, originally filed with PTAB on 4-25-13. A total of 180-days has been granted with the latest being a Final extension expiring on 4-19-14. Intervenor is requesting a Stay in light of a stipulation agreement. This appeal has nine (9) parcels with steps being taken to process a Certificate of Error for four (4) of the parcels. A Certificate of Error has already been processed for 3 parcels.

- qq. TCB Development Group, LTD: #13-00357-I-3 (Will)

Appellant originally filed with PTAB on 2-11-14. A hearing officer review indicated information was missing such as sufficient evidence and requested assessment amounts. A notification letter was generated and sent to the Appellant along with a checklist with a due date of 4-25-14. Required information was not received and the appeal was dismissed on 5-14-14. Per correspondence received 5-19-14, Appellant is requesting the PTAB reinstate the appeal stating a petition with supporting evidence including a narrative appraisal was mailed on or about

4-23-14. Reinstatement request does not contain either of the above. A copy of a Certified Mail Receipt (4-24-14) signed by a PTAB employee is also included but does not reflect a docket number.

rr. Deer Creek Golf: #11-00856-C-2 (Will)

The Will County Board of Review has filed a Motion to Stay Proceedings. This stay is requested in order for the PTAB to finalize their decision on the Onwentsia Country Club. It is the BOR's intent to incorporate the merits of the final decision on Onwentsia into an offer for Deer creek Golf Club and since the Onwentsia case has not been fully adjudicated, the BOR contends that hearing a case with the same or similar merits would be duplicitous and/or lead to additional court actions. Currently, all evidence has been received and the file is "Ready Hearing".

ss. Prologis: #11-01522-C-2 (Ogle)

Intervenor, Rochelle S.D. #231, originally filed with PTAB on 12-9-13. A total of 90-days has been granted for the submission of evidence. Intervenor has filed a Motion for Dismissal of Appeal and Request for Extension of Time for Filing Legal Brief. Motion states the Appellant submitted an "Affidavit as to Use" that contains a description of the property but fails to satisfy the applicable burden of going forward because a legal argument was not provided. In the case the appeal is not dismissed, Intervenor is requesting an additional 60-day extension to perform an independent analysis of the property at issue for the preparation of a legal brief and/or evidence. Properties in question are four retention ponds, which the taxpayer contends are worthless.

tt. 1411 N. State Condominium Assoc.: #09-28335-R-3 (Cook – N. Chicago)

A PTAB hearing was held in the above referenced matter on 3-25-14. During the hearing, the PTAB's ALJ denied the Appellant's request to substitute two pages of the appraisal to include the appraiser's signature. An appraisal report of the property was purportedly prepared by Robert W. Schlitz of S.A.S. Inc. that valued the subject property as of January 1, 2009. Schlitz passed away in May 2012. During the preparation of the hearing, Appellant's counsel realized the appraisal submitted to the PTAB was not signed by Schlitz. Upon counsel's request, S.A.S. Inc. provided counsel a copy of the appraisal report that contained Schlitz's signature on the pages titled "Reconciliation and Final Value" and "Appraiser Certification." The Appellant also submitted an affidavit of Michael Gilligan, an M.A.I. appraiser and Vice President of S.A.S. Inc., attesting that the signature on the pages in question is the true and accurate signature of Schlitz. On 4-28-14, the Appellant filed a Motion to Substitute Unsigned "Reconciliation and Final

Value Conclusion” and “Appraiser Certification” Pages of Appraisal Report with Signed Copies”.

The Cook County Board of Review filed a response objecting to the Appellant’s motion to substitute the pages. The BOR also continues to maintain its objection to the appraisal as being hearsay.

Appellant originally filed with PTAB on 10-6-10 based on a recent appraisal with a fair market value of \$1,500,000 and requesting an oral hearing. A decision was rendered and mailed to all parties to the appeal on 3-21-14 lowering the total assessment to \$175,700 based on the evidence contained in the file. Per correspondence received 4-3-14, Appellant has submitted a Motion for Reconsideration and is seeking reconsideration of the Board’s decision due to the PTAB’s misapplication of Section 16-185 of the Illinois Property Tax Code. Motion states the Appellant did not request a “rollover” from decisions rendered by PTAB for tax years 2007 and 2008 but requested a decision based on the equity and weight of the evidence submitted.
