Appellant submitted information within time frame but a second review deemed the information insufficient. A few pages of an appraisal was submitted for each docket number. The appeals were dismissed on 5-14-14. Per correspondence received 5-29-14, Appellant is requesting the PTAB reinstate

the appeals and has submitted full appraisals for each appeal stating that at the time of filing, he believed relevant pages of each appraisal was sufficient.

Per correspondence received with evidence, counsel for Appellant is requesting the PTAB accept the tardy evidence stating the original extension letter from PTAB was accidentally delivered to the wrong office and that person was out of town.

ll. Sal Melilli: #12-20665-R-1 (Cook – Lake View)

Appellant originally filed with PTAB on 12-19-12. An initial extension was granted, per request, with a deadline of 1-12-14 (Sunday). Appellant submitted evidence that was received on 1-22-14 by the PTAB. The envelope had a postmark date of 1-14-14 (Tuesday), officially one-day late. Monday, 1-13-14, was not a holiday with the State of Illinois. Appeal was dismissed for lack of evidence on 6-4-14. Per correspondence received 6-17-14, Appellant is requesting the PTAB reinstate the appeal and believe they have satisfied all of the requirements of going forward. Request has a tracking and confirmation printout listing the evidence as delivered on 1-22-14 and confirm that the cover sheet for evidence was dated 1-12-14. A printout was also attached to the request for a different docket number (12-03884) reflecting the PTAB granted an extension for 30-days on 2-7-14. Appellant seems to be confusing this docket number with the one in question.

Appellant originally filed with PTAB on 4-15-13. Filing was deemed insufficient and a 30-day extension was granted until 12-8-13 (Sunday) to complete and submit all items listed on the checklist included with notification. On 12-9-13 (Monday), the PTAB received evidence from the Appellant. The evidence received did not satisfy the burden of going forward and a second extension was granted explaining that an additional copy of evidence is required per checklist that was originally sent. This second extension expired on 3-9-14. The additional copy of evidence was not received and the appeal was dismissed on 5-30-14. Per correspondence received on 6-17-14, Appellant is requesting the PTAB reinstate the appeal and believe the evidence postmarked on 12-9-14 satisfied the burden of going forward. Appellant further states they did not receive the second extension due on 3-9-14 but saw it on the ASI screen. The primary issue is that the

Appellant did not initially complete Section V of the appeal form grid. On the subsequent submission, the Appellant completed Section V but provided the PTAB with only one copy.

Evidence was received untimely on 6-6-14 and each appeal was dismissed on 6-10-14. Per correspondence received 6-16-14, Appellant is requesting the PTAB reinstate the appeals and states the PTAB correspondence was inadvertently separated from the case files in counsel's office and was not discovered until after the evidence deadline.

Appellant originally filed with PTAB on 4-19-13. Evidence was received from all parties to the appeal and this docket number was made ready for hearing on 5-8-14. Per correspondence received 5-30-14, Appellant submitted a Motion to Stay Proceedings, or in the alternative, Motion for an Extension of Time to Submit Rebuttal Evidence. Motion states the subject property is a private golf club and currently receives open space valuation and refers to the remanded Onwentsia Club.

Intervenors, Glenbard T.H.S.D. #87 and Glen Ellyn S.D. #41, were served a copy of the above Motion and have responded per correspondence received 6-12-14. Response is in opposition of the Appellant's Motion to Stay Proceedings, but does not oppose Appellant's Motion for an Extension of Time to Submit Rebuttal Evidence. Intervenors counter it is unclear as to whether either House Bill 1053 or Senate Bill 3382 will ever pass and to stay proceedings indefinitely on the chance either Bill will pass is not judicially efficient.

Appellant originally filed with PTAB on 3-1-13. All evidence was received from all parties to the appeal and this docket number was made ready for hearing on 4-25-14. Per correspondence received 5-23-14, Appellant submitted a Motion to Stay Proceedings, or in the alternative, Motion for an Extension of Time to Submit Rebuttal Evidence. Motion states the subject property is a private golf club and currently receives open space valuation and refers to the remanded Onwentsia Club.

Intervenor, Barrington C.U.S.D. #220, was served a copy of the above Motion and has responded per correspondence received 6-12-14. Response is in opposition of the Appellant's Motion to Stay Proceedings, but does not oppose Appellant's Motion for an Extension of Time to Submit Rebuttal Evidence. Intervenor counters it is unclear as to whether either House Bill 1053 or Senate Bill 3382 will ever pass and to stay proceedings indefinitely on the chance either Bill will pass is not judicially efficient.

qq. Invesco Realty Advisors: #12-01261-C-3 (Kane)

Appellant originally filed with PTAB on 3-6-13. Appeal and evidence submitted was deemed sufficient and an extension request by the Appellant was not received. The Kane County Board of Review was notified of the appeal on 8-15-13 and granted a 90-day extension to submit evidence. Notes on Appeal and evidence was timely filed by the BOR as well as a statement adopting any evidence supplied by an Intervenor. Intervenor, Geneva C.U.S.D. #304 timely filed with PTAB for this docket number and were granted a 90-day extension to submit evidence, expiring on 1-22-14. A second request for an extension from the Intervenor was received and went before our Board at its 2-11-14 meeting. A final 90-day extension was granted to the Intervenor, expiring on 5-19-14. At the same board meeting the PTAB ordered the Appellant to supply the Intervenor with a copy of a sales contract and rent rolls. On 3-20-14, Appellant submitted a Request for Withdrawal for this appeal and a copy was forwarded to the Intervenor and the BOR. By letter dated, 4-28-14, the Intervenor reported that the Appellant has failed to comply with the production of documents set forth in the Board's Order and objects to the withdrawal of the appeal asserting that they have retained an appraiser. Appellant's counsel asserts that the documents regarding the sale of the property on August 2013 are not relevant because the sale was placed 20 months after the assessment date at issue.

rr. Vittorio Laudati: #08-20184-R-1 (Cook - Evanston)

A Final Administrative Decision was issued by PTAB on 6-20-14 based on the evidence presented in the file confirming the assessment of the BOR. The appeal was based on a market value contention in which the Appellant submitted an appraisal. The BOR submitted equity comparables and no market value information. The PTAB found the appraiser's conclusion of value to be unreliable and confirmed the assessment. The Appellant has filed an Emergency Motion To Reconsider Final Administrative Decision. The Appellant asserts the BOR submitted no evidence contradicting the Taxpayer's market value argument and further contends the equity comparables did not refute the Taxpayer's market value argument. The Appellant asserts the PTAB's ALJ should have examined the raw sales if the appraisal was found unreliable. Taxpayer requests the PTAB

grant the Motion to Reconsider and render a decision based on the appraised value or any other relief deemed appropriate.
