Appellant originally filed with PTAB on 2-20-12. A total of 450 days has been granted for the submission of evidence. Appellant is requesting an additional extension of 90-days following the conclusion of the 2009 appeal to file evidence and to continue efforts to settle pending appeals under the same parcel number.

Appellant originally filed with PTAB on 2-12-13. A total of 360 days has been granted for the submission of evidence. Appellant originally filed with PTAB on 2-18-14. A total of 180 days has been granted for the submission of evidence. Appellant is requesting an additional extension of 90-days following the conclusion of the 2009 appeal to file evidence and to continue efforts to settle pending appeals under the same parcel number.

- d. Several Taxing Districts: #11-05956-I-3 (Madison)

Appellant (taxing districts) originally filed with PTAB on 4-13-12. The appeal is for WRB Refining's Wood River Refinery, one of the largest refineries in the United States. A total of 270-days has been granted for the submission of evidence. Appellant is requesting an additional 90-day extension for the possibility of a global settlement that would dispose of all pending litigation and avoid future years of litigation of the 2011, 2012, and 2013 assessed values before the Illinois Department of Revenue (pollution control facilities).

Appellant (taxing districts) originally filed with PTAB on 4-3-13. The appeal is for WRB Refining's Wood River Refinery, one of the largest refineries in the United States. A total of 270-days has been granted for the submission of evidence. Appellant is requesting an additional 90-day extension for the possibility of a global settlement that would dispose of all pending litigation and avoid future years of litigation of the 2011, 2012, and 2013 assessed values before the Illinois Department of Revenue (pollution control facilities).

- f. Marquardt School District No. 15: #13-03769-I-3 (DuPage)

Appellant (taxing district) originally filed with PTAB on 4-11-14. The appeal is for KTR Capital Partners, LLC. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an additional 60-day extension to complete a summary appraisal report. Letter from appraiser (10-15-14) cites professional commitments as reason for request.

- g. Eugene & Gail Friedman: #13-02482-R-1 (Lake)

Appellant originally filed with PTAB on 3-12-14. A total of 120-days has been granted for the submission of evidence with the latest being a Final extension that expired 10-14-14. Per correspondence received 10-14-14, Appellant is requesting an additional extension of 60-days to file written evidence on comparable properties, citing a foot injury occurring on 9-28-14, as the reason for this request beyond the final extension.

Appellant originally filed with PTAB on 2-5-14. A total of 120-days has been granted for the submission of evidence. Appellant is requesting an additional 90-day extension to file evidence.

Intervenor is requesting an additional 60-day extension, to determine whether an appraisal should be obtained of the subject properties, or if settlements can be reached.

- x. BASF Corporation: #12-00919-I-3 (Kankakee)

Intervenor, City of Kankakee and Kankakee S.D. #111, originally filed with PTAB on 3-11-14. A total of 180-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (10-9-14) indicates personal and professional commitments as reason for request. Request further states the Appellant was sent a request for an inspection, and a number of documents that are critical to completion of the appraisal report, but a response has not been received.

- y. Fred Schwer Exelon Corporation: #11-05318-I-3 (DeWitt)

Intervenor, DeWitt County, Richland Community College #537, Clinton U.S.D. #15, and Vespasian Warner Public Library, originally filed with PTAB on 2-20-14. A total of 180-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (10-9-14) indicates the information supplied by the owner is insufficient to proceed with the appraisal report, and that additional requests for information have been made. The subject property is a nuclear power plant that is extremely complicated to appraise, and can only be appraised by a limited number of qualified appraisers.

z. Stahelin Properties: #12-03839-C-3 (DuPage)

Intervenor, College of DuPage, originally filed with PTAB on 7-11-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for a possible settlement between the parties. If the settlement falls through, the Intervenor will file evidence and/or a brief.

aa. Walgreens: #13-02962-C-2 (Kane)

Intervenor, C.S.D. #158, originally filed with PTAB on 7-15-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

bb. Walgreens: #13-01012-C-2 (Kane)

Intervenor, C.U.S.D. #300, originally filed with PTAB on 5-19-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

cc. Carson Pirie Scott & Co.: #11-29608-C-3 (Cook – Wheeling)

Intervenor, River Trails S.D. #26, originally filed with PTAB on 7-1-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

dd. Cedar State, LLC: #13-03250-C-3 (McHenry)

Intervenor, Algonquin Twp., originally filed with PTAB on 7-3-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser is not included with request.

ee. Welsh Properties LLC: #11-03093-I-3 (DuPage)

(1) Intervenor, Glenbard T.H.S.D. #87, originally filed with PTAB on 5-29-14. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to prepare and file evidence.

(2) Intervenor, Village of Glendale Heights, originally filed with PTAB on 6-2-14. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension for the submission of evidence, in the event a proposed stipulation is not accepted.

ff. Graybar Electric Company, Inc.: #12-03973-I-3 (DuPage)

(1) Intervenor, Marquardt S.D. #15, originally filed with PTAB on 6-17-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal report. Letter from appraiser (10-10-14) indicates other professional commitments as reason for request.

(2) Intervenor, Village of Glendale Heights, originally filed with PTAB on 6-2-14. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal report. Letter from appraiser (10-10-14) indicates other professional commitments as reason for request.

gg. Graybar Electric Company, Inc.: #11-03557-I-3 (DuPage)

Intervenor, Village of Glendale Heights, originally filed with PTAB on 6-2-14. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (10-10-14) indicates other professional commitments as reason for request.

hh. Piotr Wilewski: #11-05601-R-1 (Kendall)

Appellant originally filed with PTAB on 7-21-12 requesting an oral hearing. On 7-10-14, a letter scheduling an oral hearing was mailed to the Appellant using the address provided on the original appeal form. This letter informed the Appellant that a hearing would be held on 9-18-14, for the above docket number, and was not returned to this office for any reason. The Appellant failed to appear at the scheduled hearing and the appeal was dismissed on 9-22-14. Per correspondence received 10-6-14, Appellant is requesting the PTAB reopen and reschedule a hearing for the above docket number because the hearing notice was not received.

ii. Midlothian Country Club: #11-23530-C-3 (Cook – Bremen)

Intervenor, Bremen T.H.S.D. #228, originally filed with PTAB on 12-20-13. A total of 135-days was granted for the submission of evidence with the last extension being a final extension. Evidence was not received and the Intervenor was defaulted on 8-18-14. Per correspondence received 8-22-14, Intervenor requested a Motion to Rescind Default along with a stipulation dated 7-1-14, signed by both of the Intervenor and the Appellant, but never received by the PTAB. Motion also indicates this Intervenor submitted an appraisal report with a valuation date of 1-1-11 to our office (date sent was not provided). The PTAB

does not have a record of receiving this appraisal report. On 8-26-14, the PTAB sent a response to the Intervenor indicating the appraisal report was not received and granting a 14-day extension (expiring 9-9-14), to provide proof of timely filing of the appraisal, along with three copies of the appraisal. This requested information was not received. A 30-day letter was mailed to the BOR on 9-25-14, and no response has been received objecting to the stipulation.

jj. Walgreens Stores, Inc.: #13-02625-C-2 (McHenry)

Intervenor, C.U.S.D. #300, originally filed with PTAB on 6-20-14. A total of 90-days was granted for the submission of evidence with the extension expiring 9-23-14. A request for a 60-day extension was received by PTAB on 10-7-14. Intervenor is requesting the PTAB accept this late filing due to a former secretary failing to docket the matter and instead “filed it away”. The Appellant’s attorney has no objection to the Intervenor’s request.

kk. The Golf Club at Stonewall Orchard, LLC: #13-01974-C-3 (Lake)

The Lake County Board of Review was notified of the above filing on 5-23-14. A 90-day extension was granted for the submission of evidence with a due date of 8-21-14. The required Notes on Appeal form(s) nor evidence were received from the BOR, and a default letter was generated and mailed on 9-19-14. Per correspondence received 10-2-14, the BOR is requesting the PTAB vacate the default issued, stating they believe the required information was mailed from their office on 8-21-14, but they do not have proof of mailing. Along with this request is a copy of the required Notes on Appeal form(s) and a 90-day extension request.

ll. DS Waters of America Inc.: #13-01632-C-2 (Kane)

The Kane County Board of Review was notified of the above filing on 5-6-14. A total of 90-days has been granted for the submission of evidence with a due date of 8-4-14. The required Notes on Appeal form(s) nor evidence were received from the BOR, and a default letter was generated and mailed on 8-26-14. Per correspondence received 9-22-14, the BOR is requesting a Motion to Vacate Default and have provided evidence and Notes on Appeal. Along with the Motion is a copy of an email from a BOR member dated 8-4-14, which purportedly had evidence as an attachment. The Deputy Supervisor of Assessments asserts that she printed out the email and attachments and sent to the PTAB on 8-4-14.

mm. Michael Baldwin: #13-04284-R-1 (St. Clair)

Appellant originally filed with PTAB on 5-5-14. An initial review of the appeal resulted in a notification letter with a checklist of information for the Appellant to return for completion of filing. This information was due 8-30-14. The PTAB does not have a record of information being received and the appeal was dismissed on 9-23-14. Per correspondence received 10-2-14, Appellant is requesting the PTAB reinstate the appeal. Appellant states he did not receive the notification letter and checklist from PTAB and also believes the information previously sent with original filing is sufficient.

nn. River Park Place, LLC: #13-01554-R-2 (Kane)

Appellant originally filed with PTAB on 3-10-14 along with a 60-day extension request to submit evidence. A notification letter and extension was granted with a due date of 7-5-14. The PTAB does not have a record of information being received and the appeal was dismissed for insufficient evidence on 9-10-14. Per correspondence received 10-8-14, Appellant states the extension letter was not received, and requests the appeal be reinstated and the PTAB accept the evidence that accompanied the request.

oo. Carl E. Thomas: #12-22876-C-1 (Cook – Elk Grove)

Appellant originally filed with PTAB on 2-5-13. The original filing included the BOR decision and an appraisal for a PIN that differed from the address and PIN on the appeal form. An initial review determined the appeal was incomplete, and a checklist with a 30-day extension was generated and mailed to the Appellant on 12-31-13, with an extension until 1-30-14 to return the requested information. A response was not received and PTAB dismissed the appeal on 6-12-14 for insufficient evidence. Per correspondence received 9-2-14, Appellant is requesting the PTAB reinstate the appeal and provided the required information. Request states the Appellant did supply this information in a timely manner and an inadvertent error appears to have occurred in processing the supplemental evidence packet.

pp. Walgreens: #13-00903-C-2 (Vermillion)

The Vermillion County Board of Review was notified of the above filing on 4-8-14 and granted a 90-day extension to submit evidence with a due date of 7-7-14. On 7-22-14 (15-days late) the BOR submitted evidence, without the required Notes on Appeal, apologizing for the late submission. The BOR was found in default on 9-19-14. Per correspondence received 10-7-14, the BOR has submitted a Motion to Reconsider and to Admit Evidence. Motion states the apology for the late submission on 7-22-14, is essentially an extension request, and should be honored.

qq. Willowhill LLC: #12-29258-C-2 (Cook – Northfield)

Appellant originally filed with PTAB on 4-9-13. On 10-15-13, before an initial review of the appeal could be made, the Appellant requested the PTAB withdraw and close the appeal. On 10-17-13, Appellant filed letter stating the withdrawal request was sent in error, and to please disregard and continue with the appeal. An initial review of the appeal determined it to be incomplete, and a return sheet was generated and mailed on 4-10-14, with a due date of 5-10-14. Evidence and Appellant requested amounts required to continue the appeal were not received, but a signed stipulation was received on 6-16-14 between the Appellant and the BOR.

rr. Gus Valkanas: #12-26940-C-2 (Cook – Hyde Park)

The following request was denied by the PTAB at the 9-9-14 Board Meeting:

Appellant originally filed with PTAB on 3-9-13. Upon review, the appeal was deemed incomplete, and a checklist was mailed to Appellant on 5-6-14, with a deadline of 6-5-14, to correct the appeal and submit required information. The appeal was dismissed for insufficient evidence on 7-24-14, with no response to checklist. Per correspondence received 8-7-14, Appellant requested the PTAB reinstate the appeal and accept a stipulation signed by the Appellant's counsel with a statement indicating the stipulation was signed between the parties in February of 2014 and misplaced. The copy received by the PTAB is signed only by the Appellant's counsel.

Per correspondence received 10-28-14, Appellant has filed a Motion to Reconsider. Request states the denial is a governmental mishap and the Appellant believed the BOR had signed a stipulation and sent it to the PTAB.

- ss. Ardmore By The Lake, LLC: #10-21294-C-1 (Cook – Lake View)

This matter has been carried over from the October 14, 2014 meeting.

The above referenced matter was remanded by the Circuit Court of Cook County for a hearing on the exclusive issue of classification. The taxpayer was ordered to request a subpoena of the BOR or the State's Attorney of Cook County regarding a witness to testify on the remanded issue. Appellant filed a request for a subpoena pursuant to the court's order.

- tt. Pete Patel: #13-04295-C-2 (Union)

Appellant originally filed with PTAB on 5-12-14. An initial review of the appeal determined it to be incomplete, and a return sheet was generated and mailed on 7-31-14, with a due date of 8-30-14. Appellant returned some information on 8-25-14, but it was not sufficient to go forward, and did not include information requested by the reviewing hearing officer, including assessment requests. The appeal was dismissed on 9-24-14. Per correspondence received 10-28-14, Appellant is requesting the PTAB reinstate the appeal. Appellant states there are no similar properties in Anna, Illinois, so he included similar hotels in the surrounding area. He states he has no funds to obtain an appraisal.

- uu. Shoppes at Grand Prairie: #13-01147-C-3 (Peoria)

Appellant originally filed with PTAB on 2-26-14, and requested an extension of time to submit evidence. On 4-15-14, the PTAB granted an extension to the Appellant, with a due date of 5-15-14 to submit evidence. On 5-15-14, Appellant submitted a Desk Review Report in support of the assessment request. A hearing officer's review found the evidence insufficient, and the appeal was dismissed on 9-25-14. Per correspondence received 10-23-14, Appellant has filed a Motion to Reinstate Appeal to the PTAB. Motion states the Review Report was sent in error, and enclosed one copy of an appraisal report, dated 1-1-11, which was supposed to be sent originally, and is the same appraisal filed for the 2011 and 2012 appeals. Motion further states the quadrennial reassessment cycle began in 2011, and the pending 2011 appeal to PTAB is set for hearing 12-3-14.
