The BOR also stated that, "the Intervenors have ordered an appraisal for the property. We respectfully request that upon its receipt it be added to this evidence."

The BOR notified the taxing districts of the appeal on 3-31-14. Intervention was due on 5-30-14. Pekin Grade School Dist. #108 filed a request to intervene on 5-28-14 but supplied no resolution. The PTAB denied the request to intervene due to no resolution. On 6-27-14 the school district filed a Motion for Leave to Intervene. The taxpayer/appellant filed a response objecting to the request to intervene. At its meeting of 8-13-14 the PTAB voted to deny the Motion for Leave to Intervene.

On 7-18-14, the PTAB received the BOR's appraisal that was actually prepared for School Dist. #108. The Appellant filed a Motion to Strike the appraisal for not being timely filed by the BOR. In response the BOR asserted that in its response dated 4-10-14 it had requested that the appraisal prepared for the Intervenor be accepted upon its receipt.

mm. Walgreens: #13-01683-C-2 (Madison)

Intervenor, Collinsville C.U.S.D. #10 timely filed a Request to Intervene on 6-23-14. This request was accepted and a 90-day extension was granted for the submission of evidence which expired on 9-25-14. A review of the file indicated evidence was not received from this Intervenor and a default letter was generated and mailed on 11-3-14. Per correspondence received 11-21-14, Intervenor has filed with the PTAB a Motion to Vacate Default and Request for Final Extension of Time to Submit Evidence. Motion states the Intervenor was not aware that the former BOR chairman (Kerry Miller) of the BOR had retired and indicates a joint procurement of an appraisal had been coordinated with Mr. Miller.

Intervenor requests the PTAB vacate the default and grant a final extension until 1-15-15, which is the current deadline for the BOR to submit evidence.

nn. Beloit Memorial Hospital, Inc.: #11-01316-C-3 (Winnebago)

The Winnebago County Board of Review was notified of the above filing on 4-8-14. A total of 150-days was granted for the submission of evidence with the latest being a final extension expiring on 9-7-14. The required Notes on Appeal forms and evidence was received (postmarked) 10-17-14, more than one month late. A default letter was generated and mailed to the BOR on 10-27-14. Per correspondence received 11-5-14, the BOR is requesting the PTAB honor the evidence received on 10-17-14. Request states the person responsible for this file had just assumed the responsibility for the PTAB hearings, with the understanding that an extension had been granted. The BOR understood that it had been granted an extension to file evidence for this case until 11-6-14, but subsequently learned the deadline was 9-8-14.
