The appeal was filed one (1) day late and dismissed on 11-5-13. A request to reinstate the appeal was received from the Appellant and placed on the 1-14-14 agenda for the board to decide on but was denied. Appellant has since submitted a copy of a signed stipulation (12-30-13) for the 2012 assessment year. The PTAB issued a decision for the Appellant's 2011 appeal (11-03867) dated 1-24-14, reducing the assessment of the property to \$54,530, based on an agreement of the parties. Due to the reduction, the Appellant had another 30-day window to file an assessment complaint on the property pursuant to section 16-185 of the Property Tax Code but did not do so.

Appellant originally filed with PTAB on 2-13-13. All evidence was received and file was made Ready for Hearing on 8-25-14. A copy of evidence received from the Cook County Board of Review was forwarded to the Appellant on this date. The Ready for Hearing letter indicates that any rebuttal evidence will be due 30-days from the 8-25-14 date. Appellant hand-delivered rebuttal evidence to the Des Plaines Office on 9-25-14, one (1) day late, which was not accepted. Per correspondence received 11-24-14, Appellant is requesting the PTAB accept the late rebuttal evidence because he was confused by the way the 30-day filing period was calculated and believed the rebuttal had been mailed earlier.

oo. Robert Miles: #11-01521-R-1 (Sangamon)

Appellant originally filed an incomplete Residential Appeal form with PTAB on 3-30-12 requesting an oral hearing. All evidence was received and the file was made Ready for Hearing on 11-19-13. A hearing date was set for 12-10-14 and was mailed to the Appellant on 10-9-14. Appellant did not appear for the 12-10-14 hearing and the appeal was dismissed for this reason. Per correspondence received 12-13-14, Appellant is requesting the PTAB reinstate his appeal because he is almost 70 years old and forgot about the hearing date.

Per correspondence, received 12-12-14, the BOR is requesting the PTAB rescind the default issued 11-18-14 and has enclosed Notes on Appeal forms and evidence concerning the above docket number. Request states the BOR misunderstood and believed an extension that was granted for the Intervenor included themselves. Request further states the file had been given to a person who had only recently assumed the responsibility for the PTAB hearings.

The docket numbers are at various stages relative to the submittal of evidence. The parties have negotiated a settlement agreement that resolves all of the disputes concerning the 2012 and 2013 tax years currently pending before the PTAB. The parties wish to stay all proceedings before the PTAB for an additional 90-days to focus attention and resources on securing various approvals for a global resolution. A global resolution will require approval by the Circuit Court of Will County. A court order approving the settlement agreement will become final and non-appealable 30-days after its entry. Upon finality of the court order, the parties will seek the dismissal of all of the above-referenced appeals. The property involves Exelon's Braidwood Nuclear Power Station.

In each of the appeals listed above, the taxing bodies, WRB, and the Madison County Board of Review have filed a Joint Motion for a 90-day Stay of Proceedings. The parties have successfully negotiated an agreement to resolve all of the disputes concerning WRB's Wood River Refinery for the 2011 through 2013 tax years currently pending before the PTAB. The docket numbers are at various stages relative to the submittal of evidence. The parties wish to stay all proceedings before the PTAB for an additional 90-days to focus attention and resources on securing various approvals for a global resolution. Global resolution will require approval by the Circuit Court of Madison County. Currently, Section 200/9-45 of the Illinois Property Tax Code does not provide for settlement agreements regarding petroleum refineries. The parties are seeking an amendment of the PTC to allow for such settlements for petroleum refineries. A court order approving the settlement agreement will become final and non-appealable 30-days after its entry. Upon finality of the court order, the parties will seek the dismissal of all of the above-referenced appeals.

tt. Barbara Dennis: #09-26608-C-1 (Cook – Hyde Park)

A Property Tax Appeal Board administrative decision was issued for the above docket number on 11-21-14 pursuant to a stipulation received on 8-11-14 reducing the assessment to \$38,000. This stipulation was signed by the Appellant/Attorney and the Cook County Board of Review. On 12-17-14, Appellant/Attorney filed a Motion to Vacate Decision based on a Certificate of Error completed by the Cook County Assessor's Office on 6-28-11 reducing the 2009 assessment to \$35,934. Motion requests the PTAB vacate its decision of 11-21-14 and issue a revised decision indicating "no change" in assessed value.
