Request further states that this is a unique property and a very large assessment so the parties are working together to advance this matter expeditiously.

Intervenor (owner), Marquis Energy LLC, originally filed with PTAB on 10-20-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (1-20-15) indicates a backlog of work as reason for request.

- v. Marquardt Grade School District #15: #12-03868-I-3 (DuPage)

Intervenor (owner), 880 South Rohlwing Road LLC, originally filed with PTAB on 11-14-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional extension for the preparation of an appraisal and to obtain more detailed property records on the comparable properties submitted by the Appellant. Letter from appraiser (2-12-15) acknowledging authorization to complete appraisal is included with request.

- w. Community Consolidated School District #93: #12-03880-C-3 (DuPage)

Intervenor (owner) FMC Stratford Mall Members LLC, originally filed with PTAB on 11-14-14. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to submit evidence.

In each of the appeals listed above, Intervenor, Chicago Board of Education (CBOE), originally filed with PTAB In September of 2014. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 45-day extension for the preparation of an appraisal. Letter from appraiser (1-16-15) cites professional commitments as reason for request.

- y. Cedar State, LLC: #13-03250-C-3 (McHenry)

The McHenry County Board of Review was notified of the above filing on 6-23-14 with a due date of 9-21-14. A total of 90-days has been granted for the submission of evidence. The PTAB did not receive the required Notes on Appeal form, evidence, or an extension request from the BOR and a default letter was generated and mailed on 1-2-15. Per correspondence received 1-13-15, the BOR is requesting the PTAB rescind the default and accept the Notes on Appeal forms enclosed with the request. The BOR Notes on Appeal are dated 8-21-14 with an original and two copies. The BOR claims to have mailed these to PTAB within the original timeframe. The PTAB has no record of receipt.

- z. Douglas Johnson: #11-04413-R-1 (Lake)

Appellant originally filed with PTAB on 5-1-12 and did not request an oral hearing. The Lake County Board of Review timely submitted evidence and did not request an oral hearing. A decision was rendered based on the evidence submitted and mailed 12-19-14 after board meeting approval on 12-9-14. Per correspondence received 2-3-15, Appellant is requesting the PTAB reinstate the appeal based on his contention that a mistake was made adjusting the assessments. Appellant disagrees with the PTAB decision confirming assessment.

- aa. Tate Properties Trust: #13-01178-R-1 (Peoria)
Tate Properties Trust: #13-01179-R-1 (Peoria)
Tate Properties Trust: #13-01180-R-1 (Peoria)

In each of the above listed appeals, an oral hearing was scheduled for 12-8-14 at 2:45 pm. The Appellant failed to show but called the hearing officer on the date of the hearing explaining that he had a family emergency which forced him to be out of town on the date of hearing. He was told to follow up with a letter to PTAB, which he failed to do. The appeals were subsequently dismissed. Per correspondence received 1-30-15, Appellant is requesting the PTAB reinstate the appeals and reschedule hearings or write a decision based on the evidence.

- bb. Parkland Condominium Association: #13-30330-R-1 (Cook – Hyde Park)

Appellant originally filed with the PTAB on 4-9-14. A review of the new appeal indicated that there was information missing to complete the filing and an incomplete checklist and 30-day extension letter was dated and mailed 11-14-14 with a due date of 12-14-14. Nothing was received from the Appellant within this time frame and a dismissal letter was generated and mailed on 1-15-15. Per correspondence received 2-3-15, Appellant states an extension request was dated and mailed 1-5-15 to the PTAB regarding this docket number and requests a reinstatement of the appeal. A signed receipt from a PTAB employee is included with the request and a copy of the Appellant's extension request dated 1-5-15. The PTAB did receive this information from the Appellant (postmarked 1-5-15) but it was not timely as the due date was 12-14-14.

- cc. LaSalle Nat'l Bank 52072: #13-03301-R-2 (McHenry)

Appellant originally filed a Residential Appeal containing 4 parcels with the PTAB on 4-2-14. An initial review indicated amounts were not included for any of the parcels and a return sheet with a 30-day extension was generated and mailed to the Appellant on 8-20-14. This required information was not received and the appeal was dismissed on 1-2-15. Per correspondence received 2-9-15, Appellant has sent a response to the dismissal with an additional page of the original appraisal. No breakdown of amounts for the parcel numbers was returned with this response. A review of his initial correspondence indicates he requested the land assessment remain the same and an adjustment be made on the improvement portion for one of the parcels.

- dd. Mirza A. Baig: #13-30212-C-1 (Cook – Thornton)

Appellant originally filed a Commercial Appeal containing two parcel numbers with PTAB on 4-11-14. An initial review indicated a BOR notice/decision was not submitted for one of the parcels. An incomplete checklist requesting the BOR decision for the second parcel and a 30-day extension letter was generated and mailed to the Appellant on 11-6-14. The required information was not received and the appeal was dismissed on 2-9-15. Per correspondence received 2-18-15, Appellant is requesting the PTAB reinstate the appeal stating the failure to include the BOR decision for the second parcel was an administrative error on the part of the BOR due to the failure to issue the decision. The record contains a copy of the Appellant's appeal to the BOR in which the second parcel was listed.

- ee. Wayne Filosa: #13-29853-I-1 (Cook – Leyden)

Appellant originally filed with the PTAB on 4-9-14 and included an extension request to submit evidence. On 11-5-14 the PTAB granted a 60-day extension to the Appellant with a due date of 1-4-15 (Sunday). Evidence was not received and the appeal was dismissed for insufficient evidence on 2-6-15. Per correspondence received 2-13-15, Appellant is requesting the PTAB reinstate the appeal and enclosed two copies of evidence that the Appellant states was originally mailed to the PTAB on 1-5-15. A copy of a U.S. Postal Service certified mail receipt for \$11.70 (no date) is also included.

In each of the appeals listed above, counsel for Appellant filed with the PTAB on 10-10-14 and requested a 60-day extension to submit evidence. Notification letters were generated and mailed to the address provided on 10-28-14 with a due date of 12-17-14. A response was not received and the appeals were dismissed on 2-9-15. Per correspondence received 2-17-15, counsel states that an extension was never granted by the PTAB and the appeals should be reinstated and additional time be granted for the submission of evidence.

gg. Nancy Kinsella: #13-33671-R-1 (Cook – Thornton)

Appellant originally filed with the PTAB on 5-22-14. Appellant included sufficient evidence and a Cook County Board of Review Transmittal dated 3-17-14, which states the Appellant has 30-days to file a petition for review with the PTAB. The deadline to file with the PTAB was 4-16-14. The appeal was given a docket number and dismissed on 12-10-14 for untimely filing. Per correspondence received 2-11-15, Appellant is requesting the PTAB reinstate the appeal and consider the affidavit she attached to the request. The affidavit is dated 6-28-13 states the Appellant moved and the Cook County Treasurer did not update their records and, subsequently, the BOR used the wrong address from the Treasurer for mailing purposes. The Appellant did not receive a copy of the transmittal letter until 5-29-13.

hh. Nick Penesis: #08-26457-C-1 (Cook – Jefferson)

PTAB issued a decision on 1/23/15 confirming the assessment of the subject property even though it found the property had been incorrectly classified as a class 3-15 property, defined under the Ordinance as a two to three story non-fireproof corridor type apartments with interior entrance. Class 3-15 property had an Ordinance level of assessment of 20% for the 2008 tax year. The PTAB found the subject was a class 2-11 property, defined under the Ordinance as an apartment building with 2 to 6 units – any age. Class 2-11 property had an Ordinance level of assessment of 16% for the 2008 tax year. The appellant asserts that because the PTAB made a finding that the subject was a class 2-11 property, there was an error in the calculation of the assessment which allows the PTAB to issue an amended decision pursuant to section 1910.50(d) of the rules of the PTAB by applying the 16% level of assessment to the market value of the subject property. As an alternative argument the appellant asserts the PTAB should apply the median level of assessment for a class 2 property, which was 9.60% as determined by the IDOR for the 2008 tax year and not 9.21% as stated in the appellant's petition.

The subject property had a total assessment of \$83,148 which reflected a market value of \$415,740 when applying the 2008 Ordinance level of assessment for class 3-15 property of 20%. Applying the 2008 Ordinance level of assessment of class 2-11 property of 16% to the market value of \$415,740 would result in an assessment of \$66,518.

Section 1910.50(d) provides in part that:

Whether or not a hearing is held in the appeal proceeding, the proceeding before the Property Tax Appeal Board shall be terminated when the Board renders a decision. The Board may revise and/or correct a decision upon its own initiative at any time prior to the expiration of the administrative review filing period as provided in Section 16-195 of the Property Tax Code if a mistake in the calculation of an assessment or other clerical error is discovered. . . .

By finding the subject property is a class 2-11 property with an Ordinance level of assessment of 16%, the PTAB's decision can be construed as having an error in the calculation of the assessment, which would allow an amended decision.

ii. Fred Schwer Exelon Corporation: #11-05318-I-3 (DeWitt)

Intervenors, Clinton Unity S.D. #15, DeWitt County, Richland Community College, and Vespasian Warner Public Library District, submitted an Amended Motion for Subpoena Duces Tecum dated 1-20-15. Subpoena Duces Tecum requests statements of income and all data related to all income-producing activities, financial statements for the Clinton Nuclear Power Station, and copies of any power sales agreements that may have existed for the 2011 year.

Intervenors believe the subpoena is relevant and necessary to derive an estimate of the value of the real property under appeal. In response Exelon stated it does not maintain station specific income statements for its power plants. In its objection Exelon asserts it has provided all necessary information to allow the Intervenor's appraiser to appraise the property. Exelon has provided correspondence to the Intervenor's attorney in response to the information requested, dated 7-1-14 and 11-10-14. Intervenors have also filed a request for an extension of time to submit evidence.

jj. Wayne Swearingen: #13-04609-F-1 (Bureau)

Appellant originally filed with PTAB on 12-19-14 from a 2012 PTAB decision for same parcel dated 8-22-14. The due date for the 2013 assessment year with PTAB was 9-21-14. Appeal was filed nearly 3 months late. Appeal was docketed and then dismissed for untimely filing on 2-5-15. Per correspondence received 2-19-15, Appellant is requesting the PTAB reinstate the appeal. Appellant states he had his appraiser complete paperwork for him and he did not receive a copy of it until early December. Appellant asserts he is 73 years old and often can't remember things. He also explained his wife passed away four years ago and she always took care of bills and legal matters.
