A Hearing Notice (dated 4-1-15) was mailed to the Appellant with a hearing date set for 6-9-15 at 9:30 a.m. The Appellant did not show up at the hearing and the appeal was dismissed for this reason on 6-12-15. Per correspondence received 6-19-15, Appellant is requesting the PTAB reinstate the appeal stating she incorrectly added the date of the hearing as 6-19-15 instead of 6-9-15. Appellant asks the appeal be reinstated and a new hearing date set.

Appellant originally filed with the PTAB on 11-17-14. An initial review indicated that this was a multi-parcel appeal without an addendum providing a breakdown for each parcel. An incomplete checklist with a 30-day extension was sent to the Appellant on 3-3-15 with a 4-2-15 due date. The requested information was not returned and the appeal was dismissed on 6-17-15. Per correspondence received 6-22-15, Appellant submitted a Motion to Vacate Dismissal stating the request was inadvertently filed without providing the addendum as requested. A copy of a completed addendum for two parcels was included with the request.

- hh. Ruben Hernandez: #13-20442-C-1 (Cook – Rogers Park)

Appellant, represented by legal counsel, originally filed with the PTAB on 12-13-13. An initial review indicated that insufficient evidence was submitted with filing. An incomplete checklist with a 30-day extension was sent to the Appellant on 11-6-14 with a 12-6-14 (Saturday) due date. The requested information was not returned and the appeal was dismissed on 2-9-15. Per correspondence received 5-26-15, Appellant is requesting the PTAB reinstate the appeal and accept the evidence included with the request. Appellant states an extension request, in reply to the incomplete checklist, was mailed to the PTAB on 12-8-14 and delivered on 12-16-14. A Track & Confirm printout from USPS.com was included. The PTAB's mail log indicates one piece of mail came in on that date from this particular legal counsel and it was for a different docket number.

In each of the appeals listed above, Appellant, represented by counsel, originally filed with the PTAB in April of 2014. Appeals were reviewed and all were deemed incomplete. An incomplete checklist and 30-day extension was granted with a due date of 1-9-15. An extension request was timely received and a 60-day extension was granted with a due date of 3-30-15. Evidence was not received and each appeal was dismissed on 5-9-15 for insufficient evidence. Per correspondence received 6-16-15, Appellant is requesting each appeal be reinstated and submitted evidence and a USPS tracking number indicating the evidence was timely filed on 3-25-15.

In each of the appeals listed above, Appellant originally filed with the PTAB on 4-16-13 and 4-14-14, respectively. A settlement agreement has been made between all parties to withdraw the 2011 PTAB appeal. In accordance with the agreement, the 2012 PTAB appeal will be withdrawn upon certification of the 2015 assessment by the DuPage County Board of Review and the 2013 PTAB appeal will be withdrawn upon the 2016 assessment by the BOR. The parties request that the PTAB stay the 2012 and 2013 appeals until certification by the BOR of the 2015 and 2016 Medinah Country Club assessments.

kk. Lashon Defell: #12-29839-R-1 (Cook – Thornton)

Appellant originally filed with the PTAB on 4-11-13 and did not request an oral hearing. The Cook County Board of Review submitted their Notes on Appeal form and did request an oral hearing. A Hearing Notice (dated 3-17-15) was mailed to the address provided by the Appellant containing a hearing date of 5-26-15. The Appellant did not appear on this date and the appeal was dismissed on 5-29-15 for a No Show. Per correspondence received 6-11-15, Appellant requests the PTAB reinstate the appeal and states that the hearing notice was not received.

ll. Dolton Limited Partnership: #09-36036-C-2 (Cook – Thornton)

Appellant, represented by counsel, originally filed with the PTAB on 1-20-14. The Cook County Board of Review was notified of the appeal on 6-27-14. A certificate was received by the BOR but evidence was not and a default notice was generated and mailed on 12-26-14. There are no Intervenors. A decision was written based on the evidence presented in the file and was dated and mailed on 4-24-15. The Appellant's counsel has submitted a Motion to Issue Amended Decision for the 2009 appeal. Motion states the decision was not received and the time period for filing a 2010 direct appeal with the PTAB from the decision issued in the 2009 appeal has expired. Appellant's counsel has submitted a signed affidavit stating the previous.

mm. Nick Penesis: #09-26090-R-1 (Cook – Jefferson)

Appellant originally filed with the PTAB on 8-17-10 requesting an oral hearing, which was later waived when rebuttal evidence was received. The Cook County Board of Review was notified of the appeal on 10-3-11 and submitted sufficient evidence requesting an oral hearing. A decision was written based on the evidence presented with the appeal. This decision was dated and mailed on 4-24-15. The Appellant has filed a Petition for Amended Decision, dated 5-26-15. Petition states the PTAB's decision had calculation errors and the property should have been designated as Class 2-11 with a median level of assessment of 9.21% applied rather than 16%. Petition further states that the PTAB agreed with a class change from 3-15 to 2-11 for the 2008 appeal but failed to address the classification argument for 2009 and left the improper Class 3-15 designation unchanged. Appellant has also filed a Complaint for Administrative Review with the Circuit Court of Cook County.

nn. Brennan Investment Group, LLC: #13-29116-I-3 (Cook – Leyden)

Appellant, represented by legal counsel, originally filed with the PTAB on 4-4-14. An initial review of the appeal indicated an insufficient filing and an incomplete checklist with a 30-day extension was sent to the Appellant with a due date of 11-27-14. Appellant timely responded with an additional extension request of 30-days. The PTAB processed this request with the second extension due on 1-21-15. Information to complete the filing was not received and the appeal was dismissed for insufficient evidence on 6-3-15. Per correspondence received 6-17-15, Appellant is requesting the PTAB reinstate the appeal stating the second extension letter from the PTAB was not received. Evidence of a 2012 Recent Sale claim is included with request.
