Request further states that an appraiser was recently retained and that there are settlement communications regarding the pending 2009-2011 PTAB appeals regarding the same property.

Intervenor, C.U.S.D. #300, originally filed with the PTAB on 3-13-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

- x. Delnor Community Residence: #13-02534-R-3 (Kane)

Intervenor, St. Charles C.U.S.D. #303, originally filed with the PTAB on 3-5-15. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the preparation of an appraisal and cites a lack of cooperation by the Appellant as reason for the delay.

Intervenor will be deciding in the upcoming days whether to request a subpoena or move forward with the appraisal in the absence of the requested information.

- y. Edward Borkowski: #13-29652-C-3 (Cook – Leyden)

Intervenors, City of Northlake, Northlake Fire Protection Dist., S.D. #87, Addison River Conservancy, Northlake Public Library Dist., originally filed with the PTAB on 4-27-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to finalize a proposed stipulation or to obtain and submit evidence. Intervenors attached a tentative stipulation agreement.

- z. Robert & Helena Humpf: #12-05351-R-1 (DuPage)

Appellant filed the above appeal on 7-1-15 with the PTAB from a 2011 decision dated 11-21-14, over 7 months late. A cover letter accompanied the appeal stating that the PTAB decision received by the Appellant was missing the last page, which indicates the possibility of a Direct Appeal within 30-days of the date of the decision. The Appellant did not know the significance of the missing page until an inquiry was made to the DuPage County Treasurer's Office regarding a refund check and the Appellant was asked about filing for 2012 with the PTAB.

- aa. Edward Richards: #12-34250-R-1 (Cook – W. Chicago)

The above appeal was made Ready for Hearing on 4-2-15, which automatically granted the Appellant a 30-day extension until 5-2-15 to submit rebuttal evidence. Per correspondence received 7-2-15, Appellant indicates he was in Hong Kong and China from 4-2-15 until 6-2-15 and did not receive the letter and evidence until 6-3-15. Appellant is requesting an extension of time to file the rebuttal evidence or a reversal of the Ready Hearing letter. Accompanying the request was a copy of the Appellant's credit card statement indicating a purchase of an airline ticket and a copy of his passport.

- bb. Richard Wyszynski: #12-30489-R-1 (Cook – W. Chicago)

The above appeal was made Ready for Hearing on 5-5-15, which automatically granted the Appellant a 30-day extension until 6-4-15 to submit rebuttal evidence. Per correspondence received 6-22-15 and 7-3-15, Appellant indicates he was confined to a hospital from 3-13-15 through 4-5-15 for cardiac surgery and then transferred to a rehabilitation facility until 6-6-15. This is confirmed from a fax received from the hospital. Appellant indicates that he lives by himself with no family or friends, no transportation, and no computer. Appellant has submitted a motion to extend the rebuttal time period.

- cc. Marquardt School District No. 15: #12-03847-I-3 (DuPage)

Intervenor (owner), KTR Capital Partners, originally filed with the PTAB on 10-24-14. A total of 180-days has been granted for the submission of evidence with the latest expiring on 6-15-15 (Monday). Evidence was received postmarked 6-16-15 and the Intervenor was defaulted on 6-25-15 with the file being made Ready for Hearing on the same day. Per correspondence received 6-30-15, Intervenor acknowledges the evidence was one (1) day late and submitted a Motion to Reconsider along with an affidavit. The Motion states that the paralegal responsible for mailing the evidence was a victim of domestic violence and was absent during the evidentiary filing time period for the above Intervenor.

dd. Jorge Trujillo: #13-27406-C-1 (Cook – Lake)

Appellant, represented by counsel, originally filed with the PTAB on 3-17-14. A 60-day extension was granted, as requested, expiring on 12-23-14. On 12-8-14 a withdrawal request was received from Appellant's counsel regarding the above appeal and a dismissal letter was generated and mailed on 12-15-14. A Motion to Reconsider and/or Vacate Withdrawal was received on 7-13-15 from new counsel representing the Appellant. Motion states the Appellant was out of the country tending to a family emergency during the 60-day extension period in 2014 and there was inadequate communication between Appellant and Appellant's counsel resulting in counsel's withdrawal by his own volition.

ee. Michael Kazarian: #14-22255-C-1 (Cook – Berwyn)

Appellant, represented by counsel, originally filed a Commercial Appeal with the PTAB on 12-30-14. The appeal form and a cover sheet both listed 4 parcel numbers being filed (16-19-427-025 thru -028). An addendum and/or a breakdown for each parcel was not included and an incomplete checklist and 30-day extension was generated and mailed to the Appellant's counsel on 4-17-15 with a due date of 5-17-15. The requested information was not received and the appeal was dismissed on 7-2-15. Per correspondence received 7-9-15, counsel states the incomplete checklist was never received and asks that the PTAB reinstate the appeal. A completed addendum was included with the reinstatement request and an additional parcel number (16-19-427-024) has been added to it for a total of 5 parcel numbers. The BOR decision attached to the petition included 5 PINS.

In each of the appeals listed above, Appellant originally filed with the PTAB on Thursday, 4-16-15 (postmarked), from a DuPage County Board of Review decision dated 3-16-15, one-day late. The appeals were dismissed for untimely filing on 6-16-15. Per correspondence received 6-24-15, Appellant has submitted mail receipts showing the appeal forms were mailed on 4-16-15 and they believe this date is 30-days from the 3-16-15 BOR decision. The Appellant is requesting the PTAB reinstate the appeals.

- gg. David & Mary Sterling Trust: #14-03370-R-2 (DuPage)

Appellant originally filed with the PTAB on 4-21-15 (postmark) from a DuPage County Board of Review (BOR) decision dated, 3-16-15. The appeal was dismissed for untimely filing on 6-16-15. Per correspondence received 6-29-15, Appellant is requesting the PTAB reinstate the appeal stating the postmark on the decision's envelope is dated 4-1-15, thus making the filing date of 4-21-15 timely. A copy of the envelope was provided along with the request, however, the decision was not mailed to the Appellant from the BOR but rather from Illinois Real Estate Tax Appeal, Inc.

- hh. Yasir Kanan: #14-21417-R-1 (Cook – Lake)

Appellant, represented by counsel, originally filed with the PTAB on 12-24-14. An incomplete checklist and 30-day extension letter was generated and mailed on 3-27-15 with a 4-26-15 deadline to submit evidence to support Recent Sale claim checked on appeal form. A response was not received and the appeal was dismissed for insufficient evidence on 7-2-15. Per correspondence received 7-13-15, Appellant is requesting the PTAB reinstate the appeal stating a copy of a HUD settlement statement was submitted with the appeal. A copy of this evidence was included with the request. The PTAB copies of original filing received on 12-24-14 do not contain the evidence submitted along with the reinstatement request.

- ii. Beloit Memorial Hospital, Inc.: #13-02484-C-3 (Winnebago)

Appellant filed a motion to dismiss the Intervenors, Hononegah Community High School Dist. No. 207 and Kinnikinnick Comm. Consolidated School Dist. No. 131, due to the fact that the resolutions that accompanied the Requests to Intervene authorized the school districts' legal representatives to intervene in the 2013 and 2014 Winnebago County BOR appeals and in the 2011 and 2012 appeals before the PTAB. The Appellant argued that none of the resolutions submitted by the school districts' authorized the legal representative to intervene in the 2013 appeal before the PTAB.

In response the school districts' counsel assert that the Requests to Intervene were accompanied by properly adopted resolutions authorizing the Requests to Intervene and were not returned by the PTAB as incomplete. The resolutions that were submitted with the Requests to Intervene provided the legal representative the authority to intervene in the 2013 and 2014 Winnebago County BOR appeals and in the 2011 and 2012 appeals before the PTAB.

Section 1910.60(d) & (e) of the PTAB's rules provide in part:

*d) Intervenors*

- 1) *Any taxing body that has a revenue interest in an appeal before the Property Tax Appeal Board may become an intervening party by filing in triplicate with the Clerk of the Property Tax Appeal Board a Request to Intervene through legal counsel in accordance with Section 1910.70(c). The Request to Intervene must be filed within the later to occur of:
  - A) 60 days after the postmark date of the notice of the Board to the State's Attorney of the filing of an appeal; or
  - B) within 60 days after the postmark of the board of review service as required in Section 16-180 of the Property Tax Code.*
- 2) *The Request to Intervene must be accompanied by a copy of the resolution of the governing board of the taxing body authorizing its legal representative to file a Request to Intervene on its behalf.*

*e) Intervenors – Taxing District and Taxpayer/Owner – . . . Any Request to Intervene that is received without a properly adopted copy of the resolution of the governing board of the taxing body authorizing its legal representative to file the Request to Intervene on its behalf shall be treated as incomplete and shall be returned. The filing of an incomplete Request to Intervene shall not extend the 60 day deadline without a written request explaining good cause for failure to timely submit a properly completed Request to Intervene and resolution.*

The BOR certificate notifying the taxing districts of the appeal as required by section 16-180 of the PTC was dated December 17, 2014. 60 days from December 17, 2014 expired on Sunday, February 15, 2015, which then extended the filing to Monday, February 16, 2015, a holiday (President's Day), extending the date on which to file the Request to Intervene to Tuesday, February 17, 2015. The Requests to Intervene were filed by the taxing districts using FedEx with a tracking label dated February 17, 2015. Neither of the Requests to Intervene had resolutions that provided the express authority for the legal representatives to intervene in the pending 2013 appeal before the PTAB.

It should be noted that if the PTAB had determined the Requests to Intervene were incomplete at the time of filing (which was on the 60<sup>th</sup> day following the

BOR notice of the appeal to the taxing districts), this would not have extended the time to file a properly completed request to intervene and resolution. Please also note that the school districts are parties to the 2011 (11-01316) and 2012 (12-03161) pending appeals of the same property.
