Letter from appraiser (11-19-15) indicates a 90-day extension is needed to complete the assignment of appraising this 127,197 square foot, one-story, commercial building on a 451,141 square foot site.

In each of the appeals listed above, Intervenor, C.U.S.D. #300, originally filed with the PTAB on 8-11-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

Intervenor, Lemont Park District, originally filed with the PTAB on 8-11-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

- u. Aptakisic Creek Corporation LLC: #12-05337-I-3 (Lake)

Intervenors, Adlai E. Stevenson H.S.D. #125 and Aptakisic-Tripp S.D. #102, originally filed with the PTAB on 8-5-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to determine whether a settlement can be reached or an updated appraisal completed.

- v. BRE/ESA P/ Portfolio, LLC: #14-03027-C-3 (DuPage)

Intervenors, College of DuPage #502, Itasca Community Library Dist., Itasca Fire Protection Dist., Itasca Park Dist., Itasca S.D. #10, and Lake Park H.S.D. #108, originally filed with the PTAB on 7-8-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (10-6-15) indicates professional commitments as reason for extension request.

- w. Beloit Memorial Hospital, Inc.: #13-02484-C-3 (Winnebago) Motion to Reconsider

On 8/18/15 the PTAB granted the Appellant's Motion to Dismiss Intervenors, Hononegah Community High School Dist. No. 207 and Kinnikinnick Comm. Consolidated School Dist. No. 131, due to the fact that the resolutions that accompanied the Requests to Intervene authorized the school districts' legal representatives to intervene in the 2013 and 2014 Winnebago County BOR appeals and in the 2011 and 2012 appeals before the PTAB. The appellant argued that none of the resolutions submitted by the school districts' authorized the legal representative to intervene in the 2013 appeal before the PTAB.

The Intervenors filed a Motion to Reconsider and Vacate the Dismissal of the Intervenors. The Intervenors argued the Property Tax Code authorizes the PTAB to establish by rules an informal procedure for the determination of the correct assessment of property, and to the extent the Board considers practicable, shall eliminate formal rules of pleading, practice and evidence. They noted that section 1910.60 of the PTAB's rules provides: "The Request to Intervene must be accompanied by a copy of the resolution of the governing board of the taxing body authorizing its legal representative to file a Request to Intervene on its behalf" (86 IllAdmin.Code 1910.60(d)(2)).

In the Motion the school districts cited to the various resolutions that accompanied the Request to Intervene in the 2013 PTAB appeal. The resolutions submitted with the Request to Intervene authorized intervention in the 2013 and 2014 BOR appeals and in the 2011 and 2012 appeals before the PTAB under Docket Nos. 11-01316 and 12-03161. There was no specific resolution from the governing boards of the school districts authorizing intervention in the 2013 PTAB appeal. Counsel argued there is no possible reason why the governing boards would want to intervene in the enumerated proceedings but not in the present appeal. Counsel argued that the resolutions submitted leave no room for doubt as to whether the governing boards wanted their legal representative to intervene in this matter. The school districts argued that the resolutions submitted do not even permit, let alone require, the conclusion that the undersigned counsel had the authority to intervene in the 2013 appeal. Counsel argued the authority to intervene was obvious.

The Intervening School Districts requested the PTAB reconsider and vacate its ruling on the Appellant's Motion to Dismiss Intervenor, reinstate the Intervenor and accept the Intervenor's evidence.

The Appellant filed an Objection to the Motion to Reconsider and Vacate Dismissal of Intervenor. The Appellant argued in part that the PTAB is without jurisdiction to entertain the Motion to Reconsider asserting the PTAB's website provides, "the Board's enabling statute provides no means for rehearing or reconsideration of its decisions for substantive reasons." Second, the appellant argued that the PTAB's order of August 18, 2015, terminated the Intervenor's rights as parties to the appeal, making the order a final appealable decision. The Appellant argued that the Intervenor had 35 days from the date of the PTAB's order to file their complaints for administrative review in the Appellate Court. Third, the Appellant argued that the Resolutions submitted by the school districts specifically authorized intervention in the BOR Appeal No. 2013-11COM-0387 and not in the 2013 PTAB appeal.

In reply the Intervenor asserted the PTAB has jurisdiction to grant the relief requested in the Intervenor's motion in that the PTAB's August 18, 2015 ruling was interlocutory and not a final order appealable in the courts pursuant to the Administrative Review Law. The Intervenor also argued that the PTAB's rejection of the resolutions would lead to absurd results in light of the fact that

they have intervened and submitted evidence in the PTAB's 2011 and 2012 appeals.

x. Brian Radford: #14-03448-C-1 (St. Clair)

On 4-11-15, the PTAB received three copies of an appraisal report dated 4-3-15. Attached to the appraisal was a business card for R & R Glass along with a name and address for Brian Radford. The PTAB did not have any pending appeals for this person and proceeded to send a pending letter with a 30-day extension along with appeal forms and a checklist that accompanies all new appeals to aid the taxpayer in completing the forms. This letter and forms were dated and mailed on 5-5-15 with a 6-4-15 deadline. On 5-29-15, Appellant returned three copies of our Residential Appeal and three additional copies of same appraisal and a package of the properties tax history from the St. Clair County Assessor and Collector. Appellant did not provide a breakdown for his requested assessment nor a final decision from the St. Clair County Board of Review. A second 30-day extension was granted to the Appellant with a deadline of 8-9-15 to complete Commercial appeal forms with the requested breakdown completed and a BOR original decision. On 7-31-15, Appellant returned corrected Commercial appeal forms with assessment request completed, however, the requested final BOR decision was not included. Appellant did include an Estimate of Real Estate Redemption from the St. Clair County Clerk's office. The PTAB dismissed the appeal on 10-9-15 for lack of jurisdiction. The Appellant could not provide proof of filing with his local Board of Review. Per correspondence received 11-2-15, Appellant is requesting the PTAB reinstate his appeal including parcel information reports of surrounding properties only.

y. Herman & Barbara Munic: #14-00435-R-1 (Lake)

The Lake County Board of Review was notified of the above filing on 4-7-15 along with a 90-day extension expiring on 7-6-15. A review of the file indicated a response was not received from the BOR and a default letter was generated and mailed on 10-30-15. The file was made Ready for Hearing on the same day. Per correspondence received on 11-5-15 the BOR is requesting the PTAB vacate the default stating they never received the Appellant's submission on 4-7-15. The request is accompanied by evidence but not Notes on Appeal. A review of the file indicates two appeal forms and evidence missing from file.

- z. Narendra Narepalem: #14-00773-R-1 (Lake)

The Lake County Board of Review was notified of the above filing on 4-16-15 along with a 90-day extension expiring on 7-15-15. A review of the file indicated a response was not received from the BOR and a default letter was generated and mailed on 10-30-15. The file was made Ready for Hearing on the same day. Per correspondence received on 11-5-15 the BOR is requesting the PTAB vacate the default stating they never received the Appellant's submission on 4-16-15. The request is accompanied by evidence but not Notes on Appeal. A review of the file indicates two appeal forms and evidence missing from file.
