requesting a Motion for Reconsideration stating the Intervenor did not show good cause with its latest request for an extension and neglected to inform the PTAB that the appraiser inspected the property on 2-26-16 long after the first extension was granted on 7-23-15. Appellant is requesting the PTAB deny the Intervenor's request for an additional extension of time and default the Intervenor in this matter. The Intervenor was served a copy of the 5-10-16 Motion and has responded (5-11-16) by saying the Appellant has failed to comply with the basic requirements of Section 1910.64 of the Rules of Practice and Procedure for Appeals before the PTAB. Intervenor states they have been very diligent in requesting very specific and relevant documents from the Appellant on 10-7-15 and was informed that the documents should be forthcoming in the near future but a formal response was not received until 1-13-16 from the Appellant. Letter from appraiser (4-15-16) references unforeseen circumstances as reason for the 90-day extension request.

- hh. Carbondale Hucks, LLC.: #15-00244-C-3 (Jackson)

The Appellant, represented by counsel, filed with the PTAB on 1-15-16. An extension of time for the submission of an appraisal accompanied the filing. An initial review of the appeal indicated items missing to move forward including a Board of Review original decision proving timely filing. A return checklist with a 30-day extension was generated on 3-10-16 with a due date of 4-9-16. On 3-11-

16, the PTAB received a Motion to Dismiss filed by the Jackson County Board of Review's attorney (the BOR has not been notified of the filing by our office as of yet). The Motion states the Appellant did not have a hearing or a final decision from the BOR. This Motion was forwarded to the Appellant on 3-15-16. A response was received from the Appellant on 4-14-16 along with another extension request pending the PTAB's ruling on the BOR's Motion. Response states a Notice of Proposed Change in Assessed Value dated 12-16-15 was received from the Jackson County BOR with a 10-day window to request a hearing. The Appellant contends an appeal was filed within 30-days of the written notice from the BOR and the Motion does not support the contention that Appellant failed to exhaust administrative remedies by citing the Property Tax Code (PTC) or the PTAB's rules. Appellant further states the PTC does not define what constitutes a decision upon which jurisdiction will attach.

ii. Commonwealth Edison: #11-22978-I-2 (Cook – Stickney)

A decision (reduction) based on the evidence presented in the file was rendered on 3-18-16. On 4-22-16, Intervenor, represented by counsel, filed a Motion to Vacate Decision stating they did not have an option to request an oral hearing in the matter. Motion further states the appraisal submitted by Intervenor raised issues that could have been resolved at a hearing by having the appraiser to testify and defend the report.

jj. Thomas Ulie: #14-03690-R-1 (Lake)

Appellant filed the above 2014 appeal with the PTAB on 9-21-15. A decision for the Appellant's 2013 PTAB appeal (13-00962-R-1) was rendered on 9-19-14, reducing the Subject's assessment. The 2014 appeal was docketed and then dismissed for untimely filing on 5-13-16. Per correspondence received 5-23-16, Appellant is requesting the PTAB reinstate the appeal asserting the PTAB's 2013 decision was not received.

A no change decision was rendered by the PTAB for the above appeal on 4-22-16. An oral hearing was not conducted and the decision was written based on the evidence presented in the file. Per correspondence received 5-23-16, the Appellant has filed a Motion for Reconsideration based on contention of law for correction to assessment and market value. Appellant states the PTAB did not consider all of the evidence and discrepancies in the decision were found and noted. Appellant further states that exceptions were granted to the evidence submitted by the BOR that violates the appeal process.

Per correspondence from the Taxpayer dated 5-7-16, Appellant requests the PTAB reinstate the appeal stating neither she nor her attorney received a hearing notice. She requests the PTAB write the decision based on the evidence in the file or if a hearing must be scheduled, to please schedule before 8-19-16 since she is a public school teacher. The Cook County Board of Review has requested an oral hearing.

In each of the appeals listed above, Appellant, represented by counsel, filed with the PTAB on 2-9-16. A 60-day extension was requested with the original filing and this was granted on 3-10-16 with a due date of 5-9-16. The notification/extension letters were sent electronically and delivered to the counsel's email address provided on the appeal form. On 5-27-16, counsel hand-delivered a Motion for Reinstatement of Appeals to the PTAB (appeals have not been dismissed as of yet). A check of the email status by the PTAB concluded this particular email was opened 3 different times by the receiving end. Counsel writes that he did not receive the email sent out by the PTAB on 3-10-16 and only knew of it by calling and inquiring about the appeals. Motion states the PTAB's new office procedure is bound to have errors during the initial phase of the new procedure and parties should be given some leeway during the transition period.

oo. Three Step Holdings LLC: #12-30398-C-2 (Cook – Hanover)

Intervenor, Elgin S.D. U-46, originally filed with the PTAB on 6-16-14. All evidence was received and the file was made Ready for Hearing on 12-2-14. On 4-8-16, the PTAB received a stipulation from the Cook County Board of Review and issued a decision from this stipulation on 5-20-16. Per correspondence received 5-31-16, the Intervenor has filed a Motion to Vacate Final Administrative Decision. Motion states the stipulation was signed by the BOR and the Appellant only and was never circulated to the Intervenor and this violates Section 1910.55 (c) of the Official Rules of the PTAB. The Intervenor requests that the PTAB vacate the decision and reinstate the appeal in order to allow the parties to resolve this matter through settlement or if that is not possible, set the matter for hearing.

The Intervenor, Waltham S.D. #185, has filed an Application for Stay of PTAB Decision and Payment of Refund Pending Direct Review in the Appellate Court. Pursuant to Supreme Court Rule 335(g), the School District respectfully requests that the PTAB stay its April 22, 2016 decision and payment of any refund arising out of that decision pending the outcome of the appeal.
