A total of 120-days has been granted for the submission of evidence. Intervenors are requesting an additional unspecified extension for the completion of an appraisal. Letter from appraiser (6-2-16) indicates a 60-day extension is needed because of professional commitments.

- y. John Gallagher & Henry: #14-28449-R-2 (Cook – Palos)

Intervenors, Palos C.C.S.D. #118 and C.H.S.D. #230, originally filed with the PTAB on 12-4-15. A total of 120-days has been granted for the submission of evidence. Intervenors are requesting an additional unspecified extension to file evidence due to unforeseen circumstances.

- z. Sears Holding Corporation: #14-29650-C-3 (Cook – Orland)

Intervenors, C.H.S.D. #230, Orland Fire Protection Dist., Orland Park Public Library, Orland S.D. #135, and Village of Orland Park, originally filed with the PTAB on 12-18-15. A total of 120-days has been granted for the submission of evidence. Intervenors are requesting an additional unspecified extension to file evidence due to unforeseen circumstances

- aa. Kohl's Illinois, Inc.: #15-00093-C-3 (Kankakee)

Intervenor, Village of Bradley, originally filed with the PTAB on 3-24-16. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to file evidence and/or a brief.

Intervenors, Bradley S.D. #61 and City of Kankakee, originally filed with the PTAB on 3-24-16. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to commence settlement discussions of this 2015 appeal. Should this matter fail to settle, evidence will be filed.

Intervenors, Itasca Community Library Dist., Itasca Fire Protection Dist., Itasca Park District, Itasca S.D. #10, and Lake Park H.S.D. #108, originally filed with the PTAB on 3-21-16. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to analyze the Appellant's evidence to determine whether or not an appraisal should be obtained.

- dd. Christopher Foreman: #15-20171-C-3 (Cook – Norwood Park)

Intervenors, Eisenhower Library Dist., Norwood Park Fire Protection Dist., Ridgewood S.D. #234, and Union Ridge S.D. #86, originally filed with the PTAB on 2-25-16. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (5-23-16) indicates professional commitments as reason for extension request.

- ee. Johnson Controls Battery Group Inc.: #14-02328-C-3 (Kane)

Intervenor, Geneva C.U.S.D. #304, originally filed with the PTAB on 3-2-16. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to file evidence. Intervenor states they have been involved in the 2012 Byron Nuclear Power Station trial with the PTAB and post-hearing briefing in the Ford County One Earth Energy ethanol plant appeal and that these two matters have commanded the majority of counsel's time over the last several months.

- ff. KV & Sons, LLC Oswego: #15-00561-C-2 (Kendall)

Intervenor, C.U.S.D. #308, originally filed with the PTAB on 3-29-16. A total of 90-days has been granted. Intervenor is requesting an additional 60-day extension to file evidence. Intervenor states they have been involved in the 2012 Byron Nuclear Power Station trial with the PTAB and post-hearing briefing in the Ford County One Earth Energy ethanol plant appeal and that these two matters have commanded the majority of counsel's time over the last several months.

- gg. Kraft Heinz Foods Co.: #15-00250-I-3 (Madison)

Intervenor, Granite City C.U.S.D. #9, originally filed with the PTAB on 3-25-16. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to file evidence.

- hh. One Earth Energy, LLC: #15-00723-I-3 (Ford)

Appellant originally filed with the PTAB on 2-18-16. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an extension until after the final judicial resolution of the 2009 One Earth Energy appeal with the PTAB. Request further states that this request has already been granted by the PTAB for years 2011 through 2014.

- ii. Anthony Cassello: #11-26089-C-1 (Cook – Thornton)

Appellant, represented by counsel, originally filed on two parcels with the PTAB on 3-29-12 indicating on the Commercial Appeal form that the PTAB could make its decision based on the evidence provided (no oral hearing necessary). The Cook County Board of Review submitted evidence on 11-6-13 indicating that an oral hearing was requested. On 3-18-16 a PTAB decision was issued based on the evidence presented in the file and an oral hearing was not held. Per correspondence received 6-9-16, Appellant has filed a Motion to Vacate Decision through his counsel. Motion states that the Cook County Assessor issued

Certificates of Error (COE) for these parcels which were approved by the Circuit Court of Cook County and established final values but the attorney working on this appeal was unaware of the COE determination. Motion goes on to state the appeals would have been dismissed had he been aware the Court had made this determination.

jj. John Joyce: #11-23218-R-1 (Cook – New Trier)

Appellant, represented by counsel, originally filed with the PTAB on 3-5-12 indicating on the Residential Appeal form that an oral hearing was requested. The Cook County Board of Review submitted evidence on 8-2-13 and did not request a hearing. A decision on the evidence without a hearing was issued on 5-20-16 (a reduction). Per correspondence received 6-10-16, Appellant's counsel has filed a Motion to Vacate Decision and for the PTAB to schedule a hearing on this matter.

kk. 825 N. Hudson Condo Assoc.: #10-32186-R-1 (Cook – North Chicago)

Appellant, represented by counsel, originally filed with the PTAB on 8-12-11 (5 parcels) requesting an oral hearing as indicated on the Residential Appeal form. The Cook County Board of Review submitted evidence on 5-2-13 and also requested an oral hearing. A Hearing Notice (dated 6-12-15) was issued with a date set on 8-4-15 at 9:30 a.m. On 8-3-15 a signed stipulation by both parties was received by the PTAB and a decision using these amounts was issued on 1-22-16. On 2-10-16, after the issuance of the PTAB decision, a Letter of Withdrawal signed by the Appellant only was received on a BOR letterhead. This information was not processed due to a previous decision. Per correspondence received 6-2-16 from the Appellant's counsel, a Motion to Vacate the 1-22-16 PTAB decision is requested because of a Certificate of Error that has been issued for these parcel numbers.

ll. Cary Kochman: #11-21084-R-2 (Cook – New Trier)

Appellant, represented by counsel, originally filed with the PTAB on 1-31-12 and indicated that an oral hearing was **not** requested. The Cook County Board of Review filed evidence and Notes on Appeal form on 6-19-13 indicating that an oral hearing was **not** requested. There are four (4) Intervenorors that are a party to the appeal and all are represented by the same counsel. On 5-20-16, a Final Administrative Decision was issued by the PTAB reducing the assessment. Per correspondence received 6-2-16, the Intervenorors are requesting the PTAB Vacate the PTAB's 5-20-16 Decision, Reinstate the Appeal, and Schedule a Hearing on the Merits. The request further cites PTAB Rule 1910.67 (b) that the "Board shall hold a hearing at the request of any party in writing." 86 Illinois Administrative Code §1910.67 (b). The Intervenorors did request a hearing. The Appellant's

counsel filed a response asserting that the proceeding before the PTAB terminated when it rendered a decision and there is no authority for a motion to vacate a PTAB decision under the circumstances of this case. The Appellant asserts the remedy available to the Intervenor is an action in administrative review.

- mm. Jeffrey Hammes: #11-21027-R-1 (Cook – New Trier)
Sander Berman: #11-31752-R-1 (Cook – Northfield)

In each of the appeals listed above, an oral hearing was scheduled for 4-25-16. On 4-19-16, a signed stipulation was entered for each file and decisions were issued by the PTAB using these amounts from the stipulations on 5-20-16. Per correspondence received 6-28-16, Appellant is requesting the PTAB vacate the decisions and allow each appeal to be withdrawn. Request states the petitioner inadvertently agreed to a “rollover” of the prior year decisions and stipulated to a value in 2011 which actually raised the value to higher than that proposed by the Board of Review. The motion states that Nick Jordan, Deputy Commissioner from the Cook County Board of Review, has no objection to the reopening of these appeals for the purpose of dismissing the cases.

In each of the appeals listed above, Appellant, represented by counsel, originally filed with the PTAB on 2-12-16. The filings were deemed incomplete and a 30-day extension was granted with a checklist on 3-10-16 with a due date of 4-9-16. Appellant’s counsel sent an extension request of 30-days on 5-2-16 (3-weeks late) for each of the appeals. A dismissal letter was issued by the PTAB on 6-2-16 for untimely filing. Per correspondence received 6-7-16, Appellant requests reinstatement of appeals adding that an extension request was sent to PTAB followed by evidence for each appeal. He asserts he did not see the original email from the PTAB for 15-00576-R-1 but did not reference the other docket numbers.

- oo. Welsh Properties: 11-03093-I-3 (DuPage)
Welsh Properties: #12-03987-I-3 (DuPage)

In each of the appeals listed above, the Appellant has filed a Taxpayer's Motion to Stay the Proceedings until the 2016 and 2017 assessments are finalized. The Appellant, DuPage County Board of Review, and Intervenors have agreed on 2016 and 2017 assessments that will result in the Appellant withdrawing the 2011 and 2012 PTAB appeals. Appellant states that once the BOR issues a final decision that is agreed upon for the 2016 and 2017 assessments and there are no under-assessment appeals filed by taxing districts, the Appellant will request a withdrawal of the 2011 and 2012 appeals.

- pp. Jon & Lin Weiss: #11-34045-R-1 (Cook – Northfield)

A decision was rendered by the PTAB on 6-24-16 using a stipulation agreed to between the parties to the appeal. Counsel listed on this appeal has contacted the PTAB to request the decision be vacated and the appeal withdrawn. The request states that this appeal was a "rollover" from a 2010 PTAB decision and, unknown to counsel, the Appellant filed on their own appeal and received further relief adding that the 6-24-16 PTAB decision would in effect raise the assessment and create a tax bill, which was not their intention.
