Appellant, represented by counsel, originally filed a 2010 Direct Appeal with the PTAB on 2-9-15 requesting a total assessment of \$23,122. This appeal was timely filed from a 2009 PTAB reduction resulting from a stipulation between the Appellant and the Cook County Board of Review with a total assessment amount of \$27,363. The BOR was notified of the completed 2010 appeal on 6-19-15 and timely filed Notes on Appeal and evidence on 8-26-15. Evidence included a brief which states the subject property is not owner-occupied and the total assessment of the subject property is \$29,971. A “No Change” decision without a hearing was issued on 1-22-16 confirming the BOR’s assessment of \$29,971. Per correspondence received 10-28-16, Appellant submitted a Motion to Rescind Decision and Issue Amended Decision Instantly. Motion states the Appellant and the BOR agreed to settle triennial (2009-2011) tax years at an assessment of \$27,363 and a stipulation signed by the Appellant was sent to the BOR for execution on 10-23-15 but the PTAB issued a decision before the BOR could sign and return the 2010 PTAB stipulation form. Motion also states the BOR executed the 2010 stipulation on 8-23-16, ten months after the form was originally provided by the Appellant. Appellant states that this 10-month delay by the BOR should not prejudice them.

Appellant, represented by counsel, originally filed a 2011 Rollover Appeal with the PTAB on 6-11-14 requesting a total assessment of \$143,040. This appeal was timely filed from a 2010 PTAB reduction. The Cook County Board of Review was notified of the appeal and timely filed Notes on Appeal and evidence with a total assessment amount of \$182,050. A brief from the BOR states the subject property is not proven to be owner-occupied and does not receive a homeowner exemption according to the Cook County Assessor's website. A No Change decision based upon the evidence presented in the file was issued by the PTAB for the 2011 assessment year on 3-18-16. Per correspondence received 11-14-16, Appellant is requesting the PTAB issue a revised decision consistent with the agreed upon stipulation between the parties from the 2010 assessment year. Appellant states the property was owner occupied as of 1-1-11 and the absence of the homeowner's exemption is the result of a misunderstanding. The Appellant intends on filing a certificate of error to have it corrected and includes an affidavit confirming the home was owner occupied as of 1-1-11.

Evidence was not received and the appeals were dismissed on 10-7-16. Per correspondence received 11-2-16, counsel submitted evidence and a Motion to Vacate and Accept Evidence Instantly. Motion states that counsel was diagnosed with tongue and neck cancer on 4-8-16 and began chemotherapy for two months. The PTAB's 5-2-16 extension letters were misfiled and the mistake not discovered until receipt of the dismissal letter.

The Jackson County Board of Review was notified of the above Class 3 appeal on 3-10-16 and granted a 90-day extension for the submission of evidence. A review of the appeal indicated evidence was not received nor was a required Certificate indicating interested taxing districts were notified of the filing. A request for a Certificate was sent to the BOR on 10-20-16. A Certificate was received on 10-21-16 indicating the taxing bodies were notified of the appeal on 4-12-16. The Certificate received from the BOR referenced the 2015 docket number. On 11-4-

16, the BOR was defaulted and the appeal was made “Ready for Hearing”. On 11-10-16, the BOR provided the PTAB with an Amended Certificate indicating the taxing districts were notified of the appeal on 11-9-16. A cover letter was included explaining the original Certificate included a 2014 appeal of the subject property instead of the current 2015 appeal. A copy of the current appeal was included with the 11-9-16 Certificate mailing to taxing districts. A copy of the Amended Certificate was sent to counsel representing the Appellant. On 11-21-16, PTAB received a Motion to Deny Amended Certificate of Service from Appellant’s counsel. Motion states the BOR does not indicate how they became aware of this alleged error, nor is there an affidavit from the person or persons who allegedly discovered the error.

In each of the appeals listed above, a Joint Motion to Stay all Proceedings to Implement Settlement Agreement was received by the PTAB on 11-7-16. The parties to the appeal indicate a settlement agreement has been entered into for pending PTAB appeals for tax years 2012-2015. The settlement agreement calls for specific performance by the Appellant (Marquardt) and the owner (SVF Swift) that will be implemented over the next 3 years. Motion further states the BOR and Intervenors do not object to stay the proceedings or the withdrawal of pending appeals.
