Per correspondence received on both 12-7-15 and 1-7-16, Appellant has submitted documents for a Request for Reconsideration of Appeal Based on Lack of Uniformity of 2013 Assessment. Documents include a BOR 2002 decision and 2008, 2011, and 2012 PTAB decisions regarding this property.

Recommendation: Deny request for reconsideration.

ii. Kenneth Huang: #11-33751-R-1 (Cook - North Chicago)

Appellant originally filed with the PTAB on 11-16-15 requesting a Rollover from a 2010 PTAB decision regarding the same property, docket number 10-33265-R-1. The original decision for the 2010 appeal was dated and mailed on 4-24-15 but an Amended Decision was issued and mailed on 6-26-15 using stipulated amounts agreed upon by the Appellant and the BOR. On 10-8-15, the Appellant requested a copy of the 6-26-15 decision. This second copy of the 6-26-15 decision was mailed with a cover sheet to the Appellant on 10-21-15.

The receipt date for the 2011 appeal was received after the 7-26-15 deadline, almost 4 months later. The appeal was dismissed on 12-17-15 for untimely filing. Per correspondence received 1-20-16, Appellant is requesting the PTAB reinstate docket number 11-33751-R-1 stating it was filed within 30-days of the 10-21-15 receipt of their 2010 decision for same property.

jj. Jack Clarke: #11-34259-I-1 (Cook – Elk Grove)

Appellant, represented by counsel, has filed a 2011 Industrial Appeal regarding the above Appellant/Parcel number received by the PTAB on 1-5-16 (postmark). The appeal is being filed from a PTAB 2010 decision on same property dated 11-20-15. Appellant's counsel is requesting the PTAB accept this late filing (due date 12-20-15) stating he did not receive the link to the 2010 decision (10-27749-I-1). Google tracking shows the link to counsel's decisions was opened 6 times by 2 different computers/devices on 11-20-15. This link contained 12 decisions including the above. Counsel is not disputing the decisions of the other 11 appeals.
