The correct email address is listed on the original appeal form(s), which the PTAB failed to update. Counsel states that none of the correspondence sent by PTAB was received.

Appellant filed the above appeal with the PTAB on 1-17-17. His cover sheet states his original documents were mailed to the PTAB in March of 2016 but have apparently been lost or misplaced. The PTAB does not have a record of the appeal being received earlier. Appellant is requesting the appeal form and evidence, sent via certified mail, be accepted. The Notice of Findings by the Lake County Board of Review is included with a mailed date of 2-29-16. Evidence included with this 1-17-17 filing has a date of 3-12-16 printed on them.

Appellant originally filed with the PTAB on 12-22-15. The Madison County Board of Review was notified of the filing on 10-21-16. A required Certificate was received from the BOR on 10-31-16 indicating that all taxing districts were notified of this appeal on 10-27-16. Any interested taxing district requesting to intervene had until 12-26-16 to do so. The date of 12-26-16 happened to be a State Holiday so 12-27-16 was the acceptable deadline. On 12-28-16 (postmark), taxing district, City of Highland, represented by counsel, filed a Request to Intervene with the PTAB including a "draft Resolution" and promising to send an approved Resolution after its next meeting on January 3, 2017. On January 5, 2017 (postmark), an approved Resolution was received along with a cover sheet stating the Request to Intervene was only a day late (they believe the postmark date is 12-27-16) during the busy holiday season and they only found out about the Certificate being mailed out by calling the Madison County BOR. Presently, there is another Intervenor in this appeal that filed timely on 11-16-16.

Each appeal was dismissed on 12-16-16 for failure to appear. Dismissal letters state the parties remaining made a verbal motion to dismiss the appeal for want of prosecution. Appellant has sent a Motion to Vacate Dismissal requesting the PTAB reinstate each of the appeals (12-27-16). The Motion cites a calendar error and not an intentional failure as the reason for the no-show and stating that all other deadlines have been complied with.

Per correspondence received 1-4-17, Appellant has submitted a Motion to Vacate Decision by the PTAB. Motion states the proposed stipulation was not received and would have been rejected. Our I.T. Department checked the email and confirmed it was sent to the correct email addresses. The email scan was opened once on 10-4-15 and twice on 10-5-16. Appellant requests the PTAB enter an order vacating its Final Administrative Decision dated 12-23-15 and proceed to hearing. A signed affidavit from counsel is included with Motion stating the information was not received.

- uu. Ken Klassman: #12-31241-R-1 (Cook - Wheeling)

Appellant originally filed this appeal on 4-24-13 from a 2012 Cook County Board of Review decision. The appeal is based on a recent sale date of 1-28-11 with an affidavit and a settlement statement included. The BOR was notified of the appeal on 7-22-14 and the file made Ready for Hearing on 8-1-14. The Appellant submitted rebuttal evidence on 9-3-14 asking that their original request for an oral hearing to be withdrawn and a decision to be written on the evidence in the record. A "No Change" decision was issued by the PTAB on 12-23-16 with an assessment total of \$35,000. Per correspondence received 1-9-17, Appellant has submitted a Motion to Issue Revised Decision Reflecting Stipulation Provided. Motion states that in October of 2016 the Appellant and the BOR agreed to settle the 2011 and the 2012 appeals and that these signed stipulations were provided to the PTAB on 11-3-16, a copy of which was provided for the 2012 appeal. Appellant states the 2011 decision issued on 12-23-16 reflects the stipulated assessment total of \$28,000 but the 2012 appeal decision, issued on the same date, does not. Motion finally says the subject is an owner occupied residence that should have the assessment for both years of the same triennial as agreed upon by the parties.

The Champaign County Board of Review was notified of the above appeal on 7-29-16 with a 90-day extension granted and expiring on 10-27-16. Evidence was not received and the BOR was defaulted on 1-18-17. Per correspondence received on 1-26-17, the BOR is requesting the PTAB vacate the default stating the original PTAB notification letter regarding this docket number was never received.
