Per correspondence received 2-27-17, Appellant is requesting the PTAB reinstate the appeal describing the subject property as a 3-unit condominium building and states he has provided evidence of the sale price of the only internal sale within the condominium building during the relevant period of sales occurring on or after 1-1-12 and has met the burden of going forward and requests the PTAB reinstate the appeal.

Appellant, represented by counsel, originally filed with the PTAB on 3-15-16 and requested a 90-day extension to submit evidence. A 90-day extension was granted on 6-23-16 with a due date of 9-21-16. On 9-21-16, an appeal form with “comparable sales” checked and Section V (grid) containing two comparable properties were sent in as evidence. The appeal was dismissed on 1-26-17 for insufficient evidence. Per correspondence received 2-27-17, Appellant is requesting the PTAB reinstate the appeal describing the subject property as a 14-unit condominium building and states he has provided evidence of the sale price of the only 2 internal sales within the condominium building during the relevant period of sales occurring within the period from 3 years prior to and through the end of the 2015 tax year. In each of the appeals listed above, Appellant originally filed with the PTAB on 1-9-16. An initial review indicated a required item, Board of Review original decision, missing. A checklist with a 30-day extension was issued to each Appellant on 8-18-16. On 8-26-16 evidence was returned consisting of a 12-4-15 notice from the Cook County Assessor's Office indicating that further appeal is available through the Cook County Board of Review. The County Assessor's Notice was also sent with the original filing. The appeals were dismissed on 2-16-17 for lack of jurisdiction. Per correspondence received 3-1-17, each Appellant is requesting the PTAB reinstate their appeal and believe the assessment notice previously sent is sufficient.

Appellant, represented by counsel, directly (and timely) filed this Industrial Appeal with the PTAB on Monday, 2-22-16 (postmark), from a Final PTAB Decision issued on 1-22-16. Per boxes checked, the Appellant is basing the appeal on Contention of Law and Recent Appraisal. A total of 120-days was granted for the submission of evidence with a final due date of 9-8-16. Evidence to support the appeal was not received and it was dismissed for insufficient evidence on 10-21-

16. Per correspondence received 12-7-16, Appellant is requesting the PTAB reinstate the appeal. A log sheet regarding FedEx deliveries to PTAB is included with ship dates of 5-31-16, 7-15-16, 8-17-16, and 8-23-16 but does not include docket or parcel numbers to identify appeal. Request states that an extension request was submitted to the PTAB on 8-19-16 asking for a 15-day extension and then the necessary evidence was submitted on 8-23-16. Neither of these deliveries were received by the PTAB. Evidence, including a summary appraisal report, is also included with the request.

A second Motion for Reconsideration from the Appellant's counsel has been received by the PTAB for the above appeal on 2-28-17. This Motion states the Cook County Board of Review is aware of the dismissal and has agreed to sign a stipulation and forward it to the PTAB immediately if reinstated. Motion further states this was a direct appeal based on a reduction in the previous year's assessment and prior to PTAB's decision to dismiss, the BOR agreed to stipulate to a reduction of the subject property's 2011 aggregate assessed value from \$259,441 to \$225,688.

Appellant originally filed with the PTAB on 12-31-16 for the 2015 assessment year. A Cook County Board of Review decision was included with the filing for the 2001 assessment year. Per correspondence received 2-16-17, Appellant is requesting the PTAB reinstate the appeal with an exemption from the notification of filing period deadline from a BOR decision.
