A decision was rendered using the agreed upon total assessment valuation of \$204,138 on 12-23-16. Per correspondence received 4-14-17, Appellant has filed a Motion to Amend Decision. Motion states the stipulation for 2010 was intended by the parties to be a rollover of the 2009 fair market value of \$1,275,862, which resulted in an assessment of \$204,138 for 2009 as determined per the decision of PTAB. The Motion further states the Appellant and the BOR incorrectly overlooked the fact that the final assessed valuation for 2010 had been reduced to \$183,084 indicating a market value of \$1,408,338 based on an assessment level of 13%, rather than the 16% level which existed for 2009. The BOR and the Appellant have entered into an amended 2010 stipulation of \$165,862 using the correct assessment level of 13%. Appellant requests the PTAB amend the prior decision of 12-23-16 and reduce the 2010 assessed valuation to \$165,862 in accordance with the current stipulation.

Appellant, represented by counsel, originally filed with the PTAB on 5-15-06. A hearing was held on 2-13-08 with a favorable decision being rendered on 4-1-08. Per correspondence received 3-24-17, Appellant, now represented by different counsel, has filed a Motion to Revive Judgment stating the Cook County Treasurer's Office (CCTO) never issued a refund of the resulting property tax overpayment to the Appellant. New counsel states the Appellant's recent application for a refund was rejected by the CCTO on the grounds that the PTAB's decision was issued 7 years ago and has expired. Counsel states the judgment is subject to revival under 735 ILCS 5/2-1602. And requests the PTAB either reissue the decision with a current date, or enter the draft order for Revival of Judgment that has been prepared.

Appellant timely submitted information but did not complete Section 2c of the Residential appeal, the required assessments requests, which also included an addendum for 15-30193-

R-1. Each appeal was dismissed in March of 2017. Per correspondence received 4-10-17, Appellant is requesting the PTAB reinstate the appeal stating the evidence was sent to the PTAB. Along with the reinstatement request, Appellant completed Section 2c and included an addendum.

In each of the appeals listed above, Appellant asserts he filed his initial appeal through ProTaxAppeal and an attorney was assigned to his appeals. The attorney later withdrew from the appeals. Notice of the withdrawal of representation was sent to the Appellant by the attorney and the address was changed in our system so that all information would be sent to the Appellant's address, including the hearing notices for 4-12-17 and 4-13-17. The Appellant did not attend the hearings and both appeals were dismissed. Per correspondence received 4-18-17, Appellant is requesting the PTAB to reinstate both appeals stating he did not understand that the counsel who withdrew from the firm, represented his two appeals and he believed he was still being represented by someone from ProTaxAppeal.

Appellant, represented by counsel, originally filed with the PTAB on 4-10-17. A 90-day extension request accompanies the appeal. Counsel describes the parcel as comprising substantial portions of the Clinton Nuclear Power Station and will be dismissed if/when the pending settlement regarding Clinton Station is finalized by the parties.

Appellant originally filed with the PTAB on 5-10-16. A review indicated required information missing. A checklist with a 30-day extension was sent to the Appellant on 12-15-16 with a 1-14-17 due date. A response was not received and the appeal was dismissed on 3-9-17. Per correspondence received 3-30-17, Appellant is requesting the PTAB reinstate the appeal and included an appraisal of the subject property dated 1-1-15. Appellant claims the 3-9-17 PTAB dismissal letter is the only correspondence they have received since filing the original appeal.

ii. Walgreens Company: #15-05078-C-2 (DuPage)

The DuPage County Board of Review was notified of the above file on 7-28-16. A 90-day extension was granted for the submission of evidence due on 10-26-16. The BOR notified taxing districts of the appeal on 8-12-16. There are no Intervenor. The BOR did not submit their required Notes on Appeal or an extension request. On 4-4-17, The BOR submitted Notes on Appeal and an appraisal of the subject property. This prompted a review of the file and the BOR was defaulted for tardiness on 4-13-17. Per correspondence received 04-24-17, the BOR is requesting the PTAB rescind the default and accept the evidence sent in on 4-4-17 stating that the due date of 10-26-16 was at the height of their BOR session and hearings.
