For this reason, Appellant is asking the PTAB to Reinstate and Withdraw the Appeal.

A PTAB decision, based on a signed stipulation, was rendered on 12-23-16 following a scheduled hearing on 8-25-16. Appellant states there was a Certified Agreed Judgment Order entered that reduced the assessed value and this judgment supersedes the PTAB decision. Appellant is asking the PTAB to Reinstate and Withdraw the appeal.

In each of the appeals listed above, a PTAB "No Change" decision was rendered on 4-21-17 based on the evidence presented in each file. Per correspondence received 5-9-17, Appellant, represented by counsel, is requesting the PTAB Rescind Decision and Schedule for Hearing as Requested. Appellant states when appeals were originally filed a hearing was requested for both. A review of each file indicates the Hearing Requested box is checked for both docket numbers.

Appellant, represented by counsel, originally filed with the PTAB on 5-16-16. The appeal was reviewed as incomplete and a 30-day extension and checklist were sent to the attorney of record on 2-2-17 with a 3-4-17 due date. On 3-3-17, a request was received to withdraw the attorney of record and substitute a new attorney. This was completed. The appeal was reviewed a second time on 5-11-17 and dismissed for lack of evidence. Per correspondence received 5-17-17, Appellant is requesting the PTAB reinstate the appeal stating an extension request was sent on 3-23-17 to the PTAB and that he did not receive notice of a dismissal until 5-12-17. A copy of the extension request letter from counsel (dated 3-23-17) is included with request.

- v. Robert Neumeyer: #15-05208-R-1 (St. Clair)

A possible stipulation was received from the St. Clair County Board of Review on 11-21-16. This information was forwarded to the Appellant on 12-1-16 with an extension until 12-31-16 to respond back if the stipulation is not acceptable. A response was not received and a decision was rendered on 2-24-17 using the amounts contained on the stipulation. Per correspondence received 5-3-17, Appellant is requesting the PTAB reinstate the appeal stating the stipulation was not received.

- w. Jack Kane: #09-27072-C-1 (Cook – Thornton)

Appellant, represented by counsel, originally filed with the PTAB on 9-6-10. A hearing was set for 7-23-14 but a withdrawal request from counsel was received and processed on 9-19-14. Per correspondence received 5-30-17, new counsel is requesting the PTAB reinstate the appeal stating the previous counsel withdrew the appeal without consulting the Appellant first.

- x. Tom Coutretsis: #15-23573-C-1 (Cook – Palatine)

Appellant, represented by counsel, originally filed with the PTAB on 2-16-16. A 60-day extension was granted for the submission of evidence. Evidence was not received and the appeal was dismissed on 10-7-16. Per correspondence received 5-30-17, new counsel is requesting the PTAB reinstate the appeal stating the previous counsel did not complete the steps necessary for a valid appeal for reasons not known to the Appellant.

- y. Sekia Memishovski: #13-24600-C-1 (Cook – Worth)

Appellant, represented by counsel, appealed for the 2013 tax year with the PTAB and received a decision on 1-27-17. Appellant's counsel did not file a "Rollover" appeal for the 2014 tax year and the Appellant does not know if counsel attempted to contact her or not because she was going through a traumatic family experience. Counsel did, however, file with the Cook County Assessor's office. Appellant does want leave to file a 2014 appeal with the PTAB even though the filing period expired on 2-26-17.

z. Access Community Health Network: #10-36036-C-1 (Cook – W. Chicago)

Appellant, represented by counsel, originally filed with the PTAB on 3-20-15. A signed stipulation was received 3-10-16 and a decision reflecting the agreed assessment value was rendered on 9-23-16. Per correspondence received 6-1-17, the Appellant and the BOR filed a Joint Motion to Vacate PTAB Decision. Motion states that in November of 2015, the Appellant was granted a Certificate of Error on the subject property, unbeknownst to counsel. As a result, the 2010 PTAB decision increased the assessed value. The Appellant and the BOR request the PTAB grant its Motion to Vacate Decision.

aa. Abbas Hamdan: #12-25553-R-1 (Lake)

Appellant, represented by counsel, originally filed with the PTAB on 3-4-13. The file was made Ready for Hearing on 9-25-14. A withdrawal request was received and processed on 4-18-17 from the Appellant. Per correspondence received 6-2-17, Appellant is requesting the PTAB reinstate the appeal due to a ministerial error stating the appeal should have been settled with a signed stipulation (attached to request) and not withdrawn.

bb. David Sieven: #15-03766-R-1 (Lake)

Appellant originally filed with the PTAB on 3-29-16. A total of 281 days has been granted for the submission of evidence, the latest being a Final Extension and due on 6-7-17. Per correspondence dated 6-5-17, Appellant is requesting an additional 30-day extension for the completion of an appraisal. Information is included with request indicating the difficulty of obtaining an appraiser for this unique property that is located on an island. A company was contacted in April but needed time to confer with their unique property specialist who was on an assignment in Alaska. A 6-6-17 appointment was arranged for inspection of the property and a 30-day extension is requested to complete the assignment.

cc. Valero Energy Corporation: #15-25780-I-3 (Cook – Worth)

Intervenor, Village of Alsip, originally filed with the PTAB on 1-30-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to file evidence and/or a brief. The subject property is a tank terminal facility consisting of 24 steel tanks having a total storage capacity of approximately 1.5 million barrels. The property has environmental contamination issues.

dd. James Johannesen: #05-26442-R-1 (Cook – Lyons)

Appellant, represented by counsel, originally filed with the PTAB on 5-15-06. A hearing was held on 2-13-08 with a favorable decision being rendered on 4-1-08. Per correspondence received 3-24-17, Appellant, now represented by different counsel, has filed a Motion to Revive Judgment stating the Cook County Treasurer's Office (CCTO) never issued a refund of the resulting property tax overpayment to the Appellant. New counsel states the Appellant's recent application for a refund was rejected by the CCTO on the grounds that the PTAB's decision was issued 7 years ago and has expired. Counsel states the judgment is subject to revival under 735 ILCS 5/2-1602. And requests the PTAB either reissue the decision with a current date, or enter the draft order for Revival of Judgment that has been prepared.
