- a. South Riverside Building, LLC: #15-34779-C-3 (Cook – W. Chicago)

Intervenor, City of Chicago, originally filed with the PTAB on 6-15-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension for the preparation of evidence. An affidavit accompanies the request stating that an MAI has been retained to complete an appraisal but because of other professional obligations, appraiser requests to extend the current deadline.

- b. Marquardt S.D. #15: #15-05661-I-3 (DuPage)

Intervenor/Owner, DCT Mitchell Ct., LLC, originally filed with the PTAB on 5-16-17. A total of 90-days has been granted for the submission of evidence. Intervenor/Owner is requesting an additional 90-day extension to submit valuation argument and documentary evidence. This is an undervaluation complaint in which the taxing district has requested an assessment increase of \$5.4 million dollars.

Intervenor, Waukegan C.U.S.D. #60, originally filed with the PTAB on 5-19-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to compile and submit evidence.

In each of the appeals listed above, Intervenor, Chicago Board of Education, originally filed with the PTAB on 5-12-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to complete review and prepare materials for filing.

- g. Kraft Foods, Inc.: #15-29785-C-3 (Cook – Northfield)

Intervenors, New Trier H.S.D. #203 and Sunset Ridge S.D. #29, originally filed with the PTAB on 6-9-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (9-11-17) indicates a 90-day extension is requested due to the pending transfer of information from client to appraiser.

- h. 650 E. Devon Condominium Assoc.: #15-05453-C-3 (DuPage)

Intervenors, Itasca Community Library, Itasca Fire Dist., Itasca Park Dist., Itasca S.D. #10, and Lake Park H.S.D. #108, originally filed with the PTAB on 5-18-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension while negotiating settlements with the other parties to the appeal. If this matter fails to settle, Intervenors will submit evidence.

- i. North Bridge Chicago LLC: #15-34925-C-3 (Cook – N. Chicago)

Intervenor, City of Chicago, originally filed with the PTAB on 6-1-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension. An affidavit accompanies the request stating that an MAI has been retained to complete an appraisal but because of other professional obligations, appraiser requests to extend the current deadline.

- j. Anthony Remke: #15-04850-R-1 (McHenry)

Appellant, represented by legal counsel, originally filed with the PTAB on 4-5-16 and requested a hearing. All information was timely received and the McHenry County BOR was notified of the appeal on 7-14-16. The required Notes on Appeal along with evidence was received from the BOR with a red check mark on the front page indicating a proposed stipulation for the appeal. This information was forwarded to counsel with a 30-day extension for rebuttal and/or a response if the possible stipulation was not acceptable. A response was not received and a decision was issued using the amounts proposed by the BOR on 2-24-17. Per correspondence received 9-15-17, counsel is requesting the PTAB to reinstate the appeal acknowledging the small reduction offered by the BOR was noticed but it was not understood that a response was required if not acceptable.

k. Chicago Title Land Trust: #13-02893-C-2 (McHenry)

Appellant, represented by legal counsel, originally filed with the PTAB on 3-28-14. All information was timely received and the McHenry County BOR was notified of the appeal on 12-30-14. The required Notes on Appeal along with evidence was received from the BOR with a red check mark on the front page indicating a proposed stipulation for the appeal. This information was forwarded to counsel with a 30-day extension for a response if the stipulation was not acceptable. Counsel did respond by rejecting the stipulation and the file was made Ready for Hearing on 5-28-15. A stipulation signed by both parties was received 5-17-16 and a decision issued using these agreed upon amounts on 6-24-16. Per correspondence received 9-15-17, Appellant's counsel is requesting the PTAB to reinstate this 2013 appeal so that a "Rollover" appeal may be filed with the PTAB for the 2014 and 2015 tax years because they were unaware that a written request had to be made for a "Rollover".

Per a Motion received 9-15-17, Appellant, represented by counsel, is requesting the PTAB to reinstate each appeal stating he was mistakenly advised that the appeals would be taken under advisement and the Board would issue a ruling but instead each appeal was dismissed for failure to appear at hearing.
