In each of the appeals listed above, Appellant originally filed with the PTAB on 3-7-16. A total of 330-days has been granted for the submission of evidence with the latest two extensions being **Final**. Per request received 10-16-17, Appellant is requesting an additional extension to submit evidence because a 2015 exemption application has been filed and is currently pending.

- b. Michael McDonnell: #16-02211-R-1 (Lake)

Appellant, represented by counsel, originally filed with the PTAB on 3-2-17. An initial review deemed the appeal incomplete and a checklist with a 30-day extension dated 8-31-17 was sent to counsel. This extension expired on 9-30-17 with no response. On 10-18-17 counsel indicated he contacted our Executive Director inquiring about the status of the appeal and it was at this point he learned of the 8-31-17 incomplete letter. Per correspondence received 10-20-17, counsel has submitted a Motion for Extension of Time for Good Cause. Motion states he was

Motion further states counsel was under the impression that all correspondence from the PTAB was to be sent via email as of August 2017. Confirmation with our I.T. staff indicates an email with a link was sent on 8-31-17 to counsel but it was not opened/read.

She further states the office is short staffed and, due to budget constraints, has not been able to return to a full work force. An extension is requested until 2-1-18.

In each of the appeals listed above, the Kankakee County Board of Review was notified of filings on 8-3-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional unspecified extension to work with the township assessor and taxing districts to compile evidence.

Intervenor, Village of Maywood, originally filed with the PTAB on 6-29-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional unspecified extension to file evidence due to unforeseen circumstances.

- j. 2401 S. Michigan Bldg. Corp.: #15-37643-C-3 (Cook – S. Chicago)

Intervenor, Chicago Board of Education, originally filed with the PTAB on 7-3-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to complete its review and prepare materials for filing.

- k. Gladstone Group I, Inc.: #11-34741-C-2 (Cook – Elk Grove)

Intervenors C.C.S.D #59 and T.H.S.D. #214, originally filed with the PTAB on 6-29-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to complete their review and prepare materials for filing.

- l. Kingston Hotel Group LLC: #15-06692-C-2 (St. Clair)

Intervenors, O’Fallon C.C.S.D. #90, O’Fallon T.H.S.D. #203, and Southwestern IL College, originally filed with the PTAB on 7-10-17. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to submit evidence.

- m. Michael Hart: #15-05126-F-1 (McHenry)

Appellant, represented by legal counsel, originally filed with the PTAB on 4-7-16 checking “Assessment Equity” as the basis for appeal. An initial review indicated an extension was requested for the completion of evidence and a total of 90-days was granted. Upon receipt of new evidence the appeal was reviewed by a staff ALJ and deemed insufficient due to only 2 comparable properties submitted with no descriptions and no construction costs. The appeal was dismissed for insufficient evidence on 4-3-17. Per correspondence received 10-10-17, Appellant is requesting the PTAB reinstate the appeal stating they are using the same evidence submitted at the local level.

- n. Municipal Trust & Svgs Bank Tr#1616: #16-00173-R-1 (Kankakee)
The Villages of Indian Meadows, Inc.: #16-00174-R-1 (Kankakee)

In each of the appeals listed above, Appellant, represented by legal counsel, originally filed with the PTAB on 12-19-16. An initial review indicated the appeals were missing a Board of Review final decision to determine timeliness. A checklist indicating this along with a 30-day extension was issued with a due date of 9-2-17. A response was received on 8-15-17 with a return of a Kankakee County BOR Proposed Value Change and Hearing Notice (dated 11-17-16) indicating a hearing would take place on 12-19-16 for both appeals in Kankakee, IL. Both appeals were dismissed on 10-5-17 for failure to comply with the checklist. Per correspondence received 10-17-17, Appellant has submitted a Motion to Reinstate Appeals. The Motion states the Appellant waived his/her right to a hearing and thus making the 11-17-16 Hearing Notice the BOR final assessment.

- o. Balitaan Real Estate Holdings, LLC: #2016 Commercial Appeal (Cook – Maine)

Appellant, represented by legal counsel, is asking the PTAB to accept this 2016 new appeal and issue a docket number. Counsel claims a package postmarked 3-3-17 was mailed to the PTAB containing this appeal. The PTAB mail log for 3-3-17 does contain 4 appeals from this legal counsel but Balitaan Real Estate Holdings, LLC is not among these. A physical search of this and other dates did not reveal this appeal either. Counsel has re-submitted the appeal and is requesting it be accepted as timely.

- p. Thomas & Geraldine Strasser: #12-27952-R-1 (Cook – Worth)

Appellant, represented by legal counsel, originally filed with the PTAB on 3-29-13. A decision based on a signed stipulation was issued on 7-21-17 lowering the total assessment from \$25,170 to \$19,070. Per correspondence received 10-11-17, counsel has submitted a Motion to Vacate the Final Administrative Decision and Withdraw Appeal. Unbeknownst to present counsel, another law firm filed a Certificate of Error which was granted by the Assessor rendering an assessment lower than this 2012 PTAB decision.

- q. 7700 Madison, LLC: #07-25645-C-1 (Cook – Proviso)

Appellant, represented by legal counsel, originally filed with the PTAB on 7-7-08. A hearing was scheduled and held on 3-9-10 with a decision being issued on 4-23-10 and a reduction of approximately \$36,095 in assessed value. Per correspondence received 10-6-17, Appellant has submitted a Motion to Revive Final Administrative Order. Motion states that on 5-11-17 Appellant applied for the resulting property tax refund by submitting a refund application with supporting proof of payment to

the Cook County Treasurer but was rejected because the application was submitted more than 7 years after the issuance of the decision. Appellant is requesting the PTAB revive and/or reissue the Order, thereby allowing the Appellant to reapply for the real estate tax refund due from this matter.
