A hearing has been held regarding the 2012 appeal.

Appellant filed the above appeal with the PTAB from a Board of Review notice dated, 3-13-17. The last day to file with the PTAB from this notice was 4-12-17 (Wednesday). Appellant's appeal is stamped postmarked on 4-14-17 (Friday) and received by the PTAB on 4-18-17. The cover letter and the petition are both dated 4-11-17 but the PTAB does not have the original envelope bearing a postmark date. An initial review of the appeal indicated untimely filing and the appeal was dismissed on 11-2-17. Per correspondence received 11-9-17, Appellant is requesting the PTAB reinstate the appeal and believes the initial mailing was postmarked on 4-11-17.

s. Sadiq & Talat Mohyuddin: #16-06571-R-1 (Madison)

Appellant filed the above appeal with the PTAB from a Board of Review notice dated, 3-13-17. The last day to file with the PTAB from this notice was 4-12-17 (Wednesday). Appellant's appeal is postmarked on 4-13-17 (Thursday) and

received by the PTAB on 4-17-17. An initial review of the appeal indicated untimely filing and the appeal was dismissed on 10-26-17. Per correspondence received 11-6-17, Appellant is requesting the PTAB reinstate the appeal and believes the initial mailing to be timely filed. A copy of the envelope is in the file and bears the postmark date of 4-13-17.

- t. Core Assoc.: #14-20396-C-2 (Cook – Worth)

Appellant, represented by legal counsel, originally filed the above appeal with the PTAB on 12-1-14. A stipulation was agreed upon by all parties and a decision went out on 8-18-17. Per correspondence received from counsel on 11-21-17, a Motion to Vacate Decision and Withdraw Appeal is requested. Motion states a sale of the property occurred in 2014, unbeknownst to counsel, and there was an acquisition lowering the assessed values. The 2014 PTAB decision later increased the assessed values.

- u. Infinite Self Storage of Joliet, LLC: #15-00301-C-3 (Will)

Intervenor, Joliet T.H.S.D. #204, originally filed with the PTAB on 4-15-16. A 90-day extension was granted for the submission of evidence that expired on 7-20-16. Evidence was not received and the Intervenor was defaulted on 8-17-16. A Ready for Hearing letter went out the same day. Per correspondence received 11-22-17, Intervenor is requesting the PTAB vacate the default and allow Joliet T.H.S.D. #204 to adopt the evidence submitted by the Will County Board of Review.

- v. Michael Doherty: #11-22257-R-1 (Cook – Maine)

Appellant, represented by counsel, originally filed with the PTAB on 2-24-12. A stipulation was agreed upon by all parties and a PTAB decision went out on 5-19-17. Per correspondence received from counsel on 11-15-17, a Motion to Vacate Decision and Withdraw Appeal is requested. Motion states a Certificate of Error was applied to the above 2011 taxes, which are lower than the PTAB decision.

- w. Frank Mete: #13-29850-C-1 (Cook – Wheeling)

Appellant, represented by counsel, originally filed with the PTAB on 4-9-14. A stipulation was agreed upon by all parties and a PTAB decision went out on 8-18-17. Per correspondence received from counsel on 11-15-17, a Motion to Vacate Final Administrative Decision is requested. Motion states a Certificate of Error was applied to the above 2013 taxes on or about 8-11-15, unbeknownst to legal counsel lowering the total assessed valuation from \$34,024 to \$27,778 compared to PTAB's decision on 8-18-17 of \$28,887.

- x. Sanju Sharma: #15-25304-R-1 (Cook – Lake)

Appellant, represented by counsel, originally filed with the PTAB on 3-4-16. The Hearing Options area on the appeal was originally checked “I would like to present my case in person at a hearing” but was whited out and re-checked to “I would like the PTAB to determine the correct assessment based on the evidence submitted”. A “No Change” decision was issued by the PTAB based on the evidence presented in the file on 11-21-17. Per correspondence emailed from counsel on 11-21-17, a Motion to Vacate & Reinstate has been filed. Counsel states the rebuttal evidence submitted on 11-22-16 reads “We respectfully request that the PTAB set this matter for hearing or enter a decision reducing the assessed value for the subject property to an amount reflective of the subject’s purchase price”. This statement was found in the last sentence of the last paragraph of the letter.

- y. Richard Frothingham: #15-39864-R-1 (Cook – Bloom)

Appellant originally filed with the above 2015 appeal with the PTAB on 11-1-17 from a 2014 favorable decision issued 9-22-17. An initial review of the appeal deemed the filing untimely and was dismissed on 11-15-17. Per correspondence received 11-28-17, Appellant is requesting the PTAB reinstate the appeal based on an error with the U.S. Postal Service. Request states the appeal was submitted with a week to spare but the appeal was returned with a handwritten notification from the Post Office stating the mail wasn’t forwarded because previously used stamps were affixed with glue. Appellant admits the stamps did look different but were unused stamps that had not been cancelled and that the Post Office admitted it was wrong but took no responsibility. Appellant states that the returned envelope should have been included with the new mailing but did not realize this until he spoke with PTAB staff.

- z. Cindi Griffith: #16-06556-R-1 (Madison)

Appellant filed the above appeal with the PTAB from a Board of Review notice dated, 3-13-17. The last day to file with the PTAB from this notice was 4-12-17 (Wednesday). Appellant’s appeal is stamped postmarked on 4-14-17 (Friday) and received by the PTAB on 4-17-17. An initial review of the appeal indicated untimely filing and the appeal was dismissed on 10-26-17. Per correspondence received 11-8-17, Appellant is requesting the PTAB reinstate the appeal and believes the initial mailing was postmarked on 4-12-17. A receipt from a Collinsville, IL Post Office reflects a 4-12-17 (1:45 PM) postage purchase date. Evidence contains an envelope with postage of \$1.61, however, there is no postmark date on the envelope. The appeal form is dated 4-12-17.
