Minutes of the Property Tax Appeal Board Meeting Held on March 14, 2017 Des Plaines, Illinois

1. Roll Call: Chairman Mauro Glorioso; Jim Bilotta; Robert J. Steffen, Dana D. Kinion (via conference call); and Kevin Freeman (via conference call).

Staff: Louis G. Apostol, JD, CAE, Executive Director & General Counsel; Dianne Lerman, Recording Secretary.

Mr. Glorioso convened the Meeting at 10:00 a.m.

Mr. Bilotta moved to allow Mrs. Kinion to participate in the Meeting via conference call. Mr. Steffen seconded the Motion and it carried 3-0.

2. Approval of Board Minutes from February 15, 2017 Meeting.

Mr. Steffen moved to approve the Board Minutes of February 15, 2017 as presented. Mrs. Kinion seconded the Motion and it carried 4-0.

3. Adoption or Amendments to the Agenda

Mr. Steffen moved to approve the Agenda as presented. Mr. Glorioso seconded the Motion and it carried 4-0.

Mr. Bilotta moved to allow Mr. Freeman to participate in the Meeting via conference call. Mr. Steffen seconded the Motion and it carried 4-0.

4. Executive Director's Report

Mr. Apostol reviewed the PTAB's current operations and the FY17 Expense Report. He reported PTAB expended 56.5% of the approved budget through the first (8) months of the fiscal year. He further reported PTAB finished FY17 under budget as part of an expense reduction initiative. He also reported budget negotiations with Labor Relations / AFSCME are still ongoing at this time but hopefully, will result in an agreement soon.

BOARD MEMBERS

He reported PTAB will use (7) 75-day staff to assist in reducing the backlog of cases. Mr. Apostol said Becky Hesse, Shawn Murphy and Shelli Richardson will continue to work as 75-day staff. In addition, (4) 75-Day ALJs will continue to work at both the Des Plaines and Springfield offices. He stated open positions have already been posted and expects to interview prospective candidates from the final list later in March. Mr. Apostol announced that Christa Zupko, from the Department of Healthcare and Family Services, will join the Des Plaines staff on March 16th.

Mr. Apostol reported he will present PTAB's FY18 Budget Request to the Legislature on Wednesday, March 22nd in Springfield. He further reported the FY18 Budget Request provides for full funding of all approved positions and the replacement and upgrade of IT and related equipment.

Mr. Apostol reported on the progress of the Illinois Statewide Audit. He stated the auditors have completed the audit of both offices and a report has been prepared for review and compliance. He again stated PTAB staff continues to give its full cooperation and assistance when submitting documents and other requests.

Mr. Apostol reported on the progress of the PTAB/CMS On-Line Filing project. He reported staff has scanned approximately 9,500 2016 new appeals into the database in preparation for On-Line Filing. He again stated PTAB IT staff are working closely with the CMS IT Department under the DoIT program and is making progress at this time. He also noted that taxpayers and practitioners continue to access the "Appeal Status Inquiry Program" (ASI), saving staff significant time in answering questions on appeal status, appeal forms and decision processes.

Mr. Apostol reported on his participation in the Governor's "Council of Counsels" meetings in Springfield and Chicago on March 2nd. He again stated staff will attend the "Rapid Response Program" when scheduled.

Mr. Apostol reported PTAB continues to be current with all Governor's Office of Citizen Action inquiries and FOIA requests at this time.

Mr. Apostol distributed copies of Pie Charts showing the distribution of appeals before PTAB in 2014 and 2015. He noted 77.5% of all appeals come from Cook County.

Mr. Apostol reminded the Board the next meeting is scheduled for Tuesday April 11th at 10:00 a.m., in Springfield. He noted that (5) of the final (9) PTAB 2017 meetings, will be in Springfield.

As to Attachment E, Mr. Steffen moved to approve the attachment. Mr. Freeman seconded the Motion and it carried 4-0 with Mr. Bilotta recusing.

As to Attachment F, Mr. Freeman moved to approve the attachment. Mr. Glorioso seconded the Motion and it carried 4-0 with Mr. Steffen recusing.

As to Attachment Z, Mr. Bilotta moved to approve the attachment. Mr. Steffen seconded the Motion and it carried 5-0.

Workload Report

Mr. Apostol presented and reviewed the February 2017 Workload Report. He again stated this report reflects open appeals at the beginning of the year, new appeals added during the year, appeals closed during the year and appeals pending at the end of the year. He reported staff produced a total of 21,568 closed decisions in the first eight months of the fiscal year. He again stated PTAB is projected to close a record 32,000 plus appeals by June 30th and staff is working to produce more decisions in FY17 than in multiple previous years. He again credited staff for excellent production numbers and continuing to work toward reducing the backlog of appeals. He further stated, he continues to work with staff to review current systems in an effort to streamline the decision process.

Mr. Apostol again presented graphs prepared by IT that reflect, Weekly ASI Visits, Decisions Viewed Weekly, Weekly PTAB Website Visits, Board Portfolios Viewed Weekly, Letters Viewed Weekly, Board Decisions by Month and Xerox Pages printed Monthly. He again noted taxpayers and practitioners are utilizing the website more to track the progress of appeals and to download information. He again stated this continues to save significant staff time and reduced duplication expenses.

The Board expressed their appreciation to staff for significantly improving production numbers that contribute to reducing the backlog of new cases before PTAB.
