- p. The Villages of Indian Meadows: #16-00174-R-1 (Kankakee)

The Kankakee County Board of Review was notified of the above filing on 12-7-17. A total of 90-days has been granted for the submission of evidence. The BOR is requesting an additional unspecified extension to submit a signed stipulation.

- q. C.C.S.D. #93: #15-05650-I-3 (DuPage)

Intervenor/Owner, Prologis TFL, LLC, originally filed with the PTAB on 3-30-17. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to gather additional data and viewing all available options.

- r. Michael Guerra: #12-24285-R-1 (Cook – Maine)

Appellant, represented by counsel, originally filed with the PTAB on 2-13-13. Evidence was received by all parties and a decision was issued on 6-23-17 based on a stipulation signed by both the appellant and the Cook County Board of Review for an assessed value of \$78,000. Per correspondence received 3-12-18, counsel has submitted an Appellant and Respondent's Joint Motion to Vacate PTAB Decision. Counsel states that, unbeknownst to him and the CCBOR, the appellant filed a Certificate of Error with the Cook County Assessor's Office for the 2012 tax year on 6-5-13. The Certificate of Error was granted reducing the assessed value to \$65,558. The increase from PTAB resulted in an Open Item Real Estate Tax Bill on this parcel.

- s. Claudia Wilson: #15-00317-R-1 (Will)

Appellant, represented by counsel, originally filed with the PTAB on 1-20-16. Sufficient evidence, including an appraisal, was submitted. A hearing was scheduled with the PTAB on 3-5-18 but was postponed per the request of counsel

because attendance of the appraiser at the hearing could not be secured. Appraiser has moved to Florida and is not returning due to family illness. Per correspondence received 3-5-18, counsel has filed a Motion for Leave to File Replacement Appraisal. Motion states that given the unavailability of the appraiser, appellant requires an extension to file an appraisal report to replace the previously filed report and that this would enable a hearing with the PTAB to be conducted in a manner best calculated to conform to substantial justice.

- t. Benjamin Gillespie: #14-25458-R-1 (Cook – N. Trier)

Appellant originally filed with the PTAB on 2-5-15. A hearing was scheduled and held on 7-10-17 with a “No Change” decision mailed on 12-19-17. Per correspondence received 2-20-18, appellant is requesting the PTAB reinstate the appeal and issue a new hearing date so that the appellant’s appraiser can attend. An email is attached to the request dated 6-1-17 from the appraiser stating he will be out of town and unable to attend the previous PTAB hearing.

- u. Northgate Pier Condominium Assoc.: #12-20183-R-3 (Cook – Rogers Park)
Northgate Pier Condominium Assoc.: #13-23996-R-3 (Cook – Rogers Park)

In each of the appeals listed above, appellant, represented by counsel, had a hearing with the PTAB on 11-30-17. A “No Change” decision was issued for both years and mailed on 1-16-18. Per correspondence received 2-15-18, counsel has submitted a Motion for Reconsideration. Motion states the subject property is a 73-unit residential condominium. Appellant argues the PTAB misconstrued evidence and failed to consider relevant evidence to reach a decision.

- v. City of Wheaton: #16-05349-C-3 (DuPage)

Appellant/Taxing Body (City of Wheaton) originally filed with the PTAB on 4-6-17 on this parcel which is a recently constructed luxury apartment complex. This is an undervaluation complaint and the owner has not yet been notified by the Property Tax Appeal Board of the appeal. There is currently a 90-day Final extension granted with a due date of 6-19-18 for the submission of evidence. Per correspondence received 2-23-18, appellant has submitted a Motion for Subpoena *Duces Tecum* to the Taxpayer (Morningside Wheaton, LLC) for the PTAB to consider allowing the appraiser access to a survey, floor plans, historical financial statements, rent roll and lease summaries, recent real estate tax bill, information pertaining to recent offerings, sales, or listings, and any appraisals completed within the last 3 years. Appellant states that all requests to the Taxpayer have been ignored

so it is necessary to procure such documentary evidence through formal discovery. The request for the subpoena is supported by an affidavit from the appellant's appraiser.

- w. Matthew Wakeright: #16-23359-R-1 (Cook – N. Trier)

Appellant, represented by counsel, originally filed with the PTAB on 1-4-17. An initial review indicated several required items missing and a checklist with a 30-day extension was sent on 10-26-17. Counsel timely returned information without the required (2c) Appellant claim for Land, Improvement, and Total. The appeal was dismissed on 2-15-18 for failure to provide required evidence (2c). Per correspondence received 3-13-18, Counsel is requesting the PTAB reinstate the appeal and submitted a completed form with the information required and asks that the client not be penalized for his scrivener error. The appellant's submission in response to the checklist did include a narrative in which the appellant's counsel made a request for a total assessment but did not carry forward the request to the appeal form.

- x. J.C. Penney Company, Inc.: #15-33549-C-3 (Cook – Schaumburg)

(1.) Appellant, represented by counsel, originally filed with the PTAB on 4-21-16. The board of review was notified of the appeal and sent a Certificate to all taxing districts on 4-26-17 with a due date for intervening with the PTAB on 6-24-17. There are currently no intervenors. A hearing date was set for this tax assessment year along with companion files 2013 and 2014 but was later postponed. On 2-21-18 Schaumburg C.C.S.D. #54 filed with the PTAB a Motion for Leave to Intervene Instantly. The Motion states the school district has intervened and submitted evidence in support of its intervention for the 2013 and 2014 appeals (same parcel) but did not receive notice of the 2015 appeal until 2-21-18. An affidavit from the Assistant Superintendent for Business Services for Schaumburg C.C.S.D. #54, states he does not have a record of receiving notice from the Cook County Board of Review of the 2015 assessment of subject property. Motion further states that if allowed to intervene, the same appraisal evidence filed in the 2013 and 2014 appeals would be used. On 3-8-18, a response objecting to the Motion for Leave to Intervene Instantly was received from the appellant's counsel. Response states that the BOR complied with PTAB's rules and timely mailed the required notification to the correct address corroborated by the school district's affidavit of Ric King. The response includes a copy of the board of review notification marked as Exhibit B, which is dated 4-26-17 and includes the name and address of the school district in the lower left-hand corner. The response also includes a copy

of the Certificate from the Cook County Board of Review to the PTAB marked as Exhibit C asserting that all taxing districts were notified of the appeal on 4-26-17. Response further states the Motion to Intervene should be denied due to the assertion that Ric King has no record of receiving the Certificate some 10 months earlier and that this is inadequate and insufficient as a matter of law and fact to support the school district's Motion to request Intervene Instantly.

- (2) The appellant filed a Motion to Hold a Separate Hearing for Assessment Year 2015. The subject property is the subject matter of an appeal for the 2013, 2014 and 2015 tax years. The appellant has agreed to a consolidated hearing for the 2013 and 2014 tax years but has requested a separate hearing for the 2015 tax year. The appellant explained that for 2015 the property differs in that a separate detached tire, battery and auto (TBA) store located on the northeast corner on the property had been sold to Firestone and two new PINs were created, one of which is not under appeal in 2015. The appellant submitted a new appraisal for 2015 although prepared by the same company as the 2013-2014 appraisal. The appellant also asserts that the parties differ from 2013-2014 and the 2015 appeals. For the 2013-2014 appeals Palatine High School Dist. No. 211 and Schaumburg CCSD No. 54 intervened and submitted an appraisal prepared by Associated Property Counselors, Ltd. Neither school district intervened for assessment year 2015 and the only evidence includes the appellant's appraisal and the Board of Review Notes on Appeal. The appellant contends consolidation of the appeals for hearing would unfairly prejudice the taxpayer because the school districts would be given an unfair opportunity to participate in the 2015 appeal and any consideration of the PTAB's ALJ of the 2013 appraisal submitted by the school districts for the 2015 appeal would be improper. The appellant requests the PTAB hold a hearing for assessment year 2015 separate and apart from the hearing for the assessment years 2013 and 2014.

Section 1910.78 of the PTAB's rules provides:

Two or more appeals involving the same property may be consolidated on motion of any party or at the direction of the Property Tax Appeal Board when the cases involve common issues of law or fact, consolidation would not prejudice the rights of the parties, and consolidation would result in the efficient and expeditious resolution of the appeals.

- y. Marek & Anastazia Brozyna: #12-25903 (Cook – Maine Twp.)

The appellants, through counsel, filed a Motion to Vacate the Final Administrative Decision of the PTAB and Withdraw this Docket. The PTAB issued a decision on January 16, 2018, based on a stipulation of the parties. Subsequent to the decision the Cook County Treasurer's Office sent the appellants a letter stating that it had received a copy of the PTAB's decision, which resulted in the increase in the assessment of one of the two PINs under appeal and an open tax bill will be processed unless the appellants believed this was in error, then they were instructed to contact the PTAB and inform the Treasurer's Office not to process the increase. The appellants assert that the 2012 proposed assessment is the same as the 2012 settlement and that the appellants should have withdrawn the appeal. They also assert that the 2012 assessments inputted on the Addendum of the proposed stipulation were incorrect and not prorated equally. The appellants contend the open item bill will cause undue hardship and requested the PTAB vacate the decision and withdraw this docket.

z. 2017 Cook County Notices

The Cook County Board of Review (BOR) is requesting that the 2017 Cook County notice of appeals be postponed until its offices have concluded the 2017 regular BOR session. The BOR asserts that its systems need to be updated which cannot occur until the entire County's 2017 session has been reviewed and transmitted to the County Assessor to prepare the new year. The BOR indicates its office relies upon mainframe data to feed its comparable system and other related fields. The PTAB has accommodated the BOR in the past.
