In early 2017, prior to the filing of the 2016 appeal, the PTAB granted the parties' joint motion to stay the 2013-2015 appeals pending the outcome of the 2012 appeals. Accordingly, the 2016 appeal (and the 2017 appeal) is not technically stayed, although all parties

agree that it should not be adjudicated until the 2012 appeals have been decided by the PTAB, like the other stayed appeals.

eee. US Steel Corporation #16-28275-C-3 (Cook)

Motion to Stay

Intervenor, City of Chicago, by its counsel Edward N. Siskel, Corporation Counsel, moves the PTAB pursuant to 86 Ill. Adm. Code 1910.90(f) to stay this matter in the interest of judicial economy and suspend the pending evidence deadline. In support of this request, the City states as follow:

1. The Appellant filed an appeal of its 2016 assessment contesting the denial of its request for open space assessment for the subject parcels. Upon receiving notice, the City filed a request to intervene and a request for extension of time to file evidence with the PTAB. The PTAB granted both requests on April 19, 2018, giving the City until July 18, 2018 to file its evidence.
2. The subject parcels are close in proximity to several separate parcels that were the subject of a similar appeal by the Appellant under docket numbers 00-24208, 01-24775, and 02-27076. The City of Chicago intervened in those cases, and there was a contested evidentiary hearing conducted by the PTAB, which ultimately issued a decision in 2005 reversing the Board of Review's denial of open space status for the parcels.
3. In consideration of the prior litigation involving the neighboring parcels, and the costs and risks of litigation, the City, in coordination with the Board of Review, negotiated with Appellant's legal counsel to settle this matter. Pursuant to the terms of the agreement, Appellant would dismiss this 2016 appeal, subject to Cook County officials approving the open space assessment for 2017, 2018, 2019, and 2020, so long as the parcels otherwise met the requirements of the Open Space Statute.
4. In furtherance of the terms of the settlement agreement, the Board of Review, approved Appellant's open space assessment for 2017 in May of 2018. However, the Cook County Assessor failed to re-instate the open space assessment for 2018, and Appellant is pursuing an appeal with the Board of Review. It is expected and anticipated that the Board of Review will approve the open space assessment for 2018 in the due course of time.
5. The fulfillment of the terms of the agreement in relation to 2018-2020, will likely take another 2 years. Both the City and the Board of Review have demonstrated their commitment to faithfully fulfill the terms of the agreement by implementing an open space assessment for 2017.

6. For the City to obtain the benefit of its bargain, both the anticipated dismissal of this case and the avoidance of the expenses associated with developing and submitting evidence to defend the case, it is necessary for the PTAB to stay this case and suspend the pending evidence for the City.

Intervenor City of Chicago respectfully requests that the PTAB issue a written ruling granting the City's motion to stay proceedings and suspend the pending evidence deadline until July 2020.

Motion to Vacate

Cook County Board of Review by the State's Attorney of Cook County, Kimberly M. Foxx, moves to vacate the decision of the PTAB in this appeal issued on May 20, 2016, reducing the assessment from \$285,324 to \$95,000.

The parties executed stipulations dated December 1, 2015, regarding the subject for the tax years 2010 through 2014, tax year of 2012 included. The parties stipulated to an assessment of \$181,250. On November 20, 2016 and January 18, 2017, the PTAB issued decisions for the 2010 and 2011 tax years reducing the assessments based on the stipulations. The Board of Review alleges that through negligence or intentional deceit, Appellant failed to tender those stipulations to PTAB for consideration and approval.

More than one year ago, PTAB rendered a decision for the instant 2012 case based on the written evidence submitted as neither party had requested a hearing.

The Board of Review did not discover Appellant's failure to provide the PTAB with the five years of stipulations until April 2018, when Appellant attempted to negotiate "rollover" stipulations for 2013 and 2014 based off the 2012 PTAB decision.

Counsel argued the Appellant's alarming dereliction wasted significant resources of PTAB, the State's Attorney's Office, the Board of Review, and has inexplicably led to the failure of Appellant to obtain its refund checks from the Treasurer as much as 29 months ago.

Cook County Board of Review asserts PTAB should vacate its decision for the instant 2012 case and enter the original stipulation negotiated and entered into by parties in this case in December 2015.

The appellant's counsel was served a copy of the motion and did not provide a response to the PTAB.

- ggg. The Cook County Board of Review requested that the PTAB accept the 77 dockets listed on an attached exhibit due to technical issues in the Assessor's office. The filing deadline for each appeal had expired. Their office electronically transferred the 2016 appeals on Friday, July 27, 2018 and placed the older appeals in the U.S. mail. The Assessor's office stated it created the evidence prior to the deadline but the electronic files were not imported because the format of the filenames were incorrect. Their system relies on their dockets to have a 4-digit year and 5-digit docket (e.g. 2016-20000). The electronic files were saved to their shared location with a 7-digit format (e.g. 1620000) and their system did not recognize the format and ignored the files.

They are working to enhance the process to reduce or eliminate this issue from happening in the future.
