Palatine C.C.S.D. #15 and Palatine Twp. H.S.D. #211 requested to Intervene on August 23, 2018 and was granted a 90-day extension to submit evidence with a due date of November 21, 2018. On November 19, 2018, the Intervenor requested an additional 60-day extension to complete their review of the Appellant's evidence.

- ff. Target Corporation: #16-35686-C-3 (Cook - South Chicago)

Chicago Board of Education requested to Intervene on July 26, 2018 and was granted a 90-day extension to submit evidence with a due date of October 24, 2018. On November 20, 2018, (27 days late) the Intervenor requested an additional 60-

day extension to review this matter and provide additional evidence. The appeal contains a stipulation signed by the appellant and the board of review.

gg. Aris Halikias: #15-22314-R-1 (Cook - Palos)

Appellant's Corrected Motion to Vacate Decision and Appellant's Request for Withdrawal.

Appellant, through his attorney Brian P. Liston, requests the PTAB vacate its decision and dismiss the appeal for docket number 15-22314. The PTAB issued a decision on September 18, 2018, that reduced the subject property's assessment from \$76,958 to \$76,330. After the decision was issued, the Cook County Treasurer notified the Appellant that a Certificate of Error had previously been issued for the 2015 tax year revising the subject's assessment to \$65,900. Therefore, PTAB's decision reflects an increase in the subject's assessment. Appellant was unaware that the Certificates of Error had been granted until contacted by the Cook County Treasurer. As a result, appellant requests the PTAB vacate its 2015 decisions and dismiss the appeal.

hh. Atlantis Trust: #17-03652-R-1 (Lake)

Appellant Motion for PTAB to perform an interior inspection.

Appellant requests the PTAB go through his house for an interior inspection. The appellant stated that he will allow the Lake County Board of Review to go through the property for an interior inspection, however, if the board of review attempts to bring a Sheriff Deputy in the house he will not allow the inspection. The appellant asserts he has been threatened, harassed and intimidated by the Lake County Board of Review in the past year.

ii. Adams Travel: #14-35214-C-1 (Cook - North Chicago)

Motion to Rescind 2014 Decision

Appellant's counsel received notice of an increase in the subject's assessment from the Cook County Treasurer regarding a 2014 PTAB Decision. The PTAB's decision was to reduce the subject's assessment to \$777,500 based on a stipulation. However, at the time of filing the appeal, counsel was unaware that the Board of Review had already granted a 2014 reduction resulting in an assessed value of

\$658,484. The 2014 appeal before the Board of Review was filed by a different law firm. The 2014 decision by the PTAB resulted in an increase.

- jj. Bank of America: #14-23297.001 through .015-C-1 (Cook - Lake)

Motion to Vacate the Final Administrative Decision

On November 15, 2018, the law firm Klafter and Burke received notice from the Cook County Treasurer that the decision of the PTAB resulted in an increase in the assessed value for the subject property. The appellant contends the 2014 stipulation was incorrect in that it resulted in an increase in the assessment of the subject property. The stipulated amount was \$3 more than the Board of Review final assessment of the subject property.

- kk. Dominique Slawski: #17-40867-R-1 (Cook - Palos)

Reinstatement Request

By letter dated April 5, 2018 but postmarked on April 24, 2018, the appellant submitted a written narrative requesting the PTAB review the 2017 assessment of the property. The PTAB mailed pending letters to the appellant on April 30, 2018, with a due date of May 30, 2018, requesting forms be completed. On May 19, 2018, the appellant returned the appeal forms and assessment notice. The assessment notice was dated December 2, 2017, providing until January 2, 2018 to file the appeal from the decision, since January 1st was a holiday. Alternatively, the transmittal date for Palos Township was January 30, 2018, which would provide until March 1, 2018 to file the appeal. On November 29, 2018, the appeal was dismissed for being untimely filed. On December 7, 2018, the appellant requested reinstatement of the appeal.
