- The PTAB's October 10, 2016 denial of the School District's Motion to Dismiss and November 4, 2016 denial of the School District's Motion to Reconsider based on the Appellant's failure to pay taxes prior to appeal. *Madison Two Associates v. Pappas*, 227 Ill. 2d 474,501 n.2 (2008);
- Contrary to PTAB Rule 1910.30(h), the PTAB based its decision on a subject property sale when the Appellant's petition failed to state that the sale was the basis for the appeal;
- Contrary to PTAB Rule 1910.67(l); the PTAB permitted testimony of an appraisal into evidence into when the appraisal was not filed with the PTAB;
- The PTAB's incorrect valuation of a power plant using a discounted cash flow analysis that was based on prior operations rather than expected earnings.

Ms. Clover-Hill will discuss the Subject Property and the PTAB's ruling on the referenced appeal, including the impact to the School District and its buildings, employees and students if the PTAB's decision is not stayed and/or overturned.

Appellant's counsel, Patrick Doody, has filed a written response asking to be allowed time to address the Board arguing in part that: (1) the PTAB has no authority to reconsider its Final administrative decision, and (2) Shelley Clover-Hill's testimony regarding the impact of the PTAB's decision on the school district is well outside of the PTAB's jurisdiction and irrelevant to the valuation of the property.
