Motion to Reconsider Dismissal

Appellant filed a direct appeal from a decision of the Property Tax Appeal Board reducing the assessment on January 28, 2019. On February 21, 2019, the appeal was returned as incomplete. The appellant failed to complete the addendum to the appeal identifying both parcels that make up the subject property and the assessment amounts requested for each parcel. On February 28, 2019, the PTAB received the addendum to petition in response to the incomplete checklist. However, upon further review of the appeal it was discovered that the original filing was 32 days late. The prior PTAB 2015 decision was issued on November 20, 2018 based on an agreement of the parties to settle the appeal. The direct appeal should have been filed no later than December 20, 2018 in order to confer jurisdiction to the PTAB. The appeal was postmarked on January 21, 2019, 32 days late. Since the appeal was not timely filed, by letter dated March 28, 2019, the appeal was dismissed. By letter dated April 15, 2019, appellant's counsel asserted the appeal was timely filed from the incomplete/returned appeal and

requested a status update of the appeal. The Board discussed the request for status during the May 14, 2019 meeting. The Board voted 4-0 to reaffirm Dismissal of the appeal for being untimely filed. By letter dated May 14, 2019, appellant's counsel was served notice of the Dismissal and that the appeal remains closed. On August 5, 2019, the PTAB received correspondence from the attorney asserting he had a medical condition which caused him to be absent from the law firm office in early December 2018. In early December 2018, counsel had a fall which rendered him paralyzed from the neck down for 30-minutes. He was subsequently diagnosed with severe spinal stenosis. The appeal was filed on January 21, 2019, upon his return to the law firm office. Appellant's attorney respectfully requested the PTAB to reconsider the Order of Dismissal. Counsel asserted the appeal would have been filed in a timely manner if not for his medical condition.

Contradictory Treatment

For the subject appeal listed below appellant argued PTAB's issued "no change" decision, which was inconsistent and conflicts with PTAB's decision for an identical and adjacent property located at 10421 Dearlove Rd, Glenview, IL (16-38760). The appeal asserted the same evidence submitted for each appeal.

Under Docket 16-38760, the property was assessed at \$68,997. The PTAB issued a decision reding the assessment to \$50,000. The appellant argues the exact same evidence that was submitted for the other two subject properties under Docket 16-41021 and 16-41019 in which the PTAB issued "no change" decisions, confirming the board of review assessments of \$69,321 and \$56,750, respectively.

The appellant asserted these properties are all identical, adjacent to each other and located in a complex of nineteen separate, six-flat apartment buildings. Appellant

owns and operates eight of the nineteen properties in this apartment complex. Of the eight properties, five were reduced by the Cook County Board of Review to an assessment of \$50,000. The appellant appealed the remaining three properties to the PTAB, again, resulting in a “no-change” decision for two properties and an assessment reduction for one property. The appellant feels this is the inconsistent treatment by PTAB that needs to be corrected. Finally, the appellant argued it would be a significant hardship to embark on the time, effort, and legal expense of suing in the circuit court. The appellant appeals to PTAB to review and resolve this inequity by reducing the two remaining properties to a fair assessment of \$50,000.

bb. JEHLTD Partnership: #18-01690-C-3 (Lake)

Appellant filed with the PTAB on February 1, 2019 and requested an extension of time to submit evidence. On April 25, 2019, the appeal was returned as incomplete because the appellant failed to provide an assessment request for each parcel. The appellant was granted a 30-day extension for compliance with a due on May 25, 2019. The e-mail to counsel at the email address of cookproptax@gmail.com was not opened. On June 13, 2019, attorney Mary Phelan sent an e-mail to PTA.Clerk from email address mphelan@siegeltax.com regarding an outdated e-mail address and incorrect law firm name. The June 13, 2019 email contained a “chain” of emails: On June 13, 2019 at 8:23 A.M, the PTA.Clerk emailed attachments and correspondence regarding various appeals before the PTAB to counsel’s email address on file with the PTAB at cookproptax@gmail.com. On June 13, 2019, at 11:55 A.M. attorney Phelan forwarded herself the email from the PTA.Clerk that was sent to the cookproptax@gmail.com to the new email address of mphelan@siegeltax.com.

On August 22, 2019, the appeal was dismissed for failure to respond to the returned incomplete appeal ordering the requested assessment amounts. The dismissal was emailed mphelan@siegeltax.com. On August 23, 2019, the Board received correspondence from appellant’s attorney arguing the contact information was updated and noted in the submitted documentation but was not updated in the PTAB system. Thus, the attorney never received notice and did not have notice that an extension was pending. The attorney had in her possession the appraisal of the subject property in May of 2019 and would have timely submitted the evidence had she received notice. Therefore, counsel is requesting that the PTAB reinstate Docket 18-01690, accept the submitted materials and review such material as if timely submitted.

Section 1910.30(i) of the Board's rules provides in pertinent part:

A contesting party or attorney may provide an e-mail address for receipt of service of proceedings. The Property Tax Appeal Board must be notified in writing or electronically by any party of a change of mailing address or e-mail address within 30 days after the change. (86 Ill.Admin.Code §1910.30(i)).

cc. Cook County Board of Review Motion to Vacate Default

The board of review claims it timely submitted;

- Substantive, documentary evidence in support of its position in the instant case'
- The Notes on Appeal with an indication that the Board would stipulate
- A fully executed stipulation

PTAB issued notice to the BOR stating that PTAB had not received any evidence and therefore found the BOR in default. The BOR claims its system stamps the electronic file for each docket with a date. A timer runs nightly at 8:00 pm that exports the corresponding evidence to a folder. A text file is created with the name. The docket, primary pin, hearing requested and the Notes sent date is stamped in a text file. The BOR requests that PTAB:

1. Vacate its finding of default;
2. Make the BOR's submission a part of the instant record;
3. Amend its docket to indicate the BOR timely submitted evidence; and
4. Set this matter for hearing on the merits;
5. In the alternative, the BOR would ask for a hearing on the instant Motion to Vacate Default.

There are 1,596 cases on this request to vacate defaults. Two appeals were not in default status (2017-27106 and 2017-27110) and the evidence was received. Five of the appeals were pre-2016 cases that are not covered by electronic transfer. In most of those five cases, the evidence was one day late and the decisions have already been written. After removing the seven aforementioned appeals, there are 1,589 cases requested to vacate default. In the County's discussion, they explain that a timer runs at 8:00 PM nightly and a PDF file is created for the evidence and a text file is created with the docket, PIN, hearing requested and the Notes sent date. The County did not mention that the filename of the PDF file is also included in that text file and it is a very important piece of data. The PDF files are sent to the PTAB with the County's system generated ID numbers. For example, the Notes PDF file for docket number 2018-26041 was sent to us with the filename 22653695.pdf. We have to use the text file that is sent with the PDFs to cross-

reference the files with the corresponding docket numbers. NONE of the docket numbers on this request were listed in any text file that has been sent to us. In doing an in-depth, full-text search on the PDFs for several of the docket numbers listed on this report, it appears that the PDF files were sent for those several sampled, but there was no corresponding entry in the data file for the PDF files, so there was no way for the PTAB to know the evidence was sent.

- dd. Cook County BOR – Additional Extension Request. The Cook County Board of Review is respectfully requesting that the Property Tax Appeal Board allow an additional 90-day extension to file evidence on the following cases that have October deadlines as follows:
