The McHenry County Board of Review was notified of the appeal on May 2, 2019 and was granted a 90-day extension to submit evidence with a due date of July 31, 2019. On July 30, 2019, McHenry County requested the PTAB grant an additional 60-day extension to discuss an agreement with the appellant/attorney.

- b. Mt. Morris Business Park LLC: #17-04358-I-3 (Ogle)

The Ogle County Board of Review was notified of the appeal on August 16, 2018 and was granted a 90-day extension to submit evidence with a due date of November 14, 2018. On August 8, 2019 (267 days late), Ogle County requested the PTAB grant an additional 90-day extension to submit evidence. Ogle County BOR has requested the assistance of counsel in this appeal. c. Edward Sims Jr. Trust: #18-03751-F-1 (Henry)

The Henry County Board of Review was notified of the appeal on July 3, 2019 and was granted a 90-day extension to submit evidence with a due date of October 1, 2019. On August 30, 2019, Henry County requested the PTAB grant an additional 90-day extension to prepare evidence and secure an appraisal.

The Kankakee County Board of Review was notified of the appeal on February 21, 2019 and was granted a 90-day extension to submit evidence with a due date of May 22, 2019. Appellant filed with the PTAB on January 25, 2019. On April 18, 2019, the appeal was returned as incomplete with a checklist to fill out Section: 2c, 2d, III, V, a note to submit evidence and granted a 30-day extension due on May 18, 2019. On July 11, 2019, the appeal was dismissed for failure to submit evidence and complete the appeal form, the case was closed. On August 2, 2019, Appellant asserted that it is mathematically impossible that she did not meet the burden of going forward and would like to appeal the decision to deny the claim.

Motion to Stay the Submission of Evidence

Shawnee C.U.S.D. #84 requested to Intervene on May 23, 2019 and was granted a 90-day extension to submit evidence with a due date of August 21, 2019. On August 8, 2019, the Intervenor by and through its attorneys filed a Motion to Stay the Submission of Evidence until 90 days after the Appellate Court issues its Mandate concerning the 2014 (#14-03445) and 2015 (#15-00452) appeals (No. 5-19-0266), which are petitions for administrative review of the PTAB's decisions reducing the assessment of the subject property. The evidence submitted by the Intervenor in this appeal will largely depend on the Appellate Court ruling. On August 21, 2019, the intervenor filed a request for an extension of time of 90 days after the appellant court ruling in the administrative review of the 2014 and 2015 appeals involving the subject property.

The appellant filed a reply objecting to the Motion to Stay on August 14, 2019. The appellant asserts that the valuation date of 1/1/17 falls within a quadrennial assessment cycle that runs from 1/1/17 through 12/31/20. Therefore, the 2014 and 2015 appeals are unrelated to the valuation of the subject property as of 1/1/17. The appellant further noted it filed the appeal on 5/18/18 and evidence on 3/14/19. The intervenor has already had a 90-day extension and allowing the intervenor an additional year to craft its appraisal to standards that were not in existence when the appellant submitted its evidence would be highly prejudicial to the appellant and raise questions about the fairness of the proceedings. The appellant further noted that section 1910.60(f) of the rules of the Property Tax Appeal Board allows for an extension or longer for good cause shown, however, there is no provision for allowing an extension of unlimited duration.

ii. Robert Ranquist: #03-25518-C-3 (Cook - Thornton)

Motion to Revive Judgement

Taxpayer's attorney request the decision be revived because the Cook County Treasurer's Office failed to issue a refund in this matter. In the above referenced appeal the PTAB issued a decision reducing the assessment. As of this date the taxpayer has not received the refund based on the PTAB decision. The taxpayer request the PTAB issue an order reviving the judgement in this appeal so that the Cook County Treasurer's Office will issue a refund of the resulting overpayment.

- jj. The CCBOR hereby formally requests that the issue regarding the CCBOR's recommendation to amend the PTAB hearing notice be included as an "Agenda" item for the Oct. 8, 2019 PTAB Board meeting. Specifically, the CCBOR's recommendation is that the following language be deleted from the subject "Notice": "Taxpayer is encouraged to contact the Board of Review to determine if a settlement can be reached."

CCBOR's Rationale

Specifically, CCBOR cannot (1) establish authority of parties to settle over the phone; (2) address settlement inquiries without having time to review the case and schedule an appointment with the TPs to meet in person for discussion. The current language does not apprise TPs of those issues and leads to TPs confusion and frustration.

- ll. Lake County BOR – Additional Extension Request.
