The petition concerns an appeal of a property located at 11201 South Ellis, Chicago, IL, with PIN 25-22-231-004-0000. The appellant was granted until October 12, 2019, to respond to the incomplete checklist. The appellant did not file a timely response. On December 5, 2019, the appeal was dismissed for failure to submit the correct evidence. On December 27, 2019, the appellant requested the PTAB reinstate the appeal and submitted a summary appraisal report of the property at 11201 S. Ellis Avenue. The appraisal has a letter of transmittal dated November 21, 2018 with an estimate of market value of \$2,100,000 as of January 1, 2018. The property has a total assessment of \$1,067,570, which reflects a market value of approximately \$4,270,000.
