The Tazewell County Board of Review (BOR) was notified of the appeals on March 19, 2020 and was granted a 90-day extension to submit evidence with a due date of June 17, 2020. On May 4, 2020, Tazewell County requested the PTAB grant an additional 60-day extension to submit evidence.

- b. Tammy Gustafson: #18-34202-R-1 (Cook - Jefferson)

Motion to File Evidence Instanter

Appellant timely filed with the PTAB on April 30, 2019. On October 3, 2019, the appeal was returned as incomplete for the appellant to provide the assessment request, basis of the appeal and evidence. The appellant was granted a 30-day extension with a due date of November 2, 2019 to return the completed appeal. The notice stated in part if all information required to fully complete the filing of Petitioner's appeal was not received by November 2, 2019, the appeal may be dismissed. On February 26, 2020 (116 days late), Petitioner by and through her counsel, submitted a Motion to File Evidence Instanter, which included an appraisal. Petitioner obtained an appraisal from a licensed real estate appraiser regarding the value of the subject property for tax year 2018. Petitioner's counsel acknowledged that she received the docket notice and notice of incomplete submission of evidence from PTAB on October 3, 2019. Due to a docketing error by Petitioner's Counsel on this appeal and two other appeals filed on behalf of the same client the appraisal was not timely submitted to PTAB for review. Petitioner's counsel asserted there is no prejudice to any party if Petitioner could submit her evidence instanter to complete her appeal for the tax year 2018, there are no intervenors at this time nor has the appeal been dismissed at the time the evidence was filed. On May 7, 2020 the appeal was dismissed due to the appellant

failing to satisfy the burden of going forward with evidence to challenge the correctness of the assessment.

c. John Gustafson: #18-36293-R-1 (Cook - Jefferson)

Appellant filed with the PTAB on April 30, 2019 and requested a 30-day extension to submit evidence. On October 10, 2019, the appellant was granted a final 90-day extension with a due date of January 8, 2020. The notice stated if all information required to fully complete the filing of Petitioner's appeal was not received by January 8, 2020, the appeal may be dismissed. On February 26, 2020 (49 days late), Petitioner, by and through his counsel submitted, a Motion to File Evidence Instantly, which included an appraisal. Petitioner's counsel acknowledged she received a notice of final extension dated October 10, 2019. Petitioner obtained an appraisal from a licensed real estate appraiser regarding the value of the subject property for tax year 2018. Due to a docketing error by Petitioner's Counsel, on this appeal and two other appeals filed on behalf of the same client, the appraisal was not timely submitted to PTAB for review. Petitioner's counsel asserted there is no prejudice to any party if Petitioner could submit the evidence instantly to complete the appeal for the tax year 2018, there are no intervenors at this time nor has it yet been dismissed. On May 7, 2020 the appeal was dismissed due to the appellant failing to satisfy the burden of going forward with evidence to challenge the correctness of the assessment.

d. Nordstrom Store #225: #16-37932-C-3 (Cook - Schaumburg)

Second Rebuttal Extension Request

On February 7, 2020, appellant requested a 30-day extension to submit rebuttal evidence due to the appraiser's prior commitments and workload as well as the length and complexity of the appraisal under review. Counsel explained the appraiser, Michael Kelly of Real Estate Analysis Corporation (REAC), was unable to complete his review and written critique of said appraisal by the deadline date. Appellant's attorney submitted a letter from appraiser Michael Kelly requesting an additional 45-day extension to complete the assignment. On February 14, 2020, the PTAB granted a rebuttal extension request with a due date of March 15, 2020 (Sunday). On March 16, 2020, appellant requested an additional 30-day extension to submit rebuttal evidence due to the significant and unprecedented disruptions created by the COVID-19 Coronavirus. An email dated March 15, 2020, indicated that an employee who works at office building located at 205 Tower, which includes Real Estate Analysis Corporation as a tenant, had tested positive for COVID-19. This has created additional lead time to complete assignments as organizations work through the process of setting up and supporting work from

home and virtual options. An e-mail chain, including the notice to tenants, was included with the request.

Please note that on March 31, 2020, the PTAB received the appellant's rebuttal evidence, which was a review appraisal prepared by REAC.

- e. 1851 Whipple Condo Assn.: #18-43015-R-2 (Cook - West Chicago)

Motion to Reinstate

Appellant filed with the PTAB on June 3, 2019. On December 12, 2019, the appeal was returned as incomplete to fill out the Addendum to Petition as this is a multi-parcel appeal. The appellant was granted a 30-day extension to complete the petition with a due date of January 11, 2020. On January 9, 2020, the PTAB received a second copy of the supporting brief and documentation and a request to consolidate all three (3) parcels into a single complaint number. The appellant did not submit an addendum providing the land, improvement and total assessment for each PIN as determined by the BOR or the land, improvement and total assessment requested by the appellant. The appellant's brief did have the "Requested AV" but this was not on the PTAB's Addendum to Petition form (PTAB 15F). The appeal was dismissed on February 27, 2020, stating the basis for dismissal was the appellant's failure to satisfy the burden of going forward with sufficient evidence to challenge the correctness of the assessment. On March 4, 2020, appellant, by and through its attorneys, requested the PTAB reinstate Docket #18-43015. Counsel asserts the appellant timely submitted its petition to challenge the correctness of the assessment of the subject property pursuant to the Rules of Practice and Procedure before the PTAB.

#### Request to Reinstate

In each appeal the appellants filed with the PTAB in an envelope postmarked Friday, January 10, 2020. The deadline to file the appeals from the date of BOR transmittal to the County Assessor was 30-days from December 10, 2019, which was Thursday, January 9, 2020. On March 12, 2020, the appeals were dismissed due to being untimely filed resulting in a lack of jurisdiction. By letter dated March 26, 2020 and received on April 2, 2020, appellants' attorney asserted that due to a calendar error their office was a day late in mailing out PTAB applications for 2019. Counsel contends that though there is no excuse for this mistake he asks that the PTAB grant reinstatement of these cases, as there was no fault of their clients and they will be the ones affected by not getting the opportunity to present their cases at PTAB. Counsel asks PTAB to reconsider due to the tens of thousands of appeals they present each year and the low number of requests they present to PTAB.
