On April 3, 2020, the Ogle County Board of Review through its attorneys, filed a request for leave to file a corrected appraisal report as evidence in this appeal. The Ogle County Board of Review's evidence was filed on October 22, 2019, which included an appraisal by a licensed real estate appraiser. After the filing of the board of review's evidence, the board of review's appraiser noticed that the 2019 tax information had not been removed from his appraisal report and that the appraisal report did not include the multiplier in the tax section. An updated and corrected report was attached as "Amended Exhibit C". The board of review asserts this request is in good faith and is not made for any improper purpose, no party will suffer undue prejudice by the granting of this motion. The motion was served on both the appellant and the intervenor. The Ogle County Board of Review prays that this motion be granted, and the appraisal report be allowed to be filed to replace "Exhibit C" to the board of review's October 22, 2019, filing.

- b. Frank Sciackitano: #18-01800-C-3 (Lake)

#### Reinstatement Request

Appellant filed with the PTAB on February 5, 2019. On May 2, 2019, the appeal was returned as incomplete to fill out the appellant's assessment request and basis of the appeal. The appellant was granted a 30-day extension with a due date of June 1, 2019, to return the completed appeal. On August 22, 2019, the appeal was dismissed for failure to provide documentary evidence. By letter dated April 29, 2020, along with the evidence, appellant's attorney indicated upon review of open PTAB matters that the case had been dismissed. Appellant's attorney asserts the evidence was timely filed on **May 31, 2019** and included the Neopost tracking number: 9171 9690 0935 0219 6153 13. The enclosed Neopost printout indicated that the evidence was received by the PTAB on June 3, 2019, at approximately 9:52 am and lists the status as "Delivered." Appellant's attorney asserts the submission included evidence of a MAI 2018 Appraisal Report in relation to the subject property, thereby satisfying the requirements. Appellant respectfully requests that the PTAB reinstate the above-referenced docket. Attached to the request is a copy of an appraisal prepared by JSO Valuation Group, Ltd., with a letter of transmittal dated **November 25, 2019**.

- c. Home Depot USA, Inc.: #19-00058-C-3 (Madison)

#### Motion to Allow Late Filing of Request to Intervene

The postmark of the board of review service to the Taxing District, Edwardsville School District, was on or about March 5, 2020. Accordingly, the Request to

Intervene was supposed to be filed within 60 days or on or before Monday May 4, 2020. Four days after the postmark on March 9, 2020, JB Pritzker, Governor of Illinois declared all counties in the State of Illinois a disaster area in response to the outbreak of COVID-19. On March 13, 2020, the President of the United States declared a nationwide emergency covering all states and territories, including Illinois. On March 20, 2020, Governor Pritzker issued Executive Order 2020-10 (COVID-19 Executive Order No. 8). In this Executive Order, all individuals were ordered to stay at home or at their place of residence. Although legal services were considered essential business, the State encouraged employers to allow employees to work from home if possible. On Friday March 20, 2020, the attorneys and staff started to work remotely. Working remotely has continued through the date of this filing. Counsel requested that the Request to Intervene be prepared by the end of the week of March 23, 2020 and assumed the Request to Intervene had been prepared and filed. It was discovered on June 4, 2020, that it was not filed. Due to COVID-19 issues, staff and the attorneys working remotely, counsel did not follow up on the filing of Request to Intervene until June 4, 2020, when counsel first learned that the Request to Intervene was not prepared and timely filed on or before May 4, 2020. Allowing the Request to Intervene to be filed 32 days late should not represent any prejudice or substantial injustice to the Appellant under the circumstances in this case. Counsel cites *LaSalle Partners, Inc v. IL PTAB*, 269 Ill.App.3d 630 (2<sup>nd</sup>. Dist. 1995) (PTAB decision upheld despite procedurally improper request to intervene). Counsel asserted no hearing has been set and the PTAB has been postponing hearings for 60 days in response to the COVID-19. The Taxing District has included with the filing of this Motion the Request to Intervene in the above stated matter and requests that the Board allow the filing of the Request to Intervene instantler. A copy of the motion was served on the appellant's attorney and the PTAB has not received any response objecting to the same.

d. Brunetta Hill-Corley: #18-43912-C-2 (Cook)

Additional Extension Request

Appellant filed with the PTAB on June 3, 2019 and requested a 90-day extension to submit evidence. On January 2, 2020, the appeal was returned as incomplete to fill out the appellant's assessment request and basis of the appeal. The appellant was granted a 30-day extension with a due date of February 1, 2020, to return the completed appeal. On January 31, 2020, the appellant requested a 90-day extension to submit evidence. On February 27, 2020, the appellant was granted a FINAL 60-day extension to submit evidence with a due date of April 27, 2020. On April 27, 2020, the appellant was granted an automatic 60-day extension due to

COVID-19 with a due date of June 26, 2020. On June 25, 2020, the appellant requested an additional 90-day extension to submit evidence.

- e. Kerry McCarthy-Stilwell: #19-23414-R-1 (Cook)

Additional Extension Request

Appellant filed with the PTAB on January 13, 2019 and requested a 60-day extension to submit evidence. On February 27, 2020, the appellant was granted a Final 60-day extension to file evidence with a due date of April 27, 2020. On April 27, 2020, the appellant was granted an automatic 60-day extension due to COVID-19 with a due date of June 26, 2020. On June 26, 2020, the appellant requested an additional 90-day extension to submit evidence. Please note that at some point a Motion to Substitute was filed in the appeal and the original attorney was replaced. New counsel contends that due to the many complications caused by the COVID-19 pandemic, appellant will not be able to provide the additional information for the above appeal by the requested date.

- f. Cook County Extensions

The Cook County Board of Review (CCBOR) contends that due to the COVID-19 pandemic and the CCBOR's recent finalization of its 2019 Session, the CCBOR requests that the Property Tax Appeal Board allow an extension of 60-days to be granted on the cases that have July 2020 deadlines as follows:
