7. Discussion of Motions

- a. Jon Zabikow: #18-45766-R-1 (Cook - West Chicago)
Wilhelm Salmen: #18-45773-R-1 (Cook - West Chicago)

Appellants, through counsel, filed with the PTAB on June 14, 2019 and requested a 90-day extension to file evidence. On January 9, 2020, the appellants were granted a Final 90-day extension to submit evidence with a due date of April 8, 2020. On April 8, 2020, the appellants were granted an automatic 60-day extension due to COVID-19 with a due date of June 8, 2020. On June 8, 2020, the appellants requested an additional 90-day extension to submit documentation due to recent health concerns.

- b. 9375 Chestnut, LLC: #18-34049-I-2 (Cook - Leyden)

On December 17, 2019, the Village of Franklin Park filed its Request to Intervene. On January 2, 2020, the Village of Franklin Park was granted a 90-day extension to submit evidence with a due date of April 1, 2020. On April 1, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of May 31, 2020. On March 25, 2020, the Intervenor requested an additional 120-day extension, they have requested a preliminary opinion as to market value of the above referenced property from Appraisal Associates. Due to closures related to COVID-19 the Village of Franklin Park requests additional time to file evidence. The property consists of a one-story owner-occupied industrial building with 53,000 square feet of building area built in 1950. The owner has submitted an appraisal in support of its contention of the correct assessment.

- c. The Oaks of Dutch Hollow, LLC: #18-03972-C-2 (St. Clair)

On November 7, 2019, Southwestern Illinois College filed its Request to Intervene. On January 3, 2020, Southwestern Illinois College was granted a 90-day extension to submit evidence with a due date of April 2, 2020. On April 2, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of June 1, 2020. On April 1, 2020, the Intervenor requested an additional 60-day extension beyond the current deadline to submit evidence. The subject property consists of a 42-unit apartment complex. The appellant's appeal is based on assessment inequity with respect to the improvement assessment.

- d. Macy's: #18-03463-C-3 (St. Clair)
J.C. Penney Company, Inc: #18-03282-C-3 (St. Clair)

On December 12, 2019 and October 23, 2019, Southwestern Illinois College filed its Request to Intervene in each appeal, respectively. On January 16, 2020, Southwestern Illinois College was granted a 90-day extension to submit evidence

with a due date of April 15, 2020. On April 15, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of June 1, 2020. On April 15, 2020, the Intervenor requested an additional 60-day extension beyond the current deadline to submit evidence in each appeal. Each property is an anchor department store located in the St. Clair Mall. In each appeal the appellant has submitted an appraisal in support of its contention of the correct assessment.

e. Target Corporation: #18-39347-C-2 (Cook - Thornton)

On January 10, 2020, Hoover-Schrum Memorial S.D. #157 filed its Request to Intervene. On January 23, 2020, Hoover-Schrum Memorial S.D. #157 was granted a 90-day extension to submit evidence with a due date of April 22, 2020. On April 22, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of June 21, 2020. On April 22, 2020, the Intervenor requested an additional 90-day extension to submit evidence. Intervenor's attorney submitted a letter from appraiser requesting an additional 90-days to complete the appraisal report. The subject property is a single-tenant retail building with 134,359 square feet of building area. The appellant submitted an appraisal in support of its contention of the correct assessment.

f. Sheridan Road, LLC: #18-38328-C-2 (Cook - Niles)

On January 20, 2019, Niles Twp. H.S.D. #219 and East Prairie S.D. #73 filed their Requests to Intervene. On February 6, 2020, Niles Twp. H.S.D. #219 and East Prairie S.D. #73, were each granted a 90-day extension to submit evidence with a due date of April 22, 2020. On April 22, 2020, the Intervenor were granted an automatic 60-day extension due to COVID-19 with a due date of June 21, 2020. On May 4, 2020, the Intervenor requested an additional 45-day extension to submit evidence. Intervenor's attorney submitted a letter from appraiser requesting an additional 45-days to complete the appraisal report. The subject property is improved with two, free-standing, industrial buildings constructed in stages in 1954, 1978 and 1997 with a combined building area of 32,100 square feet. The appellant submitted an appraisal in support of its contention of the correct assessment.

g. Attila Suto: #18-34053-I-2 (Cook - Worth)

On January 16, 2020 and January 24, 2020, Community High School Dist. No. 218 and the Village of Alsip filed their Requests to Intervene respectively. On January 30, 2020 and February 6, 2020, C.H.S.D. #218 and the Village of Alsip were each granted a 90-day extension to submit evidence with due dates of April 29, 2020 and May 6, 2020, respectively. On April 29, 2020 and May 6, 2020, the Intervenor were granted an automatic 60-day extension due to COVID-19 with a due dates of June 28, 2020 and July 5, 2020, respectively. On April 15, 2020, the Intervenor

requested an additional 90-day extension to submit evidence. Intervenors' attorney submitted a letter from their appraiser requesting an additional 90-days to complete the appraisal report. The subject property is improved with a single-story, owner-occupied, industrial building constructed in 1969 with 29,022 square feet of building area. The appellant submitted an appraisal in support of its contention of the correct assessment.
