Appellants, through counsel, filed with the PTAB via PTA.Clerk@illinois.gov on April 30, 2020 and requested a 90-day extension to file supporting documentation. On June 11, 2020, the appellants were granted a Final 60-day extension to submit evidence with a due date of August 10, 2020. On August 10, 2020, the appellants requested an additional 30-day extension to submit documentation. Due to unforeseen circumstances resulting from civil unrest in the city of Chicago, staff was unable to physically come into the office to print/mail the evidence for these matters to send to the PTAB office in Springfield.

- b. Linda Zachman: #19-31730-C-1 (Cook - Wheeling)

Appellant, through counsel, filed with the PTAB via PTA.Clerk@illinois.gov on May 20, 2020 and requested a 90-day extension to file supporting documentation. On June 11, 2020, the appellant was granted a Final 60-day extension to submit evidence with a due date of August 10, 2020. On August 10, 2020, the appellant requested an additional 30-day extension to submit documentation. Due to unforeseen circumstances resulting from civil unrest in the city of Chicago, staff is unable to physically come into the office to print/mail the evidence for these matters to send to the PTAB office in Springfield.

- c. Christopher De Simone: #19-31744-C-1 (Cook - Wheeling)

Appellant, through counsel, filed with the PTAB via PTA.Clerk@illinois.gov on May 21, 2020 and requested a 60-day extension to file supporting documentation. On June 11, 2020, the appellant was granted a Final 60-day extension to submit evidence with a due date of August 10, 2020. On August 10, 2020, the appellant requested an additional 30-day extension to submit documentation. Due to unforeseen circumstances resulting from civil unrest in the city of Chicago, staff is unable to physically come into the office to print/mail the evidence for these matters to send to the PTAB office in Springfield.

- d. Sam Abdallah: #19-32015-C-1 (Cook - Lake)

Appellant, through counsel, filed with the PTAB via PTA.Clerk@illinois.gov on May 29, 2020 and requested a 60-day extension to file supporting documentation. On June 11, 2020, the appellant was granted a Final 60-day extension to submit evidence with a due date of August 10, 2020. On August 10, 2020, the appellant requested an additional 30-day extension to submit documentation due to unforeseen circumstances resulting from civil unrest in the city of Chicago, staff is unable to physically come in to the office to print/mail the evidence for these matters to send to the PTAB office in Springfield.

e. Manchester Square, LLC: #18-02714-C-3 (Lake)

On October 29, 2019, Libertyville C.H.S.D. #128 filed its Request to Intervene. On November 7, 2019, Libertyville C.H.S.D. was granted a 90-day extension to submit evidence with a due date of February 5, 2020. On March 13, 2020, the Intervenor was granted a **Final** 60-day extension. On May 12, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of July 11, 2020. On May 12, 2020, the Intervenor requested an additional 60-day extension to finalize the submission of evidence

f. Trustmark Insurance Co.: #18-03188-C-3 (Lake)

On January 28, 2020, Libertyville C.H.S.D. #128 filed its Request to Intervene. On February 6, 2020, Libertyville C.H.S.D. #128 was granted a 90-day extension to submit evidence with a due date of May 6, 2020. On May 6, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of July 5, 2020. On May 5, 2020, the Intervenor requested an additional 60-day extension to finalize the submission of evidence

g. V. Covington Realty LLC: #18-03189-C-3 (Lake)

On January 24, 2020, Waukegan C.H.S.D. #60 filed its Request to Intervene. On February 6, 2020, Waukegan C.H.S.D. #60 was granted a 90-day extension to submit evidence with a due date of May 6, 2020. On May 6, 2020, the Intervenor was granted an automatic 60-day extension due to COVID-19 with a due date of July 5, 2020. On May 5, 2020, the Intervenor requested an additional 60-day extension to finalize the submission of evidence.

h. Allen Snyder: #14-23804-C-1 (Cook - Berwyn)

Motion for Reinstatement

Counsel filed a Motion for Reinstatement of PTAB Docket No. 14-23804.001-C-1. The PTAB entered an order on August 1, 2018 granting the appellant's request to withdraw the appeal. The appellant asserts he would not have filed the withdrawal request but for the Cook County Assessor's Office assertion on November 28, 2017, that the 2014 Certificate of Error Application would not be reviewed and approved by the Cook County Board of Review until the 2014 Illinois Property Tax Appeal (Docket No. 14-23804.001-C-1) was dismissed. The Order of Dismissal was entered on August 1, 2018. On September 3, 2019, Appellant received a letter denying the Certificate of Error Application. On or about January 19, 2015, appellant filed an appeal on the subject property (6420 W. Cermak Road, Berwyn) and the supporting documentation which included an appraisal prepared by Property Valuation Services prepared as of January 1, 2014. The appeal and supporting documentation were never reviewed or decided by the Property Tax Appeal Board. Appellant through counsel move the PTAB to grant this Motion for Reinstatement of 2014 PTAB Docket No 14-23804.001-C-1 due to the fact the Appellant's case and previously submitted evidence has not been reviewed and decided by the PTAB.

- i. David Sbarbaro: #19-02223 (St. Clair)
David Sbarbaro: #19-02224 (St. Clair)

Appellant filed with the PTAB on March 9, 2020, three (3) days late from the St. Clair County Board of Review decision dated February 5, 2020. On July 16, 2020, the appeals were dismissed based on a lack of jurisdiction. By letter dated July 21, 2020, appellant requested a reinstatement due to the fact he was given the date of March 9, 2020, twice over the phone by staff of the "PTAB of St. Clair County," he asserts they did not give him the correct date of March 6, 2020.

- j. Rodney & Lisa Kruse: #19-02220 (St. Clair)

Appellants filed with the PTAB on March 9, 2020, three (3) days late from the St. Clair County Board of Review decision dated February 5, 2020. On July 16, 2020, the appeal was dismissed for lack of jurisdiction. By letter dated July 24, 2020, appellants requested the appeal be reinstated. The appellant, Lisa Kruse, estimated the due date to be March 6, 2020, however, appellant asserts when she spoke to Andrea Johnson, Chief Deputy, St. Clair County Board of Review on February 26, 2020, Ms. Johnson indicated twice during the call that the deadline to file with PTAB was March 9, 2020. Appellant signed her appeal on March 5, 2020,

believing the deadline to file was March 9, 2020, she chose to continue to work on the appeal over the weekend of March 7th & 8th to make sure everything was in order. Appellant contends the Property Record Card on file with St. Clair County does not reflect accurate information about the property.

k. Motion to Reconsider Cook County Extension Request:

At the PTAB’s July meeting, the Board considered Cook County BOR request for an extension of time to submit evidence on numerous files. The Cook County Board of Review (CCBOR) asserted that due to the COVID-19 pandemic and the CCBOR’s recent finalization of its 2019 Session, the Property Tax Appeal Board allow an extension of 60-days to be granted on the cases that had July 2020 deadlines as follows:

There were 1,554 cases on this request. The board of review had received the automatic COVID 60-day extension. There were 927 appeals that had received a final 90-day extension on 2/5/2020, and subsequently received an automatic COVID 60-day extension on 5/5/2020.

The PTAB ruled that for those 927 appeals that had received an initial 90-day extension when notified of the appeal plus the 90-day final extension plus the 60-day automatic COVID extension, for a total of 240 days, to deny request for a further extension of time and default the CCBOR in those appeals in which it had submitted no evidence.

For the remaining 627 appeals, the PTAB granted the CCBOR a final extension commensurate with its requested dates. The breakdown of the appeals where the extensions were requested is as follows:

Cook County Board of Review requests the PTAB reconsider its July 14, 2020, decision to deny the CCBOR’s request to extend the deadline to submit evidence on approximately 927 appeals.

The CCBOR explained that on December 23, 2019, the CCBOR requested an extension to submit evidence which was granted, extending the deadline from February 5, 2020, to May 5, 2020, noting it was a “Final 90-day extension”. On or about March 9, 2020, Governor Pritzker issued the “Executive Order in Response to COVID-19” effective March 21, 2020, mandating that “all individuals currently living within the State of Illinois are ordered to stay at home or at their place of residence.” On or about March 24th, the PTAB stated that “to help alleviate any approaching deadlines, the PTAB will be granting a 60-day extension to any deadlines that occur from March 23, 2020, through April 30, 2020, system wide.” The extensions will run from the original date for 60 additional days. The PTAB will not be sending letters for these extensions, however, the parties will be able to see the extensions granted on the Appeal Status Inquiry system once the original deadline expires. On or about April 14, 2020, and May 5, 2020, the PTAB granted an automatic extension for any pending deadlines from April 30th to May 31st, 2020. On May 5, 2020, the PTAB granted CCBOR an “automatic” additional 60-day extension to submit evidence, extending the deadline to July 4, 2020. On June 9, 2020, via the PTAB Board Meeting Minutes, the Director of the PTAB stated that the PTAB “have been granting automatic extensions and have allowed the filing of new appeals with a minimum of evidence”. On or about June 26, 2020, the CCBOR requested an additional extension to submit evidence, extending the July 4th deadline to September 2, 2020. In support of said request, the CCBOR stated that the extension was necessary “due to the COVID-19 pandemic and the CCBOR’s recent finalization of its 2019 Session.”

The CCBOR contends that due to the Governor’s “Stay at Home Order” both the BOR and the County Assessor’s Office were forced to work remotely. The BOR

and County Assessor work collectively in gathering evidence in defense of Commercial and Industrial appeals before the PTAB. The BOR also asserts that during the “Stay at Home Order” it was finalizing the 2019 Tax Appeal Session by mid-May 2021 (sic). It asserts that due to the pandemic a multitude of Cook County Govt. units have suffered significant budgetary shortfalls and, presently the real estate tax revenue is one of the few reliable income streams for municipal financing during these dire financial times. The PTAB’s denial of the CCBOR’s request for an extension of time to submit evidence is the equivalent of a “default”, which will result in several Cook County taxing districts having to disburse over \$11 million dollars in refunds. The BOR contends the PTAB’s denial of the request for an extension of time to submit evidence is fundamentally unfair to and unduly prejudices many Cook County Govt. units.
