Motion to Reinstate

Appellants, through counsel, filed with the PTAB on May 28, 2019. On December 12, 2019, the appeals were returned as incomplete to fill out Section II, 2d: the basis of the appeal and all the characteristics required in Section V: based on comparable sales or assessment equity with a due date of January 11, 2020. On January 30, 2020, (19 days late) the PTAB received the appeals with the requested information. On March 12, 2020, the PTAB sent correspondence dismissing the appeals due to untimely filing, which was incorrect in that the appeals should have been dismissed due to the failure to timely respond to the incomplete notice. On May 26, 2020, counsel requested reinstatement of the above appeals. She explained that due to Covid-19, her office, abiding by the Governor's Stay at Home Order since March 22, 2020, is the cause for delay in sending the reinstatement request letter.

On January 16, 2020, in accordance with the withdrawal request the case was dismissed. By letter dated May 13, 2020, appellant through counsel requested the case be reinstated, his request for extension was granted and then was unable to reach the appellant to secure all necessary evidence for submission in support of the complaint in a timely manner, so he submitted the request to withdraw. The appellant recently contacted counsel asserting, “he was struggling with personal matters that disturbed his day to day activities and prevented him from responding to the request for evidence in support of the appeal.”
