Petition to Reopen Proofs

The property in each of the above appeals is improved with a supportive living facility. Supportive living facilities are to be assessed in accordance with section 10-390 of the Property Tax Code using the income capitalization approach. However, local assessment officers may not consider payments from Medicaid or residents if the payments constitute income attributable to services and not the real estate.

In *Manteno Community Unit School Dist. No. 5 v. Illinois Property Tax Appeal Board, DSI Manteno Owner, LLC & Kankakee County BOR*, 2020 IL App (3d) 180384, (filed August 17, 2020, Modified Upon Denial of Rehearing September 22, 2020), the Third District Appellate Court entered its opinion following a complaint for administrative review filed in PTAB Docket No. 13-00178.001-C-3. (This appeal involves the same property that is the subject matter of appeals before the PTAB in docket numbers 14-04151, 15-06856, 16-00248 & 17-00124.) In the 2013 appeal, the PTAB reduced the assessment of the subject property based on the appraisal prepared by Honegger. The appellate court reversed and remanded the matter to the PTAB with directions to reinstate the assessment as established by the board of review. The appellate court found the methodologies of the appellant's appraiser, Keith Honegger, and intervenor's appraiser, Michael MaRous, were flawed which resulted in legally erroneous approaches to income capitalization. The methodology used by DSI's appraiser in the above pending appeals is the same methodology that was addressed in the 2013 appellate court opinion. The court found Honegger's method flawed because he did not take into consideration the capacity to earn income from double-occupancy of some one-bedroom units. The court determined that the appellant's appraiser's estimate of potential gross income should not have been based on an assumption that all income generated from one-bedroom units was limited to the amount of rent paid by a single occupant of each unit. The court reasoned that even if rental income from double-occupancy one-bedroom units is rare or minimal, the capacity to earn a reasonable amount of this additional rental income was ignored by the appellant's appraiser for purposes of determining fair cash value, which resulted in a flawed methodology under the income capitalization approach. The court also determined that the appellant's assertion that it could not charge private-pay residents higher rents than Medicaid-eligible residents was incorrect based on a provision in the Illinois Administrative Code. The court found that testimony provided by one of the appellant's witnesses demonstrated that the property owner received higher rents from private-pay residents than Medicaid residents for the same services when the private-pay residents are in a bigger room, indicating additional income is attributable to the real estate, which was not considered by the appellant's appraiser. The court determined that Honegger's estimate of value did not consider the true income earning capacity based on the real estate income from private-pay residents. The court did not disturb the PTAB's findings that MaRous's valuation methodologies and opinions were flawed and unreliable.

On December 12, 2018, the PTAB entered an Order staying the 2014 and 2015 Kankakee County proceedings in these subsequent appeals until 90-days after the appellate court issued its mandate in the 2013 appeal (13-00178-C-3). The Stay Order gave the Kankakee Board of Review and Manteno Community Unit School Dist. No. 5, 90-days from the issuance of the court's mandate in the 2013 appeal to file their evidence. The PTAB did not stay the filings in the 2016 and 2017

appeals. DSI is requesting that Proofs be reopened to allow it to file evidence following the methodology set out in the 2013 appellate court opinion.

On November 11, 2020 PTAB received a reply from intervenor, Manteno Community Unit School Dist. No. 5, objecting to Appellant's Petition to Reopen proofs for 14-04151, 15-06856, 16-00248 and 17-00124. The intervenor contends the PTAB's rules do not allow for the re-opening of proofs and evidence will be accepted after receipt of the petition only when a written request for an extension has been filed and granted. (PTAB rule 1910.30(k)). The intervenor contends that evidence that is not timely submitted is inadmissible. The intervenor contends in the 2016 and 2017 appeals it was denied the request for an extension to submit evidence until the appellate court proceeding in the 2013 appeal was resolved. The taxing district then went through the expense of obtaining updated appraisals for the 2016 and 2017 appeals. The school district contends that allowing the appellant to file new evidence now will cause substantial prejudice to the intervenor who was required to file its evidence despite the uncertainty surrounding the PTAB's 2013 decision and the appellate court proceedings. If the appellant is allowed to file new evidence, the intervenor will be required to undergo further expense by obtaining and responding to the appellant's new evidence.

In Docket No. 18-05462, the Jefferson County BOR was notified of the appeal on 1/9/20. No evidence has been submitted and all extensions appear to have expired. The PTAB has not received a certificate from the BOR that taxing districts have been notified of the appeal.

In Docket No. 19-09055, the Stephenson County was notified of the appeal on 10/15/20 with an extension until 1/13/21.

In Docket No. 18-00873, the Kane County BOR was notified of the appeal on 3/14/19. Elgin School Dist. U-46 was added as an intervenor on 5/2/19. On 9/12/19, the BOR indicated it will adopt the evidence of the intervenor and submitted no evidence. On 11/12/19 the intervenor adopted and affirmed the evidence adopted by the BOR and submitted no evidence.

In Docket No. 19-01997, the Kane County BOR was notified of the appeal on July 9, 2020 and granted an extension until 10/7/20. On 10/7/20 the BOR requested an extension to submit evidence, which is pending as part of item f. of the agenda. Elgin School Dist. U-46 was added as an intervenor on 9/10/20 and has been granted an extension until 12/9/20.
