On September 30, 2020, the St. Clair County board of review requested the PTAB grant an additional 60-day extension to evaluate the material submitted by the appellants and to prepare our own summation of value. In Docket No. 19-01764 the appellant is requesting an assessment reduction of \$6.2 million

and in Docket No. 19-01975 the appellant is requesting an assessment reduction of approximately \$1 million.

b. BIG MTV LLC: #19-01923-C-3 (Jefferson)

The Jefferson County Board of Review was notified of the appeal on July 2, 2020 and was granted a 90-day extension to submit evidence with a due date of September 30, 2020. By letter dated September 30, 2020 but postmarked on October 1, 2020 (St. Louis postmark), the Jefferson County Board of Review requested PTAB grant an additional 30-day extension to better prepare for the case. The clerk of the board of review asserts it has been working with reduced staff since April. The appellant is requesting an assessment reduction of approximately \$476,000.

c. Edward Randerson: #19-02559-F-1 (Marshall)

The Marshall County Board of Review was notified of the appeal on July 23, 2020 and was granted a 90-day extension to submit evidence with a due date of October 21, 2020. On October 1, 2020, the Marshall County board of review requested the PTAB grant an additional extension of time to submit evidence. The Chief County Assessment Officer indicated that she has been assisting the board of review and has been assigned the task of preparing a response. She explained her husband was notified on September 29<sup>th</sup> that he had tested positive for COVID and was quite ill. She is quarantined until October 13<sup>th</sup> and was concerned if she becomes ill with the virus. she would be further delayed in responding.

d. Rick & Brenda Humphrey: #19-00407-F-2 (Lee)

The Lee County Board of Review was notified of the appeal on August 20, 2020 and was granted a 90-day extension to submit evidence with a due date of November 18, 2020. On November 6, 2020, the Lee County Board of Review requested the PTAB grant an additional 30-day extension to submit evidence.

e. McDonalds USA, LLC: #19-03061-C-2 (McHenry)  
Jayson and Megan Rishling: #19-03281-R-1 (McHenry)

The McHenry County Board of Review was notified of the appeals on August 13, 2020 and was granted a 90-day extension to submit evidence with a due date of November 11, 2020. On November 9, 2020, the board of review requested the

PTAB grant an additional 60-day extension of time to discuss an agreement with appellant/attorney in each appeal.

- f. Terry Michaels Tower Sites: #19-09130-I-1 (Ford)

The Ford County Board of Review was notified of the appeal on October 22, 2020 and was granted a 90-day extension to submit evidence with a due date of January 20, 2021. On November 18, 2020, Christopher Sherer entered his appearance on behalf of the board of review requested the PTAB grant an additional 90-day extension of time to have an appraisal performed. The subject property has a total assessment of \$23,520 and the appellant is requesting an assessment of \$5,000 based on a 7/20/18 purchase for a price of \$15,000.

The McHenry County Board of Review was notified of the appeals on August 20, 2020 and was granted a 90-day extension to submit evidence with a due date of November 18, 2020. On November 16, 2020, the McHenry County Board of Review requested the PTAB grant an additional 60-day extension of time to discuss an agreement with the appellant/attorney.

- h. Chicago Title Land Trust CTLT 8002373064: #19-02082-R-1 (Kane)

The Kane County Board of Review was notified of the appeal on August 20, 2020 and was granted a 90-day extension to submit evidence with a due date of November 18, 2020. On November 13, 2020, the Kane County Board of Review requested the PTAB grant an additional extension of time to review and complete evidence on this appeal. The property is a vacant parcel with 188,614 square feet or 4.33 acres of land area. The appellant is requesting the assessment be reduced from \$33,330 to \$13,330.

The Livingston County Board of Review was notified of the appeals on October 8, 2020 and was granted a 90-day extension to submit evidence with a due date of January 6, 2021. On November 16, 2020, Christopher Sherer entered his appearance on behalf of the Livingston County Board of Review in each appeal and requested the PTAB grant an additional 90-day extension of time as the board of review is in the process of securing an appraisal in each appeal.

- j. Elwood Energy LLC: #19-00356-I-3 (Will)

The Will County Board of Review was notified of the appeal on September 3, 2020 and was granted a 90-day extension to submit evidence with a due date of December 2, 2020. On November 20, 2020, the Will County Board of Review requested the PTAB grant an additional 90-day extension of time to submit evidence. The board of review explained that it is adopting an appraisal being prepared for the interveners and it requested an extension to submit the appraisal. The appellant is requesting the assessment be reduced from approximately \$14.6 million to \$1.3 million. Laraway Community Consolidated School Dist. No. 70-C intervened and has an extension set to expire on January 6, 2021. Joliet Township High School Dist. No 204 intervened and has an extension set to expire on and January 6, 2021. Elwood Community Consolidated School Dist. No 203 intervened and has an extension set to expire on January 6, 2021.

- k. TF Peoria IL LLC dba Sears Store No 1321: #19-01303-C-3 (Peoria)

The Peoria County Board of Review was notified of the appeal on August 27, 2020 and was granted a 90-day extension to submit evidence with a due date of November 25, 2020. On November 25, 2020, the Peoria County Board of Review requested the PTAB grant an additional 90-day extension of time to gather sufficient documentation to defend this appeal. Based on appraisal, the appellant is requesting the assessment be reduced from approximately \$1.8 million to \$1.17 million.

- l. Brian Monticello: #19-03639-R-1 (DuPage – Milton)

Motion to Reinstate

Appellant filed with the PTAB on April 20, 2020. On August 20, 2020, the appeal was returned as incomplete due to the failure to sign and date the appeal. The appellant was given a 30-day extension to complete the filing (date and sign the appeal) with a due date of September 19, 2020. On November 12, 2020, the PTAB dismissed the appeal and closed the file. On November 21, 2020, the appellant requested the appeal be reinstated. The appellant asserted that upon receiving notification that the form was incomplete he sent a signed version of the appeal form but it was not received by PTAB. Upon learning the appeal had been dismissed due to incorrect documentation, he contacted the PTAB and spoke with Jackie (Rekesius) who conducted an unsuccessful search for the missing document. The appellant enclosed the completed and signed Appeal form dated November 20, 2020.

- m. Margaret A. Kedzierzawski: #19-09423- R-1 (McHenry – McHenry)

Motion to Reinstate

Appellant filed with the PTAB on June 10, 2020 from a decision issued by the McHenry County Board of Review on March 16, 2020. The last date to file the appeal was on Thursday, April 15, 2020. The appeal was filed 56 days late. On November 19, 2020 the appeal was dismissed due to being untimely filed. On November 25, 2020 the appellant requested the appeal be reinstated. She asserted she was sick with Covid-19 when she should have mailed her appeal. She also explained that she works in a hospital and worked long hours from March through June. She further stated that McHenry County gave an extension to pay property taxes until September 2020. Since places were shut down until June 26, 2020, she thought the PTAB might have an extension to file the appeal.

- n. Shaikh A. Chhabra: #19-09440-R-1 (McHenry – Grafton)

Motion to Reinstate

The appellant filed the appeal with the PTAB on June 16, 2020 from a decision issued by the board of review dated March 16, 2020. The 30-day filing deadline with the PTAB expired on Thursday, April 15, 2020. The appeal was filed 61 days late. On November 19, 2020 the appeal was dismissed due to being untimely filed. On November 30, 2020 the appellant requested the appeal be reinstated due to Covid-19 pandemic and the National Emergency Proclamation made by the President, extensions granted by the Centers for Medicare & Medicaid Services

(CMS), and the Order issued by the Supreme Court of Illinois on March 24, 2020, extending the time to file a notice of appeal, appellant and appellee briefs and petitions for rehearing.

o. Grand Tower Energy Center LLC: #19-02536-I-3 (Jackson – Grand Tower)

Shawnee Community Unit School Dist. No. 84 requested to Intervene on September 3, 2020 and were granted a 90-day extension to submit evidence with a due date of December 2, 2020. On December 1, 2020, the Intervenor requested an additional 90 or 120-day extension of time to submit evidence from the appellate court's ruling in the 2014 and 2015 PTAB appeals that are under administrative review. On August 20, 2020, the school district filed its appellate court brief in the pending appellate court proceedings. Based on the pending Appellate Court proceeding, the school district is requesting additional time by which to file its evidence. The intervenor contends the evidence it submits in the 2019 appeal will largely depend on the appellate court's ruling.

The appellant has requested the subject's assessment be reduced from approximately \$31.5 million to \$8.0 million. The property consists of a natural-gas combined cycle gas turbine generation facility with a net capacity of 529 megawatts. The PTAB issued decisions for the 2014 and 2015 tax years reducing the assessment of the subject property based on the appraisal provided by the taxpayer. These two appeals are currently on Administrative Review in the Appellate Court of Illinois, 5<sup>th</sup> District. There are currently pending a 2016 and 2017 appeals on this property.

p. Exelon Generation Company LLC: #19-02497-I-3 (Ogle -Rockvale)

Motion to Stay

Appellant filed with the PTAB on March 20, 2020 and requested an extension to submit evidence. On July 23, 2020, the appellant requested an additional extension to submit evidence with a due date of November 20, 2020. Exelon Generation Company LLC ("Exelon" or the ("Taxpayer") previously filed with the Property Tax Appeal Board. At the time of filing, Exelon requested a 90-day extension in which to file its evidence and contentions of law in this appeal. On July 23, 2020, the Property Tax Appeal Board granted that request and gave Exelon an extension until November 20, 2020, to submit evidence.

Additionally, appeals of the 2012 Ogle County assessments were filed with the Board by both Exelon and Byron Community School District Unit 226 (Docket #

12-01248 and Docket #12-02297). Both parties have intervened in the appeals. These matters were combined for purposes of hearing. The hearing in these matters began in April 2016 continued through June 2016. Post hearing briefs have been filed, and the matter is awaiting decision. The outcome of this hearing will affect all appeals currently pending regarding Property Identification Numbers (2012, 2013, 2014, 2015, 2016, 2017, 2018, and 2019). In Early 2017, prior to filing of the 2016 appeal, the PTAB granted the parties' joint motion to stay the 2013-2015 appeals pending the outcome of the 2012 appeals. On August 21, 2018, December 12, 2018, and June 18, 2019 respectively, the PTAB ordered a stay of the 2016, 2017, and 2018 appeals in lieu of considering further extensions at this time. Exelon believes that the 2019 appeal also should not be adjudicated until the 2012 appeals have been decided by the PTAB, like the other stayed appeals.

Due to the complexity of preparing evidentiary and documentary materials and contentions of law with regard to the assessment of this nuclear power station, thereby establishing good cause in accordance with PTAB Rule 1910.30(g), the Taxpayer requested the PTAB take the same course (i.e. to stay the 2019 appeals) as it relates to the 2019 appeals. Alternative, the Taxpayer requests a 90-day extension to file evidence, as well as contentions of law, in this appeal.

- q. Byron Community Unit School District #226: #19-02613-I-3 (Ogle – Rockvale)

#### Motion to Stay

Appellant filed with the PTAB on March 31, 2020 and requested a 90-day extension to submit evidence. The appellant was granted a 90-day extension on July 23, 2020, to submit evidence due on November 20, 2020. The School District's evidence in PTAB Docket #19-02613 is currently due to be filed with PTAB on November 20, 2020. Appeal proceedings are pending final resolution of the 2012 appeals. This appeal involves the 2019 assessed valuation of Exelon's Byron Nuclear Power Station. Prior to the 2012 assessment year, the assessed value Byron Station was subject to a court approved Section 9-45 settlement agreement. That agreement expired with the 2012 assessment year and both Exelon and the School District appealed the 2012 assessed value placed on Byron Station by the Ogle County Board of Review. Exelon's 2012 appeal and the Byron School District's 2012 appeal were consolidated and the testimony portion of the trial was conducted over the course of several weeks and concluded on June 22, 2020. Following trial, the admissibility of the documentary evidence being offered by the parties was fully briefed and, thereafter, the PTAB issued its ruling on the admissibility of the documentary evidence. The parties then filed initial post-hearing briefs with the PTAB on January 17, 2017 with reply briefs filed on March 20, 2017.

The documentary evidence pre-filed by the parties in the 2012 appeal consisted of over 16,000 pages of evidence contained in twenty-seven (27) binders. The factual and legal issues that will be decided by the PTAB in the 2012 consolidated appeals are largely the same as those presented in above captioned appeal, as well as the 2013, 2014, 2015, 2016, 2017 and 2018 Byron Station appeals for which the PTAB granted the School District's Motion to Stay.

Byron Community Unit School District #226 is requesting that the PTAB stay the 2019 tax assessment appeals regarding the assessed value of Byron Nuclear Power Station until 90-days following final resolution of the 2012 appeals.

In the event the PTAB denies the School District's Motion to Stay Proceedings, due to the complexity of this matter, and the voluminous evidence filing required, the School District respectfully requests a 90-day extension of time to complete its evidence filings in the 2019 appeal.

- r. David Showalter: #16-25517-R-1 (Cook)

#### Motion to vacate Final Administrative Decision

On July 21, 2020, the PTAB issued a written decision confirming the assessment of the subject property as established by the board of review totaling \$61,659. The appellant's argument in the appeal was that the second building improvement on the subject property was not a single-family dwelling but a one-car garage with workspace on the second floor. The PTAB confirmed the assessment based on an April 2016 sale price of \$775,000.

On November 20, 2020 the appellant filed a Motion to Vacate the decision issued by the PTAB. Counsel explained the Property Tax Appeal Board appeal was filed as part of an ongoing effort to correct the long-standing errant classification of the appellant's garage as a small single-family home. Subsequently to the filing of the 2016 PTAB appeal, the appellant also filed an appeal with the Cook County Assessor's Office (CCAO) in 2017. In response, the CCAO performed a field check on the property, confirmed that the garage should not be classified as a house, and reduced the property's assessed value by 29.9%. In addition, the CCAO issued Certificates of Error for tax years 2014, 2015 and 2016, which reduced the 2016 assessment to \$43,335. On September 2, 2020, the Cook County Treasurer's Office, following the decision issued by the PTAB, informed appellant that the appellant owed \$7,375.00 in taxes plus \$4,425 in interest because of the PTAB's 2016 decision, which is conflict with the CCAO's 2016 Certificate of Error. The



appellant requests that the PTAB vacate the 2016 decision. The PTAB decision effectively reverses the CCAO decision.

s. Marquardt School Dist No 15: #18-04883-I-3 (DuPage)

The is an undervaluation complaint filed by the school district requesting the assessment be increased to approximately \$2.733 million to reflect an appraised value of \$8.2 million. The subject's total assessment \$1,759,650 reflects a market value of approximately \$5.279 million.

On December 9, 2019, BCI IV Addison DC, LLC, the property owner, through attorney Brian Liston, filed a Request to Intervene. On January 2, 2020, the PTAB acknowledged the request to intervene but notified the property owner and not counsel. The owner/intervenor and was granted a 90-day extension to submit evidence with a due date of April 1, 2020. On April 1, 2020, the PTAB gave a 60-day extension due to Covid-19, with a due date of May 31, 2020. On May 31, 2020, the PTAB gave an additional 60-day extension with a due date of July 30, 2020. On July 23, 2020 the PTAB sent a letter to attorney Brian Liston, acknowledging the intervention, and granted an additional 90-day extension with a due date of October 21, 2020. By letter postmarked October 21, 2020, the Intervenor/owner is requesting an additional 90-day extension to continue discussion with the Appellant (school district) to resolve the appeal and to submit its valuation argument and its documentary evidence supporting the same.

t. John Hillman: #16-20300-R-1 (Cook - Oak Park)

Motion to Vacate Administrative Decision

On August 18, 2020, the PTAB issued a decision in the above matter reducing the assessment to \$84,486, based on a stipulation signed by the parties on May 29, 2020.

On November 24, 2020, the appellant filed a Motion to Vacate the PTAB's decision issued on August 18, 2020 and to Withdraw the Appeal.

The appellant explained that on July 18, 2019 the Cook County Assessor certified a Certificate of Error for 2016 reducing the assessment from \$91,887 to \$80,624. A copy of the Certificate of Error was attached as Exhibit A. After the Certificate of Error was issued, the Appellant's attorneys failed to properly mark their file that the Certificate of Error was granted and subsequently entered into an agreement with the Board of Review in May 2020 to settle the 2016 assessment for \$84,486,

which is greater than the assessment contained in the Certificate of Error. As a result of the PTAB settlement/decision, the Cook County Treasurer has issued an open item real estate tax bill to the Appellant for \$2,487.19 which is comprised of \$1,554.39 in taxes and \$932.80 in penalty and interest. The Appellant's attorney contends the error was clerical in nature and unintentional and requests the PTAB's decision issued on August 18, 2020 be vacated and the appeal be withdrawn.
