The DuPage County Board of Review was notified of the various appeals on 9/24/20, 10/1/20, & 10/8/20, respectively, and granted 90-day extensions for evidence that expired on 12/23/20, 12/30/20 & 1/6/21, respectively. By letter of 1/8/21, the chairman of the BOR requested a 45-day extension in each appeal. The chairman explained that since September, the start of the Board of Review (BOR) season, the BOR has been receiving almost weekly emails of new PTAB filings.

The chairman asserted that due to it being the BOR busy season, the Covid-19 situation in the office, the lack of office staff (even without the Covid-19) and only

one person handling all the PTAB and Board of Review appeals, the BOR has been unable to submit some appeals to PTAB by their due dates and are asking for some leeway in this situation. The chairman noted that staff (one person) has been working many hours trying to keep up with BOR and PTAB appeals and, although there are some dockets that have been processed and sent to the state (PTAB) already, there are many more to go. The BOR chairman hoped the PTAB would consider the request for an extension as they are processing appeals as quickly as they are able. The BOR requested an additional 45-days to submit the evidence in each appeal.

The Kane County Board of Review was notified of the appeals on June 4, 2020 and/or June 18, 2020 and was granted a 90-day extension to submit evidence with due dates of September 2, 2020 and/or September 16, 2020. On August 26, 2020 and/or September 4, 2020, the Kane County BOR requested the PTAB grant an additional extension to review and complete evidence. The appeals went on the PTAB Agenda on October 13, 2020 and the board of review was granted a Final 60-day extension, which expired on Monday, December 14, 2020. On December 11, 2020, the board of review requested the PTAB grant an additional 90-day extension to submit evidence. The Supervisor of Assessments/Clerk of the Board explained that the additional 90-day request is due to the statutory requirements regarding professional service contracts. The BOR issued a Request for Proposal for appraisal services and appraisal review services and settled on Kenneth Polach, MAI, to provide appraisal services and Susan Enright, MAI, to provide appraisal review services. According to the BOR clerk, the aggregate contracts were higher than anticipated triggering additional requirements under both state and county ordinance. He explained that the BOR cannot lawfully engage the professionals until the Kane County Board has given its approval, which was projected for January 13, 2021. He indicated that the following steps must be taken: (1) approval by the County Board Public Service Committee, (2) approval by the County Board Finance and Budget Committee, (3) approval by the County Board Executive Committee, and (4) approval by the full Kane County Board.

Motion to Reinstate

The appellant, through counsel, filed with the PTAB on April 27, 2020. On October 8, 2020, the appellant was granted a final 60-day extension to file evidence, which expired on Monday, December 7, 2020. Appellant's evidence was postmarked on December 7 and received on December 8, 2020 and included a vacancy affidavit and an argument that the subject's assessment should be reduced using an occupancy factor of 25%. No other evidence was submitted.

On December 31, 2020 the appeal was dismissed due to the lack of sufficient evidence to satisfy the burden of going forward to challenge the correctness of the assessment.

On January 6, 2021, the PTAB received a Motion to Reinstate the appeal. The appellant asserts that he filed evidence with PTAB on December 7, 2020 to meet its burden of proof as set forth in PTAB's rule. Attached to the Motion to Reinstate was an appraisal report, Exhibit No. 2, which concludes a market value of \$640,000 as of January 1, 2019. The appraisal was not filed within the extension filing period.

Motion to Reinstate

On August 18, 2020, the PTAB issued a decision reducing the assessment of the subject property for the 2017 tax year from \$30,460 to \$27,970. (The Effingham County BOR was defaulted – no evidence submitted.) The appellant filed the 2018 appeal in an envelope postmarked September 26, 2020. The appeal was filed from the PTAB's decision reducing the assessment for the prior tax year pursuant to section 16-185 of the Property Tax Code, however, the appeal must be filed within 30 days of the PTAB's written decision, which expired on Thursday, September 17, 2020. By letter dated November 19, 2020 the appeal was dismissed due to untimely filing.

By letter dated December 10, 2020, the appellant, explained that the commercial appeal form was dated September 17, 2020 and received on September 26, 2020, 8 days after the deadline. The appellant argued that considering the filing information was buried on the back of the 3rd page of the PTAB decision, the denial is callous and unfair. The appellant acknowledged the filing was late but not egregiously so. The appellant further asserted that since it took nearly 2½ years to get to the appeal and grant a reduction, the years that follow, due to the untimely resolution, should automatically be refunded as well. The appellant contends that it is up to Effingham County, on the PTAB's authority, to make the initial refund and they have the means to arrive at the appropriate subsequent refunds. The appellant contends that she and her husband continued to pay the over-priced property taxes, on time, each year as they waited for the PTAB decision to be handed down. They own a small business that will generate less than \$48,000 gross this year. The appellant asserted that the corrections of all overpayments are always appreciated. The appellant requested the PTAB reconsider the denial/dismissal of the appeal.
