Appellant filed with the PTAB on November 20, 2019. On February 13, 2020, the appeal was returned as incomplete, as the appellant did not provide any comparable sales to support the overvaluation argument, and the appellant was given a 30-day extension with a due date of March 14, 2020 to complete the appeal. On March 9, 2020, the appellant requested an extension to submit evidence. On June 11, 2020, the appellant was granted a Final 60-day extension with a due date of Monday, August 10, 2020. On August 11, 2020, the appellant requested an extension to submit evidence and allow additional time due to the Covid-19 pandemic shut-down. On October 1, 2020, the appellant was granted a "Final" 30-day extension with a due date of October 31, 2020. On November 4, 2020, the

PTAB received another extension request from the appellant requested another extension contending that due to the inability to gather the necessary evidence due to COVIDS shutdowns. On December 24, 2020, the appellant was granted a “Final” 30-day extension with a due date of January 23, 2021. On January 25, 2021, the appellant is requesting another extension. Appellant has had 150-days extension. The property consists of a residential condominium unit.

The property is composed of a two-story commercial building and the basis of the appeal is assessment inequity.

The St. Clair County Board of Review was notified of the appeals on November 5, 2020 and granted a 90-day extension to submit evidence with a due date of February 3, 2021. On January 27, 2021, St. Clair County requested the PTAB grant an additional 60-day extension to review and evaluate material submitted by the appellant and prepare evidence to submit. The board of review asserted they have a heavy workload and a small office staff.

The subject matter of the I-3 appeal is a 167,000 square foot chemical production facility built in 1940 with additions in the 1970’s, 80’s & 90’s. The appellant has

requested an assessment reduction of approximately \$980,000 based on an appraisal.

The St. Clair County Board of Review was notified of the appeal on October 22, 2020 and granted a 90-day extension to submit evidence with a due date of January 20, 2021. On January 27, 2021, St. Clair County requested the PTAB grant an additional 60-day extension to review and evaluate material submitted by the appellant and prepare evidence to submit. The board of review asserted they have a heavy workload and a small office staff.

- f. INEOS: #19-00251-I-3 (Will)

Joint Motion to Extend Board of Review Evidence Deadline

The subject property is a chemical processing and manufacturing facility inclusive of multiple buildings and significant machinery and equipment related to the production of three chemical products. The property has a total assessment of \$15,892,056 and the appellant has requested an assessment of \$6,555,001.

The Will County Board of Review was notified of the appeal on November 12, 2020 and granted a 90-day extension to submit evidence with a due date of February 10, 2021. On January 26, 2021, the appellant and the Will County Board of Review filed a motion jointly requesting the PTAB grant the board of review an additional 60-day extension to file evidence. The parties assert they have been having discussions and inquiries as to what machinery and equipment is included in the County's valuation of the property. The parties are attempting to access the County's personal property valuation records via microfiche and have had issues with the microfiche machine as well as Covid-19, delaying the research. The appellant has no objection to the extension.

The Kane County Board of Review was notified of the appeals on November 12, 2020 and granted a 90-day extension to submit evidence with a due date of February 10, 2021. On February 3, 2021, Kane County requested the PTAB grant an additional extension of time to review and complete evidence for these appeals.

- k. George Olsen: #19-03564-R-1 (McHenry)

The McHenry County Board of Review was notified of the appeal on November 19, 2020 and granted a 90-day extension to submit evidence with a due date of February 17, 2021. On February 5, 2021, the McHenry County Board of Review requested the PTAB grant an additional 60-day extension of time to discuss a possible agreement with the appellant/attorney.

- l. First National Bk of Omaha Tr. No. 1695: #19-01795-C-2 (Kendall)

The Kendall County Board of Review was notified of the appeals on November 12, 2020 and granted a 90-day extension to submit evidence with a due date of February 10, 2021. On February 9, 2021, Kendall County requested the PTAB grant an additional 60-day extension.

The subject property consists of a three-story motel with 15,504 square feet of building area built in 1996 located on a 100,634 square foot site. The appellant submitted an appraisal estimating the real estate has a market value of \$1,085,000. The subject's total assessment reflects a market value of approximately \$1,167,000.

Rainbow Aurora LLC: #19-02368-C-2 (Kane)

The Kane County Board of Review was notified of the appeals on November 19, 2020 and granted a 90-day extension to submit evidence with a due date of February 17, 2021. On February 11, 2021, Kane County requested the PTAB grant an additional extension of time to review and complete evidence for these appeals.

- n. Julian Wen Bee: #19-42495-C-2 (Cook - North Chicago)

Motion to Reinstate

The appellant, through counsel, filed with the PTAB on May 4, 2020 requesting a 30-day extension. On October 29, 2020, the appeal was returned as incomplete and the appellant was given a 30-day extension to complete the filing with a due date of November 28, 2020. Appellant did not respond to the extension and incomplete notification. On January 21, 2021, the PTAB dismissed the appeal and the case was closed. On February 4, 2021, the appellant requested the appeal be reinstated. The appellant's counsel asserted that his office has no record of the PTAB granting an extension. Counsel explained that because of COVID 19, his offices were closed and relocated to another site and perhaps some mail may not have been received. The appellant's attorney asserted that the evidence was ready for filing long ago as the appellant was waiting for PTAB's acknowledgement of the appeal. With the request to reinstate the appellant submitted an appraisal as well as a completed addendum containing the appellant's assessment request. The appellant asserted that for the 2018 tax year he reached a settlement with the board of review in the amount of \$127,000 and would do so again for the 2019 tax year.

- o. Eric Chang: #18-41128-I-1 (Cook - North Chicago)

Motion to Reinstate

The appellant, through counsel, filed with the PTAB on May 29, 2019, marking recent sale as the basis of the appeal. The appellant did not complete Section IV – Recent Sale Data of the appeal but did submit a copy of a settlement statement dated Nov. 15, 2017 disclosing a purchase price of \$120,000. On November 14, 2019, the appeal was returned as incomplete for failure to complete Section IV of the appeal form, which provides information about the transaction. The appellant was given a 30-day extension to complete the filing with a due date of December 14, 2019. The appellant did not respond to the incomplete checklist. On November 12, 2020 the PTAB dismissed the appeal. On December 8, 2020, the appellant requested the appeal be reinstated. With the reinstatement request the appellant provided the completed Section IV, identifying the seller, noting the parties were not related and further indicated the property had been advertised in the open market through the Multiple Listing Service for approximately 1 year. The appellant stated in his reinstatement request that he was not aware that Section IV on the appeal form was not completed. Appellant states he submitted detailed information regarding the sale of the subject property and thought that would suffice. Based on this, the appellant requested the appeal be reinstated.

- p. Renee and Matthew Dietz: #18-05783-R-1 (Kane)

Motion to Reinstate

The appellants filed with the PTAB on July 22, 2020 contesting the assessment for the 2018 tax year. The appellants filed the appeal from a decision of the Property Tax Appeal Board for the 2017 tax year in PTAB Docket No. 17-00457.001-R-1 issued on May 26, 2020 reducing the assessment to \$265,000. The appellants sent in the appeal for 2018 in an envelope postmarked July 22, 2020. The appellants requested the assessment of the property as established by the PTAB for 2017 be carried forward to the 2018 tax year as provided by section 16-185 of the Property Tax Code, subject to equalization. With the submission the appellants included a narrative noting that due to COVID 19 they were not able to file the appeal within 30-days of the PTAB's decision. The appellants asserted that Mr. Dietz's business was mandated to close. They had to sell the home and they had no access to a printer, because even the libraries were closed. The appellants also asserted that they were not able to contact government agencies that they needed to speak to in order to properly address their issues.

On November 5, 2020 the appeal was dismissed due to being untimely filed.

On January 21, 2021 the appellants requested the appeal be reinstated. The appellants again stated they had no access to internet or a printer due to their public library being closed during Covid-19 pandemic. They contend the COVID-19 pandemic impaired their ability to gain access to records and blocked their ability to print the needed materials to submit with the appeal. Appellants would like to have the 2018 property tax assessment adjusted accordingly in order to avoid court proceedings in this matter.

q. Jason Falkinham: #19-06101-R-1 (Lake)

Motion to Reinstate

The appellant, through counsel, filed with the PTAB on April 21, 2020, marking assessment equity as the basis of the appeal. On September 17, 2020, the appeal was returned as incomplete due to not completing sections III (description of property) & V (assessment grid) of the appeal form. Appellant was given a 30-day extension to complete the appeal with a due date of October 17, 2020. On November 16, 2020, appellant sent back the incomplete checklist, which was 30-days late. On December 24, 2020, PTAB dismissed the appeal. On January 8, 2021, appellant filed the Motion to Reinstate but no reason was given for the appeal being filed late.

- r. 115 S. Parkside LLC: #19-37311-R-1 (Cook -West Chicago)

Motion to Reinstate

The appellant, through counsel, filed with the PTAB on March 26, 2020, marking recent sale as the basis of the appeal and requested a 90-day extension to submit evidence. On August 6, 2020, the PTAB granted the appellant a final 60-day extension, which expired on October 5, 2020. On October 5, 2020 the appellant submitted a brief noting that the subject property was purchased in August 2019 for a price of \$162,000 and provided a copy of the settlement statement. The appellant's counsel further asserted the property was vacant during the 2019 tax year and argued that an occupancy factor of 20% be applied the property's improvement assessment. On December 3, 2020 the appeal was returned as incomplete and appellant was given a 30-day extension to complete IV – Recent Sale Data on the appeal form, with a due date of Saturday, January 2, 2021 (which was extended to Monday, January 4, 2021 by operation of rule). On February 4, 2021, the PTAB dismissed the appeal due to the appellant failing to complete Section IV of the appeal as requested by the PTAB. On February 16, 2021, the appellant requested the appeal be reinstated and provided a copy of an appeal petition with Section IV completed, identifying the seller, noting the parties to the transaction were not related, stating the property was sold by auction, the property had not been advertised for sale and the property was sold due to foreclosure.

- s. Willia J Schiestel: #17-21140-R-1 (Cook - Palatine)

Motion to Vacate Judgement

Appellant filed the appeal based on assessment equity on November 29, 2017, using the Cook County Board of Review decision dated November 3, 2017, which established an assessed value of \$26,909. The board of review did not file evidence and was defaulted by the PTAB on July 18, 2019. The PTAB issued a decision on September 15, 2020, reducing the assessment to \$26,431. However, unbeknownst to appellant or attorney, on November 17, 2017, the Cook County Board of Review had granted an assessment reduction via re-review, which lowered the assessment to \$24,746, which is below the assessment as established by the PTAB's decision dated September 15, 2020. On December 20, 2020, the Cook County Treasurer sent the appellant's attorney a bill for an increase based on the PTAB decision. The appellant's counsel then contacted the board of review and discovered that the re-review was not listed on the BOR's online system and was not transmitted to the appellant's attorney until January 4, 2021. Due to the fact the board of review had granted a reduction on the re-review, that the attorney and appellant were unaware

of, the appellant requested that the PTAB's decision/judgement be vacated and the appeal be dismissed.

- t. White Oak Project Company, LLC: #19-03118-C-3 (Lake)

Joint Motion to Stay 2019 Final Administrative Decision to Implement Settlement Agreement

The appellant, through its attorneys, and the Lake County Board of Review, jointly request that the PTAB stay the 2019 Final Administrative Decision until September 1, 2021, in order to implement a multi-year settlement agreement. The parties to the 2019 appeal include the appellant and the board of review, there are no intervening taxing districts. The appellant filed the appeal on April 13, 2020, based on overvaluation, which is supported by an appraisal. On December 28, 2020, the board of review filed a settlement agreement/stipulation executed by both parties resolving the 2019 appeal.

On January 7, 2021, the parties filed the Joint Motion to Stay the decision, explaining that in connection with appellant's 2020 assessment appeal of the same property to the Lake County Board of Review, the parties entered into a multi-year settlement agreement to resolve both the 2019 appeal before the PTAB and the 2020 appeal before the Lake County Board of Review. Under the terms of the settlement agreement, the 2020 assessed value for the subject property was to be revised by the board of review to a mutually agreed upon value. However, due to a clerical error, the final decision of the Lake County Board of Review for the 2020 tax year, received by the Appellant on January 4, 2021, did not reflect the agreed upon value for 2020. Accordingly, a Certificate of Error to implement the agreed upon 2020 value will now be issued by the Lake County Board of Review in the late spring or early summer. Since the multi-year settlement agreement resolved the 2019 appeal at a different value than the 2020 appeal value, the resolution of both years is dependent on the specific settlement value for each individual year. Therefore, because the 2020 value has not yet been implemented in accordance with the settlement agreement, the parties are jointly requesting that the PTAB stay issuing the Final Administrative Decision for the 2019 appeal until after the 2020 Certificate of Error is issued. Therefore, the parties are requesting that the PTAB stay issuance of the 2019 decision until at least September 1, 2021.

This matter was discussed at length during the February 2021 Board meeting. The recommendation was to deny the motion to revive and issue a certified copy of disposition. The basis of that recommendation was that the petitions did comply with PTAB's rules (R. 1910.64) and because this Board lacks authority to revive judgments. The appellants' attorney indicated that he would provide his submissions in other cases and a brief to the Board articulating this Board's authority to issue an order of revival. The Executive Director indicated he would review those submission and any brief submitted by the appellants. If a legal basis for this Board's authority to grant an order of revival was articulated in the brief or prior submissions, the Executive Director indicated he would be open to changing the recommendation. The Executive Director also indicated he would contact the Cook County Treasurer's Office to inquire if that office would accept a certified copy of disposition. To date, appellants' attorney has not submitted any additional filings in these matters. The Executive Director contacted the Cook County Treasurer's Office through her attorney, but no meeting has been scheduled.
