The Kankakee County Board of Review was notified of the appeal on November 19, 2020 and was granted a 90-day extension to submit evidence with a due date of Wednesday, February 17, 2021. By correspondence postmarked February 18, 2021, the Kankakee County Board of Review and the township assessor requested the PTAB grant an additional extension to compile evidence.

The Morgan County Board of Review was notified of the appeal on December 3, 2020 and granted a 90-day extension to submit evidence with a due date of March 3, 2021. On February 25, 2021, the Morgan County Board of Review requested the PTAB grant an additional extension to complete evidence. The property is a Holiday Inn Express – the appellant submitted an appraisal estimating the subject has a market value of \$2,825,000 – the subject’s assessment of \$973,800 reflects a market value of approximately \$2,921,400.

The Kane County Board of Review was notified of the appeals on December 10, 2020 and granted a 90-day extension to submit evidence with a due date of March 10, 2021. Docket No. 19-02186 involves a car wash facility and Docket No. 19-02440 involves a clubhouse at a golf course – the issue is open space valuation.

The St. Clair County Board of Review was notified of the appeals on December 24, 2020 and was granted a 90-day extension to submit evidence with a due date of March 24, 2021. On March 10, 2021, the St. Clair County Board of Review requested the PTAB grant an additional 60-day extension to review and evaluate material submitted by the appellant and to prepare a summation of value. The board of review asserted they have a heavy workload and a small office staff.

The LaSalle County Board of Review was notified of the appeals on December 24, 2020 and was granted a 90-day extension to submit evidence with a due date of March 24, 2021. On March 17, 2021, the LaSalle County Board of Review requested the PTAB grant an additional extension of time to submit evidence.

The subject property is a supportive living facility that was the subject matter of an appeal before the PTAB in Docket No. 13-00178. In that appeal the PTAB issued a decision reducing the assessment. The intervening school district timely filed a complaint for administrative review. On September 20, 2020, the Appellate Court, Third District, issued an opinion in *Manteno Community Unit School Dist. No. 5 v. PTAB*, 2020 IL App (3d) 180384, reversing the decision of the PTAB and reinstating the assessments.

At its meeting of December 11, 2018, for both the 2014 and 2015 appeals the PTAB voted to grant the board of review and the intervenor a final 90-day extension to submit evidence from the date the Appellate Court issued its mandate in the 2013 administrative review matter. On November 5, 2020, the appellate court issued its mandate, therefore, the extension to submit evidence expired on February 3, 2021.

However, at its meeting of December 8, 2020, the PTAB considered the extension requests filed by the intervenor and the board of review on October 22, 2020 and voted to grant each a final 90-day extension. By letters of December 17, 2020, the board of review and intervenor were given a **Final** 90-day extension to submit evidence with a due date of March 17, 2021. On March 16, 2021, Kankakee County Board of Review requested PTAB grant another extension of time for filing of additional evidence. It anticipates joining the Intervenor's evidence.

On March 17, 2021, the Kankakee County Board of Review requested the PTAB grant an extension of time for filing additional evidence. Each appeal is based on overvaluation using a recent sale of the property and comparable sales.

Motion to Vacate Order of Dismissal and for Leave to Amend Appeals

Appellant, through counsel, filed with the PTAB on April 27, 2020 and requested an extension of time to submit evidence. On October 1, 2020, the appeals were

returned as incomplete due to no addendum and section 2C of the form, appellant's assessment requests, not completed, with a due date of Monday, November 2, 2020. On January 14, 2021 the appeals were dismissed as the PTAB had not recorded a receipt to the response to the notice of being incomplete.

On February 16, 2021, the PTAB received from the appellants a Motion to Vacate Order of Dismissal and for Leave to Amend Appeal. In the Motion to Vacate, counsel asserted that on November 2, 2020, he instructed his staff to mail to the PTAB an Amended Residential Appeal form showing the itemized land and building assessed values, as well as the evidence supporting the appeals. With the Motion, Counsel submitted copies of the previous submissions as well as a copy of a Certified Mail Receipt dated November 2, 2020 to the PTAB. However, when the PTAB received the response to incomplete notice on or about November 2, 2020, there were no docket numbers on the front page or an addendum for each file. Appellant's attorney was informed by PTAB that spreadsheets showing comparable sales were received, but that the briefs were omitted and the PTAB could not identify the files to which the evidence belonged.

Appellant requested the PTAB grant leave to file the omitted materials instanter, and that PTAB vacate the order of dismissal and such further relief as the Property Tax Appeal Board deems just and proper.

#### Motion to Vacate Dismissal and for Leave to File Amended Appeal Form

The appellants in each appeal, through counsel (same attorney as in item h), filed with the PTAB on April 27, 2020 requesting an extension to submit evidence. On October 1, 2020, the appeals were returned as incomplete due to the BOR assessments shown on the appeal petitions not matching the assessments shown on the BOR final decision (19-08280) and/or granting a 30-day extension to submit evidence, with a due date of Monday, November 2, 2020. On January 14, 2021, PTAB dismissed the appeals for not submitting any evidence.

On February 12, 2021, the appellants' counsel filed a Motion to Vacate Order of Dismissal and for Leave to file Amended Appeal Form. Counsel asserts that on November 2, 2020, he instructed his staff to mail to the PTAB an Amended Residential Appeal form showing the correct assessed value, as well as the evidence (appraisal) supporting the appeals. Counsel was informed and believed that the materials were sent to the PTAB with materials in 22 PTAB cases in three sets of US Certified Mail. Included with each motion was a copy of the amended appeal petition and the appraisal. In the motion associated with Docket No. 19-08282 counsel included Certified Mail Receipts. Appellant requested the PTAB

to vacate the order of dismissal and to grant Appellant leave to file the Amended Residential Appeal form and evidence.

- j. Ted & Linda Sherman: #19-08055-R-1 (Lake)

Motion to Vacate Order of Dismissal and for Leave to file copy of BOR Decision

Appellants, through counsel (same attorney as in item h & i), filed with the PTAB on April 27, 2020, requesting an extension of time to submit evidence. On October 1, 2020, the appeal was returned as incomplete for the BOR decision was omitted from the original documentation and a 30-day extension was granted with a due date of Monday, November 2, 2020. On January 14, 2021 the appeal was dismissed for failure to submit evidence.

On February 12, 2021, counsel filed a Motion to Vacate Order of Dismissal and for Leave to File Copy of Board of Review decision. Attached to the motion was a copy of the BOR decision and an appraisal. Counsel asserts that on November 2, 2020, he instructed his staff to mail to PTAB a copy of the BOR decision and a cover letter. Counsel was informed and believed that the materials were sent to the PTAB with materials in 22 PTAB cases in three sets of US Certified Mail. Counsel submitted copies of Certified Mail Receipts with the motion. The appellant contends that in the event that the correspondence with the board of review decision was omitted from mailings to the PTAB on November 2, 2020, the PTAB grant leave to file the BOR decision instanter and vacate the dismissal.

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on May 1, 2019 and requested a 90-day extension to submit evidence. The bases of the appeal were marked as recent sale, assessment equity and contention of law. On October 10, 2019, the PTAB granted the appellant a final 60-day extension with a due date of December 9, 2019. On December 9, 2019, the appellant submitted an income approach to value prepared by counsel based on the subject's actual income and expenses for 2016 and 2017. Also submitted was a copy of a settlement statement dated 12/5/15 and reporting a contract price of \$320,800. On March 5, 2020, the appeals were returned as incomplete for failure to complete Section IV – Recent Sale Data. The appellant was given a 30-day extension to complete the filing with a due date of April 4, 2020. On January 14, 2021, the appeals were dismissed due to failure to comply and respond to incomplete checklist. Appellant stated,

because of the Pandemic their office has struggled and hopes that since they have substantially complied that the PTAB would consider reinstating the files.

1. Ellen T. Poulos Trust: #18-35653-C-1 (Cook - Lakeview)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on May 1, 2019 and requested a 90-day extension to submit evidence. The bases of the appeal were marked as contention of law, assessment equity and recent appraisal. On October 10, 2019 the appellant was granted a final 60-day extension with a due date of December 9, 2019. On December 9, 2019, the appellant submitted land uniformity comparables, an income approach to value prepared by counsel using the subject's actual income and expenses from 2015, 2016 and 2017. On March 5, 2020, the appeal was returned as incomplete for failure to complete the grid (section V – equity grid analysis) Comparable Sales or Assessment Equity. The Appellant was given a 30-day extension to complete the filing with a due date of April 4, 2020. On January 14, 2021 the appellant was dismissed for failure to complete the comparable sales and assessment equity grid of the appeal form. On February 17, 2021, the appellant requested the appeal be reinstated. The appellant asserts that there was a misunderstanding about the forms. The appellant thought they did not have to fill it out because the case is not comparing residential properties but just land values. Appellant did provide a Summary of Comparables within the brief in their original filing clearly showing the values of the land. Counsel assert that due to the Pandemic their office has struggled and hopes that since they have substantially complied that the PTAB would consider reinstating the file.

- m. Bryan Banser: #19-47312-C-1 (Cook - Jefferson)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on May 18, 2020 and requested a 90-day extension to submit evidence. The appellant marked, comparable sales, assessment equity, recent appraisal and contention of law as the bases of the appeal. On November 19, 2020, the appellant was granted a **Final** extension with a due date of Monday, December 21, 2020. On December 19, 2021, the appellant requested an additional 90-day extension of time to submit documentation for the complaint “due to recent health concerns.” On January 12, 2021, the PTAB dismissed the appeal. By correspondence postmarked February 17, 2021, the appellant requested that the PTAB reconsider its dismissal decision and reinstate the 2019 PTAB appeal which is based on an appraisal, a copy was submitted. Counsel explained the appraisal was not completed until January 18, 2020 due in part to the Covid-19 Pandemic causing the appellant's auto repair shop to be down substantially this year requiring additional time for the owner to gather funds for

an appraisal and the additional time caused to the appraiser and counsel due to working remotely.

- n. Preserve at Woodfield: #19-49640-C-3 (Cook - Schaumburg)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on May 21, 2020. On December 3, 2020, the appeal was returned as incomplete due to not completing sections 2C, the appellant's assessment request, and Section III (Description of the Property) of the appeal form or evidence to support the appeal. The appellant had marked recent appraisal as the basis of the appeal. The PTAB granted the appellant a 30-day extension to complete the appeal with a due date of Monday, January 4, 2021. On February 11, 2021, the PTAB dismissed the appeal for failure to comply with incomplete checklist and the failure to submit evidence. On March 5, 2021, the appellant requested that the appeal be reinstated asserting that on December 30, 2020, the appellant provided an updated Complaint Form and supporting documentation. Counsel asserts that the evidence was sent by Certified Mail and provided a copy of the Certified Mail Receipt. Counsel changed the basis of the appeal to a contention of law and argued the BOR reduced the assessment of the property but failed to grant the assessment reduction to all the PINs, which are located in two townships.

- o. Kulbir Thukral: #19-07165-R-1 (Lake)

Motion to Reinstate

Appellant filed with the PTAB on April 27, 2020 and requested an extension to submit evidence. The appellant marked comparable sales and assessment equity as the bases of the appeal. The submission included a grid of comparable sales and assessment equity comparables using forms other than on the PTAB's appeal form. On September 24, 2020, the PTAB granted the appellant a final 60-day extension with a due date of November 23, 2020. On January 21, 2021, the PTAB dismissed the appeal due to lack of evidence. On February 22, 2021, the PTAB received the appellant's request to review and reinstate the appeal. The appellant asserts that the reason he requested an extension was to submit an appraisal. He indicated that he had included the appraisal with the local board of review and assumed he did not need to resubmit the appraisal. He explained that he contacted the PTAB on November 19, 2020 to notify the PTAB that he did not intend to file additional evidence. With the reinstatement request the appellant submitted an appraisal prepared for a refinance transaction with an effective date of October 16, 2019 and an estimated value of \$940,000.

#### Motion to Reinstate

Appellants, through counsel Timothy J. McGrath of McGrath & Clark, P.C., 440 S. State St., Manhattan, IL, filed with the PTAB on February 14, 2020. The appellants market assessment equity and comparable sales as the bases of the appeals. The attorney noted on the appeal forms his email address is [mcgrath@mcgrathandclarklaw.com](mailto:mcgrath@mcgrathandclarklaw.com). On June 4, 2020, the appeals were returned as incomplete due in part to the failure to complete Section V of the appeal – the Comparable Sale/Assessment Equity grid of the appeal form. The appellants were given a 30-day extension to submit the completed appeals with a due date of Monday, July 6, 2020. The PTAB did not receive a response and on November 5, 2020, the PTAB dismissed the appeals.

By correspondence postmarked February 25, 2021, appellants' counsel asserts he never received the correspondence due to it going to the wrong email address and requested the appeals be reinstated. He explained that he checked the PTAB's website and discovered the appeals were dismissed and explained he was advised that the attorney information was taken off an appeal filed in 2015. The attorney of record for that appeal was Timothy J. McGrath of the Law Office of Timothy J. McGrath, P.C., P.O. Box 615, 440 S. State St., Manhattan, IL 60442 with an email address of [Mcgrathlaw@sbcglobal.net](mailto:Mcgrathlaw@sbcglobal.net).



Counsel stated that he has been employed by McGrath & Clark, P.C. since 2017 and the appeals filed by the appellants in 2018 and 2019 are under the law firm of McGrath & Clark, P.C., at 440 S. State St., Manhattan, IL 60442 with an email of [mcgrath@mcgrathandclarklaw.com](mailto:mcgrath@mcgrathandclarklaw.com), not the Law Office of Timothy J. McGrath, P.C. at 440 South State Street, P.O. Box 615, Manhattan, IL 60442 with an email of [mcgrathlaw@sbcglobal.net](mailto:mcgrathlaw@sbcglobal.net), which the PTAB has been sending correspondence to. The appeals for those two years should have been opened under McGrath & Clark, P.C., as that is the firm that filed the appeals. (Please note that Attorney Clark is now deceased, the firm, which the appellants will be filing their 2020 appeals under, is McGrath Law, P.C. The correct email has been updated in our PTAB Database.)

- q. Ian Blackburn: #19-08238-C-1 (Lake)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on April 27, 2020 based on a recent sale and comparable sales but only two comparable sales were provided. On October 1, 2020, the appeal was returned as incomplete to provide more documents surrounding the subject's sale and completing section V (Comparable Sales or Assessment Equity) for an additional comparable sale. The appellant was given a 30-day extension to submit evidence. On January 14, 2021, the PTAB dismissed the appeal due to insufficient evidence. On February 1, 2021, the appellant requested the appeal be reinstated. Appellant asserts that the PTAB's online record states that the appellant's counsel's office was provided a letter to amend the filing on October 1, 2020. Counsel asserts that in discussing this with PTAB staff, it was confirmed that an e-mail was sent to the attorney's office but not opened. He contends that he cannot find an email from the PTAB on 10/1/20. Counsel also submitted a copy of a Lake County BOR decision for the 2020 tax year reducing the assessment of the subject property to \$16,665. Therefore, the appellant request that the appeal for 2019 be reinstated. With the motion the appellant provided additional documentation surrounding the subject's September 2017 purchase.

- r. Garrett Popcorn Shop: #19-49633-C-1 (Cook - Jefferson)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on May 21, 2020, requesting and extension of time to submit evidence. On December 3, 2020, the appeal was returned as incomplete due to section 2C, the appellant's requested land, improvement and total assessment not being completed and was granted a 30-day extension to complete the filing with a due date of Monday, January 4, 2021. Appellant did not respond to the incomplete checklist and on March 11, 2021, the

PTAB dismissed the appeal. On March 11, 2021, the appellant requested the appeal be reinstated based on the evidence was submitted prior to the deadline. Counsel asserts that on December 30, 2020, the appellant's attorney's office mailed by Certified Mail, through the U.S. Postal Service, an updated complaint form, and supporting documentation which included a full narrative Appraisal. Counsel provided a copy of the Certified Mail Receipt to support his statement. The appellant request that Docket# 19-49633 be reinstated, and the evidence attached to the motion (an appraisal) be accepted as the supporting documentation for this case.

- s. John Eleftherakis: #17-05019-R-1 (McHenry)

Motion to Reinstate

Appellant, through counsel, filed with the PTAB on March 30, 2018 and requested a 90-day extension to submit evidence. On August 30, 2018, the PTAB granted the appellant a final 90-day extension to submit evidence which expired on Wednesday, November 28, 2018. On April 11, 2019, the appeal was dismissed.

By letter postmarked December 22, 2020, appellant's counsel submitted a request to reinstate the 2017 appeal and carry the assessment as established by the PTAB in Docket No. 16-06497 forward to the 2017 tax year subject to equalization. The 2016 decision was issued by the PTAB on May 21, 2019. Appellant's counsel is aware this appeal fell through the cracks due to so many "rollover requests" during 2016-2018 tax years.

Motion to Stay

Appellant filed with the PTAB on December 20, 2019. A stipulation dated March 5, 2020 was signed by the appellant and the BOR reducing the assessment to \$501,400. On March 1, 2021, the appellant requested the PTAB delay issuing any decision on this appeal for 60-days contending there is a pending Cook County Certificate of Error for 2019 that should resolve this matter. The 2019 Certificate of Error results in a revised 2019 assessed value of \$501,400, which is the same assessed value that the Appellant and the Cook County Board of Review stipulated to for the 2019 appeal pending at PTAB. Once the appellant receives notification that the 2019 Certificate of Error has been fully processed, the appellant will withdraw the 2019 PTAB appeal.

Motion to Stay Proceedings

The taxpayer and intervening Community Consolidated School District #15 have tentatively agreed on a withdrawal of the 2019 PTAB matter once the 2020 and 2021 assessments are certified by the Board of Review at an assessment of \$1,212,500. The County Board of Review and intervening school district evidence deadline is approaching in this matter. The appellant and school district contend that it is not in anyone's interest that the County and school district be required to expend resources and submit evidence on a matter that will in all likelihood settle. The taxpayer and school district request this letter serve as a Joint Motion to extend the Intervenor and County Board of Review's evidence filing deadline and stay any deadlines in this matter until the 2021 assessment for the subject property is finalized. They contend that no prejudice will result from the entry of the requested extension and it appears to be in the PTAB's interest of administrative economy and stated preference of resolving cases by stipulation.

#### Notice of Petitions to Revive Judgement

Taxpayers' attorney will be presenting Petitions to Revive Judgment in the above matters. The Notice has been served on the prior counsel. Mr. Natarajan has also submitted copies of the engagement agreement with Natarajan Worstell LLC (counsel), letter from appellant notifying the PTAB of hiring of Kensington Research & Recovery, Inc. to recover overpayments and requesting the PTAB to recognize Natarajan Worstell LLC/Ram Natarajan as counsel to revive judgment, and a letter from the appellant to prior counsel terminating representation in each appeal.

These petitions are carried over from the February and March 2021 meetings.

This matter was discussed at length during the February 2021 Board meeting. The recommendation was to deny the motion to revive and issue a certified copy of disposition. The basis of that recommendation was that the petitions did

comply with PTAB's rules (R. 1910.64) and because this Board lacks authority to revive judgments. The appellants' attorney indicated that he would provide his submissions in other cases and a brief to the Board articulating this Board's authority to issue an order of revival. The Executive Director indicated he would review those submission and any brief submitted by the appellants. If a legal basis for this Board's authority to grant an order of revival was articulated in the brief or prior submissions, the Executive Director indicated he would be open to changing the recommendation. The Executive Director also indicated he would contact the Cook County Treasurer's Office to inquire if that office would accept a certified copy of disposition. To date, appellants' attorney has not submitted any additional filings in these matters. The Executive Director contacted the Cook County Treasurer's Office through her attorney, but no meeting has been scheduled.

Prior to the March meeting, the Petitioners' attorney contacted PTAB and requested a date because of a medical emergency which prevented him from submitting his briefs and supporting documentation. A continuance was granted and on March 24<sup>th</sup> an email was sent to the Petitioners' attorney reminding him to file his briefs and supporting documentation. PTAB has not received any filings from the petitioners' attorney as of April 6, 2021.
