The Jersey County Board of Review was notified of the appeals on December 24, 2020, and was granted a 90-day extension to submit evidence with a due date of March 24, 2021. On March 18, 2021, the Jersey County BOR requested the PTAB grant an additional extension to submit evidence. The board of review asserts that it and the appellant have been in contact and are trying to negotiate a stipulated assessment in each appeal.

The Tazewell County Board of Review was notified of the appeal on February 18, 2021, and was granted a 90-day extension to submit evidence with a due date of May 19, 2021. The Henry County Board of Review was notified of the appeals on February 4, 2021, and was granted a 90-day extension to submit evidence with a due date of May 5, 2021. On April 8, 2021, the Henry County BOR requested the PTAB grant an additional 90-day extension to prepare evidence. The BOR asserts that the current office workload, such as tax bills and assessor work, contributes to the need for an extension.

The Champaign County Board of Review was notified of the appeals on January 14, 2021, and was granted a 90-day extension to submit evidence with a due date of April 14, 2021. On April 12, 2021, the Champaign County BOR requested the PTAB grant an additional 60-day extension to submit evidence in each appeal. A board of review member stated that he started his time on board of review last month and needs an extension of time to answer the PTAB appeals.

- i. Nancy Durbin: #19-09458-R-1 (Sangamon)

Motion to Reinstate

Appellant filed with the PTAB on Monday, June 22, 2020, from a Sangamon County 2019 Assessment Notice dated May 22, 2020, increasing the assessment from \$40,547 to \$40,746 by the application of an equalization factor. The appellant marked comparable sales and recent construction as the basis for the appeal. On November 19, 2020, the appeal was returned as incomplete due to the appellant not completing the appellant's assessment request in Section 2-C, Section III the description of the property, Section V the comparable sale grid, and Section VI recent construction costs of the appeal form. The appellant was given a 30-day extension to complete the appeal with a due date of December 19, 2020. The appellant did not respond to the incomplete checklist, and on January 21, 2021, the PTAB dismissed the appeal. On April 14, 2021, the appellant requested the appeal

be reinstated, contending her home has been reassessed to the correct Non-farm Market Value of \$93,519. The appellant submitted a copy of the Sangamon County 2020 Assessment Notice dated March 26, 2021, reducing the assessment from \$40,746 to \$31,173. Appellant requests that the Board refund their overpayment for their tax bill based on the current 2020 assessment.

Motion to Reinstate

On March 25, 2021, the PTAB dismissed each of the above appeals for being untimely filed. Each appeal contains a cover letter dated December 17, 2020, from the appellant's counsel asserting the appeals were originally filed on April 25, 2020. However, a tracking document submitted by the appellant indicates the package (containing the appeals) had arrived at the USPS Regional Facility in Carol Stream at 10:50 PM on April 30, 2020, and picked up at 8:44 AM on May 4, 2020, in Springfield. The appellant also submitted a letter, dated April 25, 2020, requesting a 90-day extension to submit evidence, a commercial appeal form signed and dated April 25, 2020, and a copy of a board of review decision dated March 27, 2020, further indicating the filing deadline with the PTAB was Monday, April 27, 2020. The appellant also submitted a U.S. Postal Service Certified Mail Receipt copy, which is not signed.

On April 7, 2021, the appellant's counsel requested that the appeals be reinstated. With the request, counsel attached an affidavit from Michael Flannery, an employee of the law firm, attesting that on April 25, 2020, he filed with the PTAB a cover letter and appeal form in each appeal by depositing the same via the U.S. Postal Service Certified mail at the Post Office located at 1240 N. Ashland, Chicago, IL. The affiant stated that on December 17, 2020, not having received confirmation from PTAB for the original filings, the appellant resubmitted the appeals. Also included with each appeal is evidence.

The PTAB has no record of receipt of the appeals in April or May 2020.

- k. Padma Rao: #19-20668-R-1 (Cook - Evanston)

Motion to Reinstate

Appellant filed with the PTAB on November 20, 2019. On February 13, 2020, the appeal was returned as incomplete. The appellant did not provide any comparable sales to support the overvaluation argument. The appellant was given a 30-day extension with a due date of March 14, 2020, to complete the appeal. On March 9, 2020, the appellant requested an extension to submit evidence. On June 11, 2020, the appellant was granted a Final 60-day extension with a due date of Monday, August 10, 2020. On August 11, 2020, the appellant requested an extension to submit evidence and allow additional time due to the Covid-19 pandemic shutdown. On October 1, 2020, the appellant was granted a “Final” 30-day extension with a due date of October 31, 2020. On November 4, 2020, the PTAB received another extension request from the appellant with another extension contending due to the inability to gather the necessary evidence due to the Covid-19 shutdowns. On December 24, 2020, the appellant was granted a “Final” 30-day extension with a due date of January 23, 2021. On January 21, 2021, the appellant requested another extension. On March 9, 2021, the Board voted to deny the appellant a further extension of time to submit evidence. The appeal was dismissed for not providing sufficient evidence to challenge the assessment. On April 8, 2021, the appellant requested the appeal be reinstated, he be granted additional time beyond all coronavirus pandemic restrictions and limitations, and he be granted an in-person hearing after all coronavirus pandemic restrictions and limitations have ceased. Attached to the request is a copy of a notice from the Cook County Assessor informing the appellant that the application of a COVID Adjustment reduced the 2020 assessment of the property.

1. Daniel Fajerstein: #15-22078-C-1 (Cook - Evanston)

Motion to Vacate Final Administrative Decision

On September 17, 2019, the PTAB issued a decision establishing a total assessment of the property of \$20,000 based on a stipulation of the parties. On April 9, 2021, the appellant filed a Motion to Vacate the PTAB's decision issued on September 17, 2019, and Withdraw the Appeal.

The appellant explained that based on a request for the issuance of a Certificate of Error for 2015, the Cook County Assessor's Office had issued a Certificate of Error that changed the property's classification from 5-7 (Commercial) to 2-12 (Residential Mixed Use), resulting in a reduction of the assessment level from 25% to 10%. As a result, the Cook County Treasurer's Office issued a refund to the appellant on December 19, 2017, because of the change in classification.

Due to an internal docketing error, the appellant's counsel also filed an appeal for the 2015 tax year with PTAB on January 25, 2016, alleging that the subject

property was over-assessed for the tax year of 2015 based on a recent purchase of the subject property by Petitioner.

On September 17, 2019, PTAB issued its Final Administrative Decision in this matter, based on an agreement between the Petitioner and the Cook County Board of Review, “correcting” the assessed valuation to \$20,000.

The unintended result of the 2015 PTAB settlement agreement is that the appellant would no longer be eligible to receive the refund due to the Certificate of Error for the tax year 2015 and would be required to repay the funds to the County.

According to the appellant, Illinois law prohibits the filing of both a Certificate of Error with the Assessor and an assessment appeal before the PTAB for the same tax year. Petitioner's counsel should not have filed the PTAB appeal, and the 2015 PTAB appeal and decision should be voided. For these reasons, the appellant requested that the PTAB’s Final Administrative Decision be vacated and the appeal be dismissed.

- m. Elwood Energy LLC: #19-00356-I-3 (Will)

Motion to Issue a Subpoena

The subject property consists of two non-contiguous land parcels containing approximately 71 acres. The property has a total of nine (9) General Electric 7FA, 160 MW, simple cycle natural gas turbines put in operation in 1999 and 2001 used to produce electricity. Other improvements include a Spare Parts Building, two Guard Booths, two Storage Warehouses, and an Operations & Maintenance Building. The property also has machinery and equipment used in conjunction with the production of electricity. The subject property is used as a peaking power plant.

Elwood Community Consolidated School Dist. No 203, and Laraway Comm. Consolidated School Dist. 70-C and Joliet Twp. High School Dist. No. 204 filed their Requests to Intervene on September 9, 2020 and September 16, 2020, respectively. On October 8, 2020, the PTAB granted each Intervenor a 90-day extension to submit evidence with a due date of January 6, 2021.

On January 4, 2021, Elwood Community Consolidated School Dist. No 203 requested a 90-day extension to submit evidence. Counsel asserted that as of that date, he had no confirmation of the intervention. On January 22, 2021, the PTAB granted Elwood Community Consolidated School Dist. No 203 a Final 90-day extension with a due date of April 22, 2021.

On January 5, 2021, Joliet Twp. High School Dist. No. 204 requested an extension on time to submit evidence. On January 15, 2021, the PTAB granted Joliet Twp. High School Dist. No. 204 a final 60-day extension with a due date of March 16, 2021.

On March 18, 2021, the PTAB issued a letter to Laraway Comm. Consolidated School Dist. 70-C, finding it in default for the failure to submit evidence.

On March 15, 2021, Joliet Twp. High School Dist. No. 204, and Laraway Comm. Consolidated School Dist. 70-C filed a request for an extension of time to submit evidence. They assert that they have hired an appraiser and requested documents from the owner to complete the appraisal. However, the owner has not voluntarily complied, and they are preparing a subpoena request. On March 18, 2021, the PTAB granted Joliet Twp. High School Dist. No. 204, a 60-day extension to expire on May 17, 2021.

On March 23, 2021, the intervening school districts filed a Motion to Compel the PTAB issue a Subpoena to the appellant, Elwood Energy, LLC. The motion includes an affidavit from appraiser Mark Simzyk of Duff & Phelps, retained by the taxing districts, asserting he needs certain information to prepare an appraisal. In summary, the intervenors have requested a subpoena for the following records:

1. Detailed financial operating statements for 2014 through 2018.
2. Forward merchant power and gas price curves and expected dispatch capacity factors, revenue, and fuel expenses for the subject property.
3. Status/details of any type of contract which provides additional revenue.
4. A detailed forecast of future budgeted capital expenditures with a brief description of each project as of January 1, 2019.
5. Copy of any appraisals on the Elwood Energy Generating Station for any purpose since 2017.

Elwood Energy LLC submitted a Response in Opposition to Intervenors' Motion to Compel PTAB Issue a Subpoena to the Appellant. The appellant, Elwood Energy, asserts it has been in Jackson Township in Will County for approximately twenty years. There have been no significant modifications to the asset during that time, and the property tax liability has been steady until it suddenly more than doubled in 2019, resulting in the doubling of Elwood Energy's property tax liability.

The taxpayer asserts that the Intervenors' Motion to issue a Subpoena highlights many of the issues that have arisen with the 2019 assessment of the subject property. The issues mentioned by the taxpayer included the attempted valuation

of personal property, the inappropriate consideration of manufacturing equipment & machinery as real property, and the attempted consideration of going concern value (including intangible assets). These factors may be relevant if the Intervenor's intend to purchase the entire company but are irrelevant for purposes of real property valuation. The appellant argues that the Intervenor's affiant focuses on machinery & equipment valuation instead of real property, which explains the attempt to push into this area. The owner contends such an approach is contrary to law and established Will County precedent. The taxpayer argues that the Intervenor's attempt to find a path to make Elwood Energy's overall business valuation the same as the valuation of its real property should be denied. The owner asserts that real property does not consume gas, consider future commodity pricing, and sell power; it is only one supporting piece of that process.

The owner further explained that the Intervenor's valuation consultant, Duff & Phelps (which also performed the 2019 valuation of the plant on behalf of the Will County Supervisor of Assessments Office and testified on behalf of the County before the Will County Board of Review), has twice been hosted at the subject property for site visits, once in the fall of 2019 and most recently on November 20, 2020. After each of those visits, Duff & Phelps was offered the opportunity to submit follow-up information requests. However, it was not until January 29, 2021, that the requests at issue were transmitted.

The owner contends that after the receipt of Elwood Energy's detailed responses, provided on or before February 26, 2021, which included all relevant materials such as: (1) survey and legal descriptions; (2) a complete recently prepared appraisal, including a fixed asset listing and extensive supporting material; (3) foundation and other drawings; (4) photographs and overhead pictures; (5) generation statistics; (6) information regarding environmental site conditions; and (7) information regarding construction activity, Intervenor's did not attempt a follow up regarding why certain material was or was not provided prior to filing this Motion.

The owner further asserts that in ruling on a subpoena request, the Board shall consider the reasonableness of the demand and whether the requested documents are relevant and necessary to derive an estimate of the value of the real property under appeal. The appellant contends the information sought by the Intervenor's is neither reasonable, relevant, or necessary, and the Motion should be denied as it fails to meet the applicable test established in 86 Ill. Admin. Code 1910.68(a).

- n. 401 North Wabash Venture, LLC: #11-24443 (Cook)

Motion to Stay Further Action on the Appeal Until the OEIG Completes Its Investigation and Releases its Findings.

A hearing in this matter was held in 2017. It is an appeal of the tax year 2011 assessment. After the hearing, a complaint was filed with the Office of Executive Inspector General (OEIG), which opened an investigation into the matter. The Board, upon learning of the investigation, postponed calling this matter for a decision. In March 2021, the Board voted to move forward with this matter. The Cook County Board of Review now comes before this Board asking that this Board stay the matter pending the OEIG investigation, or in the alternative, order a new hearing.
