- a. Dika Windmill Lakes LLC: #19-02398-C-2 (Kane)

The Kane County Board of Review (BOR) was notified of the appeal on January 28, 2021 and was granted a 90-day extension to submit evidence with a due date of April 28, 2021. On April 22, 2021, the BOR requested the PTAB grant an additional extension of time to review and complete evidence.

The Woodford County Board of Review was notified of the appeal on January 28, 2021 and was granted a 90-day extension to submit evidence with a due date of April 28, 2021. On April 20, 2021, the BOR requested the PTAB grant a 60-day extension of time to submit evidence.

- c. DSI Manteno Owner, LLC: #20-00319-C-3 (Kankakee)

The Kankakee County Board of Review was notified of the appeal on January 21, 2021 and was granted a 90-day extension to submit evidence with a due date of April 21, 2021. On April 21, 2021, the BOR requested the PTAB grant an extension of time for filing of additional evidence. The subject property is a Supportive Living Facility. The appellant has requested an assessment reduction of approximately \$778,000.

- d. Steve & Laura Michelini: #19-09241-F-1 (LaSalle)  
Steve & Laura Michelini: #19-09296-F-1 (LaSalle)

The LaSalle County Board of Review was notified of the appeal on February 4, 2021 and was granted a 90-day extension to submit evidence with a due date of May 5, 2021. On May 3, 2021, the BOR requested the PTAB grant an additional 60-day extension to review and complete evidence.

- e. Alex Deligiannis: #19-09462-C-1 (Kane)

The Kane County Board of Review was notified of the appeal on February 11, 2021 and was granted a 90-day extension to submit evidence with a due date of May 12, 2021. On May 6, 2021 the BOR requested the PTAB grant an additional extension of time to review and complete evidence.

- f. JP Morgan Chase Bank NA: #19-01298-C-1 (Winnebago)

The Winnebago County Board of Review was notified of the appeal on June 4, 2020 and was granted a 90-day extension to submit evidence with a due date of September 2, 2020. On July 7, 2020, Winnebago County submitted the "Board of Review Notes on Appeals," and a one paragraph narrative critiquing the sales contained in the appellant's appraisal. The paragraph further states, "The BOR is relying on the TA's evidence to prove that the assessed value is fair & reasonable." However, no additional evidence was submitted.

On February 18, 2021, the PTAB forwarded the BOR's submission to the appellant's counsel and granted a 30-day rebuttal period. Counsel responded on March 18, 2021 requesting the PTAB enter an Order granting the appellant's appeal based on the MAI appraisal valuing the subject at \$270,000. Counsel noted that the BOR stated it will rely on the township assessor's evidence, however, either the evidence was not filed or not included with the PTAB's notice. The PTAB forwarded the appellant's correspondence to the BOR by letter dated April 29, 2021.

On April 30, 2021, the BOR responded by letter to the PTAB asserting the BOR may have inadvertently included a copy of the appellant's petition and evidence in the original Board of Review Notes on Appeal submission, instead of a copy of the township assessor's evidence. The BOR enclosed a copy of the township assessor's evidence, which was referenced in the original Notes on Appeal and requested that the PTAB accept this submission of township assessor's evidence.

- g. Pearl Enterprises Land Trust: #19-01402-C-3 (Peoria)

#### Motion for Leave to File Evidence Instanter

Dunlap Community Unit School District #323 intervened in the appeal on January 26, 2021 and requested an extension of time to submit evidence. On February 4, 2021, the PTAB granted the intervenor 90-day extension to submit evidence with a due date of Wednesday, May 5, 2021. On Friday, May 7, 2021, the Intervenor filed the Motion for Leave to File Evidence Instanter along with a copy of an appraisal prepared by Kristina K. Clore of LKG Valuation Services, Inc. The appraisal has a letter of transmittal date of May 4, 2021. The Intervenor's counsel explained that on May 4, 2021, he received the appraisal by e-mail. He further noted that the deadline for filing of evidence in this appeal was May 5, 2021. He asserts that due to inadvertence, the appraisal was not filed prior to May 5, 2021. Counsel contends the filing of the appraisal within a few days after May 5, 2021 will not cause any delay in the hearing of this appeal, nor will it result in any prejudice to any of the other parties to this appeal. Counsel served a copy of the appraisal by mail on the appellant's attorney and the Peoria County Board of Review on May 7, 2021.

The subject property consists of a one-story retail building with 38,221 square feet of building area that was constructed in 1986 and is located on a 4.42-acre site.

The subject property has an assessment of \$630,720 reflecting a market value of approximately \$1,892,350. The appellant has requested the assessment be reduce

to \$291,670 to reflect a market value of approximately \$875,100. The intervenors' appraiser arrived at an estimated market value of \$1,775,000.

- h. 401 North Wabash Venture LLC: #15-40159-R-3 (Cook - North Chicago)  
401 North Wabash Venture LLC: #15-40160-R-3 (Cook - North Chicago)

Appellant's Motion to Disqualify the Intervenor, to Bar Additional Evidence, to Appoint an Independent Hearing Officer, and to schedule a Hearing Within 60-days.

On April 26, 2021 the PTAB received Appellant's Motion to Disqualify the Intervenor, to Bar Additional Evidence, to Appoint an Independent Hearing Officer, and to schedule a Hearing within 60-days. Appellant is requesting the PTAB schedule a formal hearing on this motion, Disqualify the Intervenor as the time for the Intervention has expired years prior, Bar any additional evidentiary submissions as evidence has been closed since October 23, 2019. Appoint an independent hearing officer/counsel as PTAB has demonstrated a bias in appeals related to this building. Appellant also would like a hearing date within 60-days to avoid further delay to the homeowners/ Appellant's which still will result in a hearing taking place more than one year after the original hearing date (March 19, 2020) was improperly cancelled on PTAB's own motion and not timely rescheduled.

On May 13, 2021, the intervenor's attorney submitted a "Brief in Opposition to Appellant's Motion to Disqualify the Intervenor, Bar Additional Evidence, Appoint an Independent Hearing Officer, & Schedule a Hearing within 60 Days." The intervenor asks that the PTAB deny the motions to disqualify the intervenor and bar the intervenor's ability to submit evidence. The intervenor was not notified, by the Board of Review, of the appeal until October 6, 2020. The intervenor filed a Request to Intervene on November 18, 2020.

- i. David M. and Mary K. Wellman: #19-09539-R-1 (Adams)  
David M. & Mark. K Wellman: #20-06792-R-1 (Adams)

Motion to Reinstate

On November 17, 2020, the PTAB issued a decision involving the subject property in Docket No. 18-00689.001-R-1, reducing the assessment to \$188,500. On or about March 19, 2021, the appellants filed the 2019 and 2020 appeals with the PTAB from the decision lowering the assessment for the 2018 tax year. By letters dated April 22, 2021 and April 29, 2021 the PTAB dismissed the appeals due to

being untimely filed in that neither was filed within the 30-day time frame from the issuance of the PTAB's decision for the 2018 tax year.

Appellant's counsel argues that the notice of the 2018 decision has not been properly given. Counsel contends the PTAB's service of the decision does not comply with section 16-185 of the Property Tax Code, which provides in part:

The final administrative decision of the Property Tax Appeal Board shall be deemed served on a party when a copy of the decision is: (1) deposited in the United States Mail, in a sealed package, with postage prepaid, addressed to that party at the address listed for that party in the pleadings; except that, if the party is represented by an attorney, the notice shall go to the attorney at the address listed in the pleadings; or (2) sent electronically to the party at the e-mail addresses provided for that party in the pleadings. The Property Tax Appeal Board shall allow each party to designate one or more individuals to receive electronic correspondence on behalf of that party and shall allow each party to change, add, or remove designees selected by that party during the proceedings. Decisions and all electronic correspondence shall be directed to each individual so designated.

The attorney contends the Code does not allow for the substitution of the attorney for the party when the decision is served by electronic means. Counsel argues that the plain language of the statute does not provide for the electronic service of the decision on the attorney in place of the party in subsection (2) as the statute provides for in subsection (1) when the decision is sent by mail. Counsel asserts that neither the Wellmans (the party) or the attorney received a copy of the decision via United States Mail.

Additionally, Wellmans did not receive a copy of the decision electronically even though the Wellmans provided an e-mail address in the pleadings. Counsel contends that since the statute states "addresses" when serving the decision by e-mail, both the attorney and the Wellmans should have been served a copy of the decision electronically. Counsel contends that service on the attorney only via electronic means is only proper where the attorney's email address is the only email address provided in the pleadings.

Counsel also references the PTAB's website which provides that a petition must be filed within 30-days of ... the postmark date of the decision of the PTAB lowering the assessment.

Counsel contends that with the service requirements in mind, the decision has not been properly served and, thus, the 30-day appeal period has not yet begun. Considering the 30-day appeal period has not yet begun (and, thus, has not expired), the PTAB continues to have jurisdiction over the appeal in the above referenced dockets. Appellants requested reinstatement of the appeals for the 2019 and 2020 tax years

- j. Kianoosh Jafari: #16-24155-R-1 (Cook - Barrington)

Motion to Vacate PTAB decision & withdraw appeal.

The PTAB issued a decision in the above matter on March 16, 2021, based on a stipulation of the parties establishing an assessment of \$120,000. On April 30, 2021, the appellant, through counsel, requested the PTAB's decision be withdrawn. Counsel asserted the 2016 PTAB decision is in conflict with a 2016 Certificate of Error issued by the Cook County Assessor. The appellant submitted a copy a letter dated April 21, 2021, from the Cook County Treasurer indicating that the PTAB's decision increased the assessed value of the property and an open item bill will be mailed.

- k. William Grant: #16-23209-R-1 (Cook - New Trier)

Appellant through counsel filed a Motion to Reinstate

The PTAB issued a decision in the above matter on March 16, 2021, based on a stipulation of the parties establishing an assessment for PIN 05-08-321-043-0000 of \$118,859 and an assessment for PIN 05-08-400-036-0000 of \$181,141. On April 30, 2021, the appellant, through counsel, file the above entitled motion stating in part:

[T]he Appellant . . . moves this honorable Board to allow vacation and withdrawal of the March 16, 2021 stipulated assessment on the parcel to lower the assessment on the parcel for the above entitled cause.

Wherefore, . . . the Appellant, requests this honorable Board to enter an order to allow the vacation and withdrawal of the 2016 Docket in the above entitled cause.

The appellant's counsel did not provide any other basis for the request.

- l. Rodny Penner: #16-27456-R-1 (Cook - Lakeview)

Motion to Reinstate

The PTAB issued a decision in the above matter on March 16, 2021, based on a stipulation of the parties establishing an assessment of \$119,125. On April 30, 2021, the appellant, through counsel, file the above entitled motion stating in part:

[T]he Appellant . . . moves this honorable Board to allow vacation and withdrawal of the March 16, 2021 stipulated assessment on the parcel to lower the assessment on the parcel for the above entitled cause.

Wherefore, . . . the Appellant, requests this honorable Board to enter an order to allow the vacation and withdrawal of the 2016 Docket in the above entitled cause.

The appellant's counsel did not provide any other basis for the request.

- m. 401 North Wabash Venture, LLC: #11-24443 (Cook)

CCBOR Motion to Stay Further Action on the Appeal Until the OEIG Completes Its Investigation and Releases its Findings.

A hearing in this matter was held in 2017. It is an appeal of the tax year 2011 assessment. After the hearing, a complaint was filed with the Office of Executive Inspector General (OEIG), which opened an investigation into the matter. The Board, upon learning of the investigation, postponed calling this matter for a vote. In March 2021, the Board voted to move forward with this matter. The Cook County Board of Review now moves the PTAB stay the matter pending the duration of the OEIG investigation, or in the alternative, order a new hearing.

- a. Standing Order on Pre-Hearing Conferences and Continuances. As we approach a 100,000-case backlog, the staff is working on implementing procedures to bring cases to hearing at a much faster rate. As part of this effort, the Executive Director is asking the Board to issue a standing order to fully advise the parties that appear before PTAB that the rules regarding pre-hearing conferences and continuances of hearings will be strictly enforced.
  
- b. 401 North Wabash Venture, LLC: #11-24443 (Cook) – Final Decision

Discussion: 401 North Wabash Venture, LLC., the appellant, timely filed an appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160), challenging the assessment for the 2011 tax year. The property under appeal is only a portion of a 92-story mixed use building located in the City of Chicago. The appellant contends that the subject property's market value is not accurately reflected in its assessed valuation. This matter went to hearing in December 2017. The Board delayed issuing a decision in this matter. The current Executive Director recommended the Board move forward with issuing a decision in this matter as to not delay justice. The Board instructed the current Executive Director to conduct an independent review of this matter which has been completed.
