The Kane County Board of Review was notified of the appeals on February 18, 2021, and was granted a 90-day extension to submit evidence with a due date of May 19, 2021. On May 12, 2021, the Kane County Board of Review requested the PTAB grant an additional extension of time to review and complete evidence to file for these appeals.

The Kane County Board of Review was notified of the appeals on February 25, 2021, and was granted a 90-day extension to submit evidence with a due date of May 26, 2021. On May 20, 2021, the Kane County Board of Review requested the PTAB grant an additional extension of time to review and complete evidence to file for these appeals.

Counsel asserted the parties to this appeal are currently completing settlement negotiations involving the 2019 appeal and potential 2020 and 2021 appeals. He also indicated the Counsel in the firm that was representing the taxing district resigned on March 5, 2021. The Intervenor has had a 180-days extension.

On July 16, 2020, the PTAB granted New Trier H.S.D. #203 a 90-day extension to submit evidence with a due date of October 14, 2020. On October 13, 2020, the Intervenor requested an additional 90-day extension to determine an appropriate response, including the need for the Intervenor to obtain an appraisal of the subject property. On January 22, 2021, the Intervenor was granted a **Final 90-day extension** with a due date of April 22, 2021. On April 21, 2021, the Intervenor requested an additional 60-day extension. Counsel asserted the parties to this appeal are currently completing settlement negotiations involving the 2019 appeal and potential 2020 and 2021 appeals. On January 22, 2021, the Intervenor was granted a **Final 90-day extension** with a due date of April 22, 2021. On April 21, 2021, the Intervenor requested an additional 60-day extension. Counsel asserted the parties to this appeal are currently completing settlement negotiations involving the 2019 appeal and potential 2020 and 2021 appeals. On July 16, 2020, the PTAB granted New Trier H.S.D. #203 and Glencoe School District #34 a 90-day extension to submit evidence with a due date of October 14, 2020. On October 13, 2020, the Intervenor requested an additional 90-day extension to determine an appropriate response, including the need for the Intervenor to obtain an appraisal of the subject property. On January 22, 2021, the Intervenor was granted a **Final 90-day extension** with a due date of April 22, 2021. On April 21, 2021, the Intervenor requested an additional 60-day extension. Counsel asserted the parties to this appeal are currently completing settlement negotiations involving the 2019 appeal and potential 2020 and 2021 appeals. He also indicated the Counsel in the firm that was representing the taxing district resigned on March 5, 2021. Attached to the request was an email from the Appellant's attorney asserting he has no objection to a further extension of time. The Intervenor has had 180 days in extension.

r. Northfield Storage Properties LLC: #19-25886-I-1 (Cook - New Trier)

New Trier H.S.D. #203 and Avoca S.D. #37 file their Requests to Intervene on September 23, 2020. On November 5, 2020, the Intervenor was granted a 90-day extension to submit evidence with a due date of February 3, 2021. On February 3, 2021, the Intervenor requested an additional 90-day extension to determine whether there is a need for the Intervenor to obtain an appraisal of the subject property or whether the matter can be resolved by settlement. On March 4, 2021, the Intervenor was granted a Final 90-day extension with a due date of June 2, 2021. On June 2, 2021, the Intervenor requested an additional 90-day extension to file evidence or Brief. This matter involves a single self-storage property that is located on two separate PINS in two different Cook County townships. Due to the different townships, the PTAB processed these matters as two separate appeals (2019-25886 and 2019-38139). On April 29, 2021, the Taxing Bodies submitted an Agreed Motion to Consolidate requesting the consolidation of PTAB Docket #2019-25886 and 2019-38139 because they both involve the same property. As of this date, PTAB has not yet processed the request to consolidate these appeals. The intervenors requested an additional 90-day extension to file evidence or a brief.

s. Butera Center Management Inc: #19-02850-C-2 (Lake)

On October 5, 2020, Kildeer County C.C.S.D. #96 and Stevenson H.S.D. #125 each filed their Request to Intervene. On October 22, 2020, Kildeer County C.C.S.D. #96 and Stevenson H.S.D. #125 were each granted a 90-day extension to submit evidence with a due date of January 20, 2021. On January 19, 2021 the Intervenor requested an additional 90-day extension to determine whether there is a need for the Intervenor to obtain an appraisal of the subject property or whether the matter can be resolved by settlement. On February 4, 2021, the Intervenor was granted a Final 90-day extension with a due date of May 5, 2021. On May 5, 2021, the Intervenor requested an additional 60-day extension. Counsel asserted the taxing bodies are analyzing the file and preparing evidence, and anticipating settlement negotiations to resolve the 2019 appeal and potential 2020 -2022 appeals. He also indicated the Counsel in the firm that was representing the taxing districts resigned on March 5, 2021. Intervenor has had 180 days in extension.

t. Walgreens: #19-03396-C-3 (DuPage)

On September 28, 2020, Addison Fire Protection, Addison Park District, Addison Public Library, Addison S.D. #4, DuPage School Dist. #88 and Village of Addison each filed a Request to Intervene. On October 22, 2020, the intervenors were granted a 90-day extension to submit evidence with a due date of January 20, 2021. On January 19, 2021, the Intervenor requested an additional 90-day extension as they were currently in the process of analyzing the taxpayer's evidence to determine whether there is a need for the Intervenor to obtain an appraisal of the subject property or whether the matter can be resolved by settlement. On February 4, 2021, the Intervenor was granted a **Final 90-day extension** with a due date of May 5, 2021. On May 4, 2021, the Intervenor requested an additional 60-day extension, contending the taxing bodies are currently analyzing the file and preparing evidence for filing, as well as anticipating settlement negotiations to resolve this 2019 appeal and potential 2020-2022 assessment disputes concerning the property that is the subject of this case. Counsel also indicated the previous Counsel in the firm that was representing the taxing districts resigned on March 5, 2021. Intervenor has had 180 days in extension.

u. California Gardens Associates: #18-45849-C-3 (Cook - West Chicago)

Motion Request to Intervene

The Appellant filed the appeal on June 6, 2019, and on January 9, 2020, was granted an extension to submit evidence due on March 9, 2020. On March 5, 2020, the Appellant through Counsel, Lena Henderson, filed its evidence consisting of an appraisal. *(Please note that Lena Henderson is deceased (3/15/21), and no*

attorney has entered an appearance on behalf of the Appellant.) The Cook County BOR was notified of the appeal on August 6, 2020. The BOR filed its Certificate indicating the taxing districts were notified of the appeal on September 2, 2020. Sixty days to intervene (1910.60(d)(1)(A)) expired on Monday, November 2, 2020.

On June 9, 2021, the City of Chicago filed its Requested to Intervene. The City of Chicago contends it never received actual notice from the Cook County Board of Review despite the fact the Appellant is requesting an assessment reduction in excess of \$100,000, and the City is listed on the 2018 tax bill.

The City of Chicago asserts that after receiving notice of the 2019 PTAB appeal for the subject property, the City engaged in an additional investigation regarding the appeal history for this property and discovered the existence of the 2018 appeal for the subject property. The City then contacted the Cook County Board of Review to determine why the City never received formal notice of this appeal from the Board of Review. The City then promptly filed this Request to Intervene in the 2018 appeal. Attached to the Motion are affidavits from Richard G. Danaher, Chief Assistant Corp. Counsel, and Mark Roschen, Assistant Commissioner for the Department of Planning and Development for the City of Chicago, contending they did not receive notice of the appeal. Danaher asserted that if he had received notice of the 2018 appeal, he would have filed a written request to intervene.

The City requests the PTAB grant its Request to Intervene.

v. Boreas LLC: #19-02289-C-3 (Kane)

Intervenor's Motion to Dismiss Absent Evidence of Timely Request to File Single Petition Pursuant to PTAB Rule 1910.30

On March 12, 2020, the Appellant filed the above-referenced appeal from decisions issued by the Kane County Board of Review. The appeal involves 39 scattered homes within Kane County. The Appellant asserted the homes are used as low-income housing subject to a Regulatory and Operating Agreement. In support of the overvaluation argument, the Appellant submitted an appraisal prepared by an Illinois Certified General Appraiser identifying the property as being commonly known as Fox Prairie Homes, with all the homes being located in Aurora, 39 homes in Kane County, and one home in DuPage County. Using the income capitalization approach, the appraiser arrived at an estimated market value for the property of \$2,950,000.

On July 31, 2020, the Kane County BOR notified the taxing districts of the appeal. On September 2, 2020, the City of Aurora, East Aurora School Dist. No. 131, and West Aurora School Dist. No. 129 each filed a Request to Intervene. On October

15, 2020, the PTAB granted the Intervenors a 90-day extension to submit evidence expiring on January 13, 2021. On January 13, 2021, the Intervenors filed a request for a 90-day extension of time to submit evidence acknowledging the appeal involves 38 (sic) distinct properties. On February 4, 2021, the PTAB granted the Intervenors a final 90-day extension expiring on May 5, 2021.

On May 4, 2021, the Intervenors filed a *Motion to Dismiss Absent Evidence of Timely Request to File a Single Petition Pursuant to PTAB Rule 1910.30*.

The Intervenors assert the Appellant has filed a single petition appealing the assessed value of 39 separate, non-contiguous parcels located all over the City of Aurora, for parcels spanning two different school districts and acknowledged the Appellant's evidence in this appeal considers and values an additional parcel in another county, for a total of 40 separate, non-contiguous parcels.

The Intervenors argue PTAB rule 1910.30 requires that a petition for appeal "shall be on the prescribed form and a separate petition must be filed for each separately assessed parcel except for contiguous single-owner parcels that constitute a single property and except for condominium buildings or unless a written request is made to the Board for the filing of a single petition for multiple parcels." 86 Ill. Admin. Code 1910.30. The Intervenors assert that in this appeal, only a single petition was filed, the parcels are not contiguous, and there was no request made by the Appellant to file a single petition for multiple parcels. They assert that based upon PTAB's online docket and the documents provided to the Intervenors, this mandatory prerequisite was disregarded by the Appellant and the appeal should be dismissed.

In the Motion the Intervenors also contend that the Appellant filed 39 separate appeals with the Kane County Board of Review for the 2019 tax year and further provided a brief critique of the appraisal submitted by the Appellant. For these reasons, the Intervenors requested the PTAB dismiss the appeal filed by the Appellant in this docket.

In the alternative, if the PTAB does not dismiss the above-captioned appeal, the Intervenors request the PTAB:

1. Require the Appellant to file: (a) competent appraisal to support a market value for each non-contiguous parcel, (b) the Regulatory and Operating Agreement, the Extended Use Agreement, development agreement, property management documents, and other documentation referred to by Appellant and its appraisers in the Brief of Taxpayer and Renzi & Associates appraisal; and

2. Grant the Intervenors 90-days from the date of receipt of those filings, or the PTAB's determination of this Motion, whichever is later, to file additional evidence or argument in its case-in-chief.

The Appellant did not respond to the Motion.

- w. Robert Shannon: #20-06716-R-1 (McHenry)

Motion to Reinstate

Appellant filed an appeal for the 2020 tax year in an envelope postmarked March 12, 2020. The appeal was filed from a favorable decision issued by the PTAB in Docket No. 19-02543 on January 19, 2021. The Appellant had 30 days from the date of the PTAB's decision to file a direct appeal with this Board, which expired on Thursday, February 18, 2021. By letter dated April 22, 2021, the appeal was dismissed for being untimely (the appeal was filed 20 days late). By letter dated April 28, 2021, the Appellant contends that due to Covid concerns, he was unable to mail the appeal in the allowed time frame. The Appellant is asking for reconsideration to grant the appeal. This property is an owner-occupied residence.

- x. Shinna Prabhu: #17-29789-R-1 (Cook - Elk Grove)

Motion to Vacate the decision and Motion to Withdraw the appeal

On May 18, 2021, the PTAB issued a decision establishing a total assessment of the property of \$23,793 based on a stipulation signed by the Appellant's attorney and the Cook County BOR. On May 27, 2021, the Appellant filed a Motion to Vacate the PTAB's decision requesting that the decision entered May 18, 2021, be vacated or nullified and that the appeal be withdrawn.

The Appellant's attorney explained that the 2017 stipulation was done in conjunction with the 2016 appeal (16-28878), which was up for hearing and was stipulated to the same value. The Appellant's attorney failed to notice that the stipulated for 2017 value was an assessment of \$528 greater than the 2017 Board of Review decision on the matter. It was never the taxpayer's intention to agree to increase the assessment with the stipulation. Accordingly, the taxpayer requests a nullification or vacation of the order.

A copy of the 2017 BOR decision disclosed it had reduced the assessment from \$25,413 to \$23,265.

The Appellant did not serve a copy of the Motion on the board of review.

- y. Scott Goldberg: #17-44798-R-1 (Cook - New Trier)
Nipesh Patel: #18-49523-R-1 (Cook - Palatine)

Motion to Amend Decision

Appellant, Noah J. Schmidt, through his attorneys, requests the PTAB to amend its final administrative decisions for Docket Nos. 17-44798 and 18-49523.

In Docket No. 17-44789, the PTAB issued a decision on May 18, 2021, resulting in a total assessment of \$199,739 based on a "rollover" of the decision issued in 2016 tax year. The BOR had submitted its "Notes on Appeal," indicating that it would stipulate to a revised assessment of \$199,739 based on a rollover of the 2016 decision of the PTAB. This decision increased the assessment of the property by \$2,825. Counsel asserts that unbeknownst to him, the Appellant had hired other Counsel for 2017, and he had no authority to file an appeal for the 2017 tax year. Counsel requests the PTAB issue an amended decision to correct the 2017 assessment to reflect a no change in the assessment.

In Docket No. 18-49523, the PTAB issued a decision on May 18, 2021, resulting in a total assessment of \$77,990 based on a "rollover" of the decision issued in 2017 tax year. The BOR had submitted its "Notes on Appeal," indicating that it would stipulate to a revised assessment of \$77,990 based on a rollover of the 2017 decision of the PTAB in Docket No. 17-20512. This decision actually increased the assessment of the property by \$609. Counsel asserts that unbeknownst to him, the Appellant had hired other Counsel for 2018, and he had no authority to file an appeal for the 2018 tax year. Counsel requests the PTAB issue an amended decision to correct the 2018 assessment to reflect a no change in the assessment.

The Appellant did not serve a copy of the motions on the board of review.

- z. Dennis J. Guest: #08-29234-C-1 (Cook - Rich)

Motion to Revive Judgment

On November 22, 2013, the Board entered a decision in favor of the Appellant, Dennis J. Guest, and against the Cook County Board of Review, reducing the

assessed value of the subject property from \$163,429 to \$77,520 for the 2008 tax year.

Due to an attorney lien placed on the Subject Property on November 25, 2013, by Fitzgerald Law Group, P.C. ("Fitzgerald Law"), the Appellant was prevented from receiving the refund from the decision entered by the PTAB.

The PTAB's decision/judgment expired in November of 2020.

The Appellant faced years of failed negotiations with Fitzgerald Law and could not resolve the debt until January 2021, when the parties agreed to arbitration.

An arbitration occurred after the expiration of the judgment.

Arbitration was successful, and the parties came to a settlement agreement, and on January 25, 2021, Fitzgerald Law released the attorney lien against Guest in its full 100% satisfaction.

That until the attorney lien was released, Guest had been precluded from seeking a refund from the Cook County Treasurer's Office.

As of this date, Cook County Treasurer's Office has made no refund of the resulting property tax overpayment to the Appellant.

The Appellant requests the PTAB issue an Order reviving its decision issued on November 22, 2013, to allow him to receive his refund.

Appellant's Motion to Disqualify the Intervenor, to Bar Additional Evidence, to Appoint an Independent Hearing Officer, and to schedule a Hearing Within 60-days.

On April 26, 2021, the PTAB received Appellant's Motion to Disqualify the Intervenor, to Bar Additional Evidence, to Appoint an Independent Hearing Officer, and to schedule a Hearing within 60-days. Appellant is requesting

1. PTAB schedule a formal hearing on this Motion.
2. Disqualify the Intervenor as the time for the Intervention has expired years prior.

3. Bar any additional evidentiary submissions as evidence has been closed since October 23, 2019.
4. Appoint an independent hearing officer/counsel as PTAB has demonstrated a bias in appeals related to this building.
5. Appellant also would like a hearing date within 60-days to avoid further delay to the homeowners/Appellants. This will still result in a hearing taking place more than one year after the original hearing date (March 19, 2020) was improperly canceled on PTAB's Motion and not timely rescheduled.

On May 13, 2021, the Intervenor's attorney submitted a "Brief in Opposition to Appellant's Motion to Disqualify the Intervenor, Bar Additional Evidence, Appoint an Independent Hearing Officer, & Schedule a Hearing within 60 Days." The Intervenor asks that the PTAB deny the motions to disqualify the Intervenor and bar the Intervenor's ability to submit evidence. The Intervenor was not notified, by the Board of Review, of the appeal until October 6, 2020. The Intervenor filed a Request to Intervene on November 18, 2020.

bb. INEOS: #20-04809-I-3 (Will)

The Appellant timely filed the appeal on February 2, 2021, from a final decision of the Will County Board of Review establishing a total assessment for the subject property of \$15,892,000 and requested a 60-day extension of time to submit evidence. On March 25, 2021, the PTAB granted the Appellant a final 60-day extension with a due date of May 24, 2021. On May 21, 2021, the Appellant, the Will County Board of Review, Troy C.C.S.D. #30-C and Minooka H.S.D. 111 (potential intervenors) filed a *Joint Motion to Extend Appellant's Evidence Deadline*. They explained the subject property is a chemical processing and manufacturing facility with significant machinery and equipment (M & E). The Appellant, BOR, and school districts are engaged in discussions and a determination as to what M & E is included in the valuation of the property by the County. The parties met on May 13, 2021, to review documentation including that related to M & E, and toured the premises. They also noted the property includes significant amounts of pollution control equipment assessed by the Illinois Dept. of Revenue, which needs to be excluded from the Appellant's valuation analysis. Additionally, the County's original personal property records could only be accessed via microfiche, but the machine has encountered numerous issues delaying the parties' research on M & E classification and valuation.

The BOR and school districts have no objection to the extension, and the parties have agreed to continue to work together to resolve the complex valuation issues. The Appellant, BOR, and school districts agree that an additional 60-day extension will help secure a fair determination of the valuation issues.
