 - a. Walgreens: #20-01073-C-3 (Massac)

The Massac County Board of Review (BOR) was notified of the appeal on April 26, 2021. It was granted a 90-day extension to submit evidence with a due date of July 25, 2021. On June 9, 2021, the Massac County Board of Review requested the PTAB grant an additional 90-day extension to submit evidence because they

and the Massac County State's Attorney requested the assistance of the law firm of Giffin, Winning, Cohen & Bodewes, PC, and is in the process of securing an appraisal.

b. SC Decatur Property LLC: #20-05782-C-3 (Macon)

The Macon County Board of Review was notified of the appeal on April 8, 2021. It was granted a 90-day extension to submit evidence with a due date of July 7, 2021. On June 14, 2021, the Macon County Board of Review requested a second 90-day extension to obtain an appraisal review for the subject property. The subject property is improved with a 164-unit/bed skilled nursing and independent living facility.

c. Aperion Care Spring Valley: #20-06763-C-3 (Bureau)

The Bureau County Board of Review was notified of the appeal on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On June 15, 2021, the Bureau County Board of Review requested the PTAB grant an additional 60-day extension to submit evidence. The board of review indicated that it and the Bureau County State's Attorney had requested the assistance of the law firm of Giffin, Winning, Cohen & Bodewes, PC, and is in the process of securing an appraisal. The subject property is a 98-bed skilled nursing facility.

d. 3490 Humbert Road, LLC: #20-00412-C-2 (Madison)

The Madison County Board of Review was notified of the appeal on April 1, 2021. It was granted a 90-day extension to submit evidence with a due date of June 30, 2021. On June 16, 2021, the Madison County Board of Review requested the PTAB grant a 90-day extension to gather evidence. The subject property is a one-story, 180-bed nursing home with 57,492 square feet of building area. The appeal is based on the purchase price of the property.

e. Kin, Inc.: #20-05930-C-3 (Kane)

The Kane County Board of Review was notified of the appeal on April 8, 2021. It was granted a 90-day extension to submit evidence with a due date of July 7, 2021. On July 6, 2021, the Kane County Board of Review requested the PTAB grant an additional extension of time to review and complete evidence to file for this appeal.

The property consists of a one-story single-occupant commercial retail building with 86,584 square feet operating as a Kohl's.

- f. 1st Federal Savings and Loan: #20-06010-C-2 (St. Clair)
1st Federal Savings Bank MASCO: #20-06011-C-1 (St. Clair)

The St. Clair County Board of Review was notified of the appeals on April 8, 2021. It was granted a 90-day extension to submit evidence with a due date of July 7, 2021. On July 7, 2021, the St. Clair County Board of Review requested the PTAB grant a 60-day extension to submit evidence for these appeals due to a heavy workload and small staff.

- g. Commerce Bank: #20-05830-C-1 (Peoria)
Commerce Bank (Northpoint CC 3117): #20-05831-C-1 (Peoria)
Walgreens: #20-06128-C-2 (Peoria)

The Peoria County Board of Review was notified of the appeals on April 8, 2021. It was granted a 90-day extension to submit evidence with a due date of July 7, 2021. On July 7, 2021, the Peoria County Board of Review requested a 90-day extension to gather sufficient documentation to defend these appeals.

- h. John P. and Cynthia Hassiepen: #20-06829-R-1 (Knox)

The Knox County Board of Review was notified of the appeal on April 29, 2021. It was granted a 90-day extension to submit evidence with a due date of July 28, 2021. On July 9, 2021, the Knox County Board of Review requested a 60-day extension to submit its evidence. The BOR explained that it was having trouble getting an appraiser to appraise the property. The BOR further explained that its primary contact to assist in getting evidence together had been hospitalized in an induced coma. The BOR has been unable to get to his files. The appellants have submitted an appraisal and requested an assessment reduction of \$15,285.

- i. MOC Realty LLC: #20-06233-C-3 (Peoria)

The Peoria County Board of Review was notified of the appeal on April 15, 2021. It was granted a 90-day extension to submit evidence with a due date of July 14, 2021. On July 9, 2021, the Peoria County Board of Review requested the PTAB

grant a 90-day extension. The Board of Review asserted it is currently working with the Appellant and the Intervenor for a resolution.

- j. Knoxville Pointe Owner LLC: #20-06529-C-3 (Peoria)
Briar Group Limited Partnership: #20-06662-C-2 (Peoria)

The Peoria County Board of Review was notified of the appeals on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On July 9, 2021, the Peoria County Board of Review filed a request for a 90-day extension to obtain evidence. The Board of Review asserts that it's working with the Appellant and the Intervenor to try and reach a resolution.

- k. Steven Svestka: #20-04198-R-2 (Kane)
View St. Charles: #20-04906-C-3 (Kane)

The Kane County Board of Review was notified of the appeals on April 15, 2021. It was granted a 90-day extension to submit evidence with a due date of July 14, 2021. On July 9, 2021, the Kane County Board of Review requested the PTAB grant an additional extension of time to review and complete evidence to file for these appeals. Docket No. 20-04198 involves a single-family dwelling in poor condition – the Appellant has submitted an appraisal. Docket No. 20-04906 is improved with a 160-unit apartment complex composed of 20 two-story buildings located on a 476,133 square foot site – the Appellant submitted an appraisal.

- l. Petersen Companies LLC: #20-06683-C-1 (Mason)

The Mason County Board of Review was notified of the appeal on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On July 12, 2021, the Mason County Board of Review requested the PTAB grant an additional extension of time to submit evidence regarding this appeal.

- m. Von Maur: #20-06434-C-3 (Macon)

The Macon County Board of Review (BOR) was notified of the appeal on April 15, 2021. It was granted a 90-day extension to submit evidence with a due date of July 14, 2021. On July 13, 2021, the BOR requested a 60-day extension to file its evidence until September 29, 2021. The BOR indicated that it and the Macon County State's Attorney requested the assistance of the law firm of Giffin, Winning, Cohen & Bodewes, PC. The BOR asserted that the Intervenor's evidence

is due on September 29. The BOR retained counsel has been in communication with the Intervenor's attorney and the Appellant's attorney discussing settlement possibilities.

- n. First Midwest Bank: #20-06675-C-2 (DeKalb)
Joan Tripp / Greenfeather LLC: #20-06779-R-1 (DeKalb)

The DeKalb County Board of Review was notified of the appeals on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On July 19, 2021, the DeKalb County Board of Review requested a 90-day extension to gather evidence.

- o. Momence Meadows Nursing & Rehabilitation: #20-00162-C-3 (Kankakee)

The Kankakee County Board of Review was notified of the appeal on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On July 19, 2021, the Kankakee County Board of Review requested an extension for filing additional evidence. The BOR asserted it was working with the township assessor and taxing districts to compile its evidence. The property is improved with a 140-bed skilled nursing facility.

- p. Roger Broders: #20-06768-C-2 (McHenry)

The McHenry County Board of Review was notified of the appeal on April 22, 2021. It was granted a 90-day extension to submit evidence with a due date of July 21, 2021. On July 19, 2021, the McHenry County Board of Review requested a 60-day extension to discuss an agreement with the appellant/attorney. The property is improved with a nine-building, 466-unit self-storage facility.

- q. Walgreens: #19-03394-C-3 (DuPage)

On October 19, 2020, Fenton Community High School District #100, Itasca Community Library, Itasca Park District, Wood Dale Fire Protection District, and Wood Dale School District #7 requested to Intervene, and on November 12, 2020, were granted a 90-day extension to submit evidence with a due date of February 10, 2021. On February 10, 2021, the Intervenor's requested an additional 90-day extension to determine whether there is a need for the Intervenor's to obtain an appraisal of the Subject Property or whether the matter can be resolved by settlement. On March 11, 2021, the PTAB granted the Intervenor's an additional

90-day Final extension with a due date of June 9, 2021. On June 9, 2021, the Intervenor requested another 90-day extension to file evidence asserting they are in consultation with appraiser Dale Kleszynski to prepare an appraisal of the property subject to this appeal. However, due to unforeseen circumstances, Mr. Kleszynski has not yet completed his report. Attached to the request was a letter from Mr. Kleszynski dated June 8, 2021, asserting that he needs to have his left shoulder replaced and requested 90-days to complete the assignment.

r. Mr. David's Carpet Service: #19-04397-I-2 (DuPage)

Itasca Fire Protection District, Itasca Community Library, Itasca Park District, Itasca Park School District #10, and Lake Park High School District #108 requested to Intervene, and on November 12, 2020, were granted a 90-day extension to submit evidence with a due date of February 10, 2021. On February 10, 2021, the Intervenor requested an additional 90-day extension to determine whether there is a need for the Intervenor to obtain an appraisal of the subject property or whether the matter can be resolved by settlement. However, due to unforeseen circumstances, the Intervenor had not yet completed their analysis. On March 11, 2021, the PTAB granted the Intervenor an additional 90-day Final extension with a due date of June 9, 2021. On June 9, 2021, the Intervenor requested another 90-day extension to file evidence. The Intervenor asserts they are currently analyzing the file and preparing evidence in preparation for filing.

Additionally, the Intervenor is anticipating settlement negotiations to resolve this 2019 appeal and potential 2020-2022 assessment disputes concerning the subject property. The settlement negotiations and evidence on this file were previously handled by the Intervenor's attorney, Jessica L. Knox. However, Ms. Knox recently resigned from the firm, effective March 5, 2021. Due to Ms. Knox's departure, the parties have not yet completed their analysis of the evidence, compilation of the districts' evidence for filing, or settlement negotiations. If this matter should fail to settle, the Intervenor intends to obtain an appraisal for this property, which can be completed within 60-days. The BOR has filed evidence in the appeal and requested an increase in the assessment.

s. Bill White: #17-33491-R-1 (Cook - Lyons)
Maria Sourbis: #17-33492-R-1 (Cook - Stickney)
Waclaw Pazdziora: #17-33496-R-1 (Cook - Lyons)

Motion to Reinstate

The appellants' attorney filed these appeals with the PTAB on March 23, 2018, and requested a 90-day extension to submit evidence. On August 16, 2018, the

PTAB granted the appellants a Final 90-day extension to submit evidence. That extension expired on November 14, 2018. The PTAB did not receive a response from the appellants to the Final extension due date of November 14, 2018, and the PTAB dismissed the appeals by letter dated March 14, 2019.

By e-mail dated July 12, 2021, counsel submitted a Motion to Reinstate the appeals contending that the attorney had prepared and timely mailed all evidence to the PTAB on November 5, 2018, through the United States Postal Service (USPS) located in Park Ridge, Illinois 60068. However, by some error beyond counsel or the Appellants' control, the evidence was not received, and the appeals were, therefore, dismissed. As evidence of the timely submission, Appellants included a scanned copy of the original evidence along with a copy of the USPS receipt dated November 5, 2018.

- t. Kenneth & Francis Young: #20-31273-R-3 (Cook - Worth)

Motion to Reinstate

Appellants filed an appeal with PTAB on April 19, 2021. There was no assessment decision notice attached. The CCBOR issued decisions for Worth Township on February 8, 2021, and the transmittal date for Worth Township was March 12, 2021. Included with the appellants' appeal was a copy of an e-mail dated April 14, 2021, from the BOR to the Appellant which asserted that the BOR did not receive the Appellant's mail until after Worth Township was certified. This means that the BOR could not add or adjust any values to Worth Township for the 2020 appeal session. Manuel also stated that the office was working remotely, and no one was in the office to sign for certified mail. It appears the Appellant's correspondence has been in transit since October. The e-mail further indicated that an analyst had reviewed the appellants' documents and determined the evidence would have been insufficient to grant an assessment reduction.

On June 17, 2021, the PTAB dismissed the appeal due to being untimely filed. On June 22, 2021, the Appellant requested the appeal be reinstated. Appellant states the appeal was sent to Cook County Board of Review in a timely manner, that it was sent within two weeks of the first notice, and some things are beyond their control. The appeal was mailed to the BOR on 10-28-2020, certified mail. The appellant states it took the USPS over five months to deliver it; therefore, the Cook County Board of Appeal declared it late.

- u. David Bashore: #20-07655-R-1 (St. Clair)

Motion to Reinstate

Appellant filed the appeal with PTAB in an envelope postmarked, Monday, April 12, 2021. A copy of the BOR decision submitted with the appeal was dated March 10, 2021. Thirty days from March 10, 2021, expired on Friday, April 9, 2021. On June 17, 2021, the PTAB dismissed the appeal due to being untimely filed.

On June 23, 2021, the Appellant requested that the appeal be reinstated. Appellant feels that his appeal application was filed in a timely fashion. The Appellant explained that he originally dealt with the St. Clair County Tax Appeal Board as per the process for appeal. Per the appeal process, the Appellant was supposed to be able to go into the Court House and meet with the Board to discuss his appeal. However, Appellant was advised that due to COVID-19, he would instead have an appeal by phone. An appeal by phone was scheduled for October 6, 2020. On that day, Ms. Angie Roewe (member of the Board of St. Clair County) telephoned him. She advised that he would not have an appeal on the phone this day. She advised that his case would be reviewed and that he would receive a final decision in March 2021, when the "Notice of Final Decision on Assessed Value by Board of Review" cards were to be mailed. Appellant then asked Ms. Roewe when Appellant could file with Springfield if he were turned down by St. Clair County. Ms. Roewe advised that Appellant had 30 days to file with Springfield after receiving the County's final decision card in March. The Appellant later called Ms. Roewe again (twice), just to reconfirm her advice to him. She once again advised that Appellant had 30 days after receipt of this card.

On April 12, 2021, the Appellants' wife called Springfield to confirm the mailing address for his appeal. During the conversation, the Appellant's wife was told that Appellant had missed the deadline. Appellants' wife explained the information given to the Appellant by Ms. Roewe. It was suggested that Appellant contact St. Clair County. The wife called St. Clair County and spoke with Ms. Andrea Johnson. Ms. Johnson could not offer any help, saying that they needed to talk to Ms. Roewe, who was not in the office and did not know when she would be back. Appellants' wife left a voice mail for Ms. Roewe letting her know that Appellant needed her assistance with the appeal because she had given incorrect information.

The Appellant further stated that the BOR decision card is dated March 10, 2021. The Appellant did not receive this card until March 15, 2021. Per our local post office, either the card was not sent out on that date by St. Clair County, or the mail service was delayed due to COVID-19. According to Springfield's requirements appellant states, he was forty-eight (48) hours late. Appellant mailed his appeal on April 12, 2021, and PTAB's requirements were to receive by April 10, 2021. The

Appellant feels that a further review is warranted because of the delays encountered along the way, including acquiring the required data, mail delays and processing, and the COVID-19 impact during this period. He asserted that even the United States Government had extended many deadlines by several months as a result of COVID-19.

v. Tate and Lyle Americas LLC: #18-24313-C-3 (Cook - Barrington)

Motion to Amend Decision

On May 18, 2021, the PTAB issued a decision in the above matter based on a stipulation dated September 24, 2019, reducing the assessment from \$2,690,442 to a total assessment of \$2,075,000.

On July 19, 2021, Community Unit School Dist. 300, the Intervenor, filed a Motion to Amend Decision. The school district asserts that:

1. On May 11, 2021, the Illinois Property Tax Appeal Board approved a stipulation in the above-captioned matter.
2. At this time, the parties were renegotiating the assessment of the subject property for 2018. They were unaware that the original stipulation had been sent downstate for approval by the Board.
3. The parties have since finished their negotiations, and all have signed a new stipulation that increases the 2018 assessment of the subject property, which is attached hereto.

There is no objection, and all parties have signed the new stipulation. Community Unit School District 300 requests that the Board amend their previous decision by submitting the assessment figures as set forth in the revised stipulation for that previously decided on by the Board.

Attached to the Motion was a revised stipulation dated June 21, 2021, signed by all the parties totaling \$2,420,700.

w. Nicole Huber: #18-03317-R-1 (Will)

Motion to Reinstate

Appellant, through counsel Timothy J. McGrath of McGrath & Clark, P.C., 440 S. State St., Manhattan, IL, filed with the PTAB on February 8, 2019. The appellants market assessment equity and comparable sales as the basis of the appeal. The attorney noted on the appeal forms that his e-mail address is

mcgrath@mcgrathandclarklaw.com. On June 20, 2019, the appeals were returned as incomplete due, in part, to the failure to complete Section V of the appeal – the Comparable Sale/Assessment Equity grid of the appeal form. The appellants were given a 30-day extension to submit the completed appeals with a due date of Monday, July 20, 2019. The PTAB did not receive a response, and on November 7, 2019, the PTAB dismissed the appeal.

By correspondence postmarked July 16, 2021, Appellants' counsel asserts he never received the correspondence due to it going to the wrong e-mail address and requested the appeal be reinstated. He explained that he checked the PTAB's website and discovered the appeal was dismissed and explained he was advised that the attorney information was taken off an appeal filed in 2015. The attorney of record for that appeal was Timothy J. McGrath of the Law Office of Timothy J. McGrath, P.C., P.O. Box 615, 440 S. State St., Manhattan, IL 60442 with an e-mail address of Mcgrathlaw@sbcglobal.net.

Counsel stated that he had been employed by McGrath & Clark, P.C. since 2017, and the appeals filed by the appellants in 2018 and 2019 are under the law firm of McGrath & Clark, P.C., at 440 S. State St., Manhattan, IL 60442 with an e-mail of mcgrath@mcgrathandclarklaw.com, not the Law Office of Timothy J. McGrath, P.C. at 440 South State Street, P.O. Box 615, Manhattan, IL 60442 with an e-mail of mcgrathlaw@sbcglobal.net, which the PTAB has been sending correspondence to. The appeals for those two years should have been opened under McGrath & Clark, P.C., as the firm filed the appeals. (Please note that Attorney Clark is now deceased. The firm, which the appellants will be filing their 2020 appeals, is McGrath Law, P.C. The correct e-mail has been updated in our PTAB Database.)

Motion to Reinstate

Appellant filed with the PTAB on June 17, 2021. On July 8, 2021 appellant's appeals were dismissed due to being untimely filed. On July 8, 2021, PTAB received an e-mail request to reinstate the 2020 appeals listed above from Ronald E. Kingsley. Counsel asserted that on January 27, 2021, his colleague, Mitch Furllett, took five boxes of 2020 appeals to the Wheeling, Illinois post office for shipment to PTAB with signature required (Lake County Appeal had previously mailed to the PTAB two other boxes containing 2020 appeals.) Between February 2 and 9, 2021, the PTAB picked up all five boxes from the U.S. Post office. Moreover, on February 10, 2021, Jacqui Rekesius confirmed by e-mail that PTAB had received all five boxes.

In early June 2021, it came to counsel's attention that not all appeals sent to the PTAB had been logged into the PTAB's system. Appellant's colleague, Jill Odzer, immediately began communicating with Jacqui Rekesius, Dan House, and Dave Suarez at PTAB to resolve the issue. The culmination of the conversations was the Motion sent to PTAB on June 17. (A copy of the Motion is in the file.) All appeals sent to the PTAB on June 17 included the dated PTAB forms indicating that they were completed by staff before the submission deadline.

Counsel asserts that the denial of the request would be devastating to Lake County Appeal and its clients, who rely on the PTAB for judicial fairness.

- y. California Gardens Associates: #18-45849-C-3 (Cook - West Chicago)

Motion Request to Intervene

The Appellant filed the appeal on June 6, 2019, and on January 9, 2020, was granted an extension to submit evidence due on March 9, 2020. On March 5, 2020, the Appellant through Counsel, Lena Henderson, filed its evidence consisting of an appraisal. (*Please note that Lena Henderson is deceased (3/15/21), and Daniel Pappano entered his appearance on behalf of the Appellant on July 21, 2021.*) The Cook County BOR was notified of the appeal on August 6, 2020. The BOR filed its Certificate indicating the taxing districts were notified of the appeal on September 2, 2020. Sixty days to Intervene (1910.60(d)(1)(A)) expired on Monday, November 2, 2020.

On June 9, 2021, the City of Chicago filed its Requested to Intervene. The City of Chicago contends it never received actual notice from the Cook County Board of Review even though the Appellant requested an assessment reduction over \$100,000. Chicago is listed on the 2018 tax bill.

The City of Chicago asserts that after receiving notice of the 2019 PTAB appeal for the subject property, the City engaged in an additional investigation regarding the appeal history for this property and discovered the existence of the 2018 appeal for the subject property. The City then contacted the Cook County Board of Review to determine why the City never received formal notice of this appeal from the Board of Review. The City then promptly filed this Request to Intervene in the 2018 appeal. Attached to the Motion are affidavits from Richard G. Danaher, Chief Assistant Corp. Counsel, and Mark Roschen, Assistant Commissioner for the Department of Planning and Development for the City of Chicago, contending they did not receive notice of the appeal. Danaher asserted that if he had received notice of the 2018 appeal, he would have filed a written request to intervene.

The City requests the PTAB grant its Request to Intervene.

- z. Shinna Prabhu: #17-29789-R-1 (Cook - Elk Grove)

Motion to Vacate the Decision and Motion to Withdraw the appeal

On May 18, 2021, the PTAB issued a decision establishing a total assessment of \$23,793 based on a stipulation signed by the Appellant's attorney and the Cook County BOR. On May 27, 2021, the Appellant filed a Motion to Vacate that Decision and withdrawn the appeal. The Appellant's attorney explained that the 2017 stipulation was done in conjunction with the 2016 appeal (16-28878), which

was up for hearing and stipulated to the same value. The Appellant's attorney failed to notice that the stipulation for 2017 value assessed \$528 higher than the 2017 Board of Review decision on the matter. It was never the taxpayer's intention to agree to increase the assessment with the stipulation. Accordingly, the taxpayer requests a nullification or vacation of the order. A copy of the 2017 BOR decision disclosed that it had reduced the assessment from \$25,413 to \$23,265.

On July 13, 2021, the BOR was served a copy of the Motion by the PTAB and given 21-days to respond. The BOR did not file a response.

Motion to Amend Decision

Appellants Scott Goldberg and Nilesh Patel, through their attorneys, request the PTAB to amend its final administrative decisions for Docket Nos. 17-44798 and 18-49523.

In Docket No. 17-44789, the PTAB issued a decision on May 18, 2021, resulting in a total assessment of \$199,739 based on a "rollover" of the decision issued in the 2016 tax year. The BOR had submitted its "Notes on Appeal," indicating that it would stipulate a revised assessment of \$199,739 based on a rollover of the 2016 decision of the PTAB. This decision increased the assessment of the property by \$2,825. Counsel asserts that unbeknownst to him, the Appellant had hired other counsel for 2017, and he had no authority to file an appeal for the 2017 tax year. Counsel requests the PTAB issue an amended decision to correct the 2017 assessment to reflect a no change in the assessment.

In Docket No. 18-49523, the PTAB issued a decision on May 18, 2021, resulting in a total assessment of \$77,990 based on a "rollover" of the decision issued in the 2017 tax year. The BOR had submitted its "Notes on Appeal," indicating that it would stipulate a revised assessment of \$77,990 based on a rollover of the 2017 decision of the PTAB in Docket No. 17-20512. This decision increased the assessment of the property by \$609. Counsel asserts that unbeknownst to him, the Appellant had hired other counsel for 2018, and he had no authority to file an appeal for the 2018 tax year. Counsel requests the PTAB issue an amended decision to correct the 2018 assessment to reflect a no change in the assessment.

On July 13, 2021, the BOR was served a copy of the Motions by the PTAB and given 21-days to respond. The BOR did not file a response.

Motion to Reinstate

Appellant sent in a new appeal postmarked on April 30, 2021, challenging the 2020 assessment. The Cook County Board of Review decision notice has a date of February 22, 2021, and the transmittal date for New Trier township was March 22, 2021. In counties of 3,000,000 or more inhabitants, appeals are to be filed within 30 days after the board of review notice or within 30 days after the date that the board of review transmits to the county assessor. The PTAB informed the Appellant by letter dated July 8, 2021, that the appeal was untimely filed.

On July 21, 2021, the Appellant requested the PTAB reinstate the appeal. The Appellant contends he was informed by the New Trier Township Assessor that she had spoken to the Commissioner's Office of the Cook County Board of Review and that the Commissioner's Office is in the process of sending PTAB a written confirmation that the Office did agree to extend the deadline for PTAB appeals due to a fire in the New Trier Township Assessor's Office. The Appellant requested that once the PTAB receives such confirmation, that the above-mentioned appeal be reinstated as timely filed.

Motion to Reconsider the Request to Intervene

Various Intervenors have filed Motions to Reconsider Request to Intervene and allow intervention in the above appeals.

For numerous appeals, the PTAB issued letters denying the Intervenor's request to intervene as being untimely. In denying the request to intervene, the PTAB was measuring the date of notice to the Intervenor from the BOR certificate received in these appeals, informing the PTAB when the taxing districts were purportedly notified of the appeals.

By letter dated July 30, 2021, William R. O'Shields, Chief Deputy Commissioner, notified Michael O'Malley, PTAB Executive Director & General Counsel, that, on or about March 16, 2021, April 13, 2021, and May 24, 2021, pursuant to 35 ILCS 200/16-180, the Cook County Board of Review (hereafter "CCBOR") attempted to serve copies of 2020 PTAB petitions upon certain taxing districts. O'Shields explained that the CCBOR did not finalize the 2020 tax year session until June 10th and the related 2020 tax codes had yet to be uploaded in the Cook County "mainframe." Therefore, the subject taxing districts did not receive the subject "notices" as intended.

Deputy Commissioner O'Shields explained that after being made aware of the "error," the subject "tax codes" were uploaded, and CCBOR immediately notified the impacted taxing districts on or about June 1, 2021.

Deputy Commissioner O'Shields contends this issue highlights some of the challenges of "noticing" and preparing evidence for PTAB petitions for the same year of a current CCBOR session (2020 PTAB petitions during the 2020 CCBOR tax year session).

Based on the CCBOR's acknowledgment of the date of actual notification to the taxing districts, the Intervenors contend they properly and timely intervened in the various appeals and request that the PTAB allow the intervention.
