Motion to Rescind the Default

- On March 10, 2021, Granite City C.U.S.D. #9 (the Intervenor) filed its request to intervene in each appeal.
- On April 1, 2021, the Intervenor was granted a 90-day extension to submit evidence with a due date of June 30, 2021.
- On July 30, 2021, the Intervenor was found in default due to a lack of evidence.

Counsel for the Intervenor stated he spoke with a clerk of PTAB who advised him that the last date to submit evidence was June 30, 2021.

Counsel states that he has no memory of receiving any correspondence from PTAB dated March or April 2021 outlining the date for the deadline for submitting evidence.

The Clerk of the PTAB did advise him that PTAB's computer records show that his office did access the April letter outlining that evidence was to be submitted on or before June 30, 2021.

Counsel stated that the only reason he can think of that these letters were not printed out and properly calendared was that his office computer had an email computer issue where he did lose several emails on or about the time the letter was sent.

On behalf of the Intervenor, Granite City Community Unit School District #9, counsel has retained Kevin Byrnes with the appraisal firm of Byrnes & Walsh, LLC to appraise the above-captioned property.

Based on the preceding, counsel requested that the Intervenor's finding of default be set aside and that it, Granite City Community Unit School District #9, be granted an extension to submit appraisal evidence on or before October 6, 2021. The appraiser has advised that the appraisal should be finalized by then.

IT reports that it appears that the April 1, 2021 notification was opened five (5) times on 4/1/2021.

i. Pamela Lee: #20-00912-R-1 (Lake)

Motion to Reinstate

Appellant filed the appeal with the PTAB on January 12, 2021, and requested an extension to file further evidence. With the appeal, the Appellant marked comparable sales and assessment equity as the basis of the appeal. The Appellant partially completed Section V (the grid analysis) of the form, submitted a letter/narrative explaining there are four parts to the appeal, and provided various documents and spreadsheets to support the appeal. On February 11, 2021, the Appellant was granted a Final 90-day extension to submit evidence with a due date of May 12, 2021. On July 22, 2021, the appeal was dismissed due to not providing sufficient evidence.

On August 5, 2021, PTAB received Appellant's Motion to Reinstate. She requested the reinstatement for the following reasons:

First, there was no detail attached, and it was unclear what was insufficient.

Second, Appellant believes that in the extra strain of working during the pandemic that the supporting documentation may have been misplaced or gone unrecorded. She contends that she supplied numerous documents for comparable sales and other information in the filing made on January 12, 2021. She also asserted that there are very few sales in their neighborhood, but Appellant included the most recent and relevant ones.

Motion to Reinstate

Appellant filed the appeal with PTAB on May 18, 2021, from a decision of the board of review dated January 1, 2021, and a township transmittal date of February 19, 2021. On July 22, 2021, the PTAB dismissed the Appellant for being untimely filed as the last day to file the appeal expired on Monday, March 22, 2021. The Appellant asserted that he received his Cook County Board of Review decision late with his initial filing.

On August 2, 2021, the Appellant submitted a Motion to Reinstate, asserting the Board of Review had a system malfunction and did not have Appellant's decision uploaded on its portal, nor did they mail a copy of the decision letter. The Appellant stated that he called the Board of Review multiple times in February and March and was on hold for a long time and told his property was still in review. Appellant finally obtained a copy of the decision on April 19, 2021. The Appellant attached copies of emails as proof of him contacting the Board of Review and the Board of Review (Tabitha Statkiewicz) uploading the decision to the portal on April 19, 2021. The Appellant contends he submitted the appeal to the PTAB on May 18, 2021, which was within 30-days of the date the Appellant received the decision. The Appellant contends he could not have sent the appeal earlier as his wife was sick with Covid-19, and he and his two children were in self-isolation. (Attached is a letter showing proof of wife's positive results.)

Motion to Set Aside July 22, 2021 Dismissal and Reopen Appeal

On November 19, 2020, Appellant was granted a Final 60-day extension to submit evidence with a due date of January 18, 2021, in each appeal. On July 22, 2021, Appellant was dismissed due to the information submitted not satisfying the burden of going forward. On August 10, 2021, Springfield Realty, LLC filed with PTAB a "Motion to Set Aside the July 22, 2021 Dismissal and Reopen Appeal" for each of the above-referenced matters. Counsel made the following contentions in each appeal:

1. Appellant's counsel cannot confirm its receipt of correspondence from PTAB granting or denying its initial extension request in this matter.

2. Appellant first became aware of the PTAB's dismissal of this matter via email correspondence on July 22, 2021.
3. Appellant's counsel acted expeditiously to remedy this default.
4. The enclosed Appraisal by Collins Real Estate Advisors, LLC, was completed just one business day ago, on Friday, August 6, 2021, and filed as evidence to meet the Appellant's initial burden of proof.
5. Setting aside the dismissal and reopening this appeal will not prejudice the Sangamon County Board of Review, or any potential intervenors. Each of them will still have the opportunity to obtain valuation and rebuttal evidence pursuant to Section 1910.40 and Section 1910.60. Wherefore, Appellant respectfully moves the Board to set aside its dismissal and Reopen this Appeal.

Motion to Reconsider the Request to Intervene/BOR Sanctions – this item is being carried over from the Board's August meeting, item 5cc.

In summary, various Intervenors filed Motions to Reconsider Request to Intervene in the above appeals because they were previously denied as untimely.

In denying the request to intervene, the PTAB measured the date of notice to the Intervenor from the BOR certificate received in these appeals, informing the PTAB when the taxing districts were purportedly notified of the appeals.

By letter dated July 30, 2021, William R. O'Shields, Chief Deputy Commissioner, notified Michael O'Malley, PTAB Executive Director & General Counsel, that, on or about March 16, 2021, April 13, 2021, and May 24, 2021, pursuant to 35 ILCS 200/16-180, the Cook County Board of Review (hereafter "CCBOR") attempted to serve copies of 2020 PTAB petitions upon certain taxing districts. O'Shields explained that the CCBOR did not finalize the 2020 tax year session until June 10, and the related 2020 tax codes had yet to be uploaded in the CCBOR's "mainframe." Therefore, the subject taxing districts did not receive the subject "notices" as intended.

Deputy Commissioner O'Shields explained that after being made aware of the "error," the subject "tax codes" were uploaded, and CCBOR immediately notified the impacted taxing districts on or about June 1, 2021.

Deputy Commissioner O'Shields contends this issue highlights some of the challenges of "noticing" and preparing evidence for PTAB petitions for the same year of a current CCBOR session (2020 PTAB petitions during the 2020 CCBOR tax year session).

Based on the CCBOR's acknowledgment of the date of actual notification to the taxing districts, the Intervenors contend they properly and timely intervened in the various appeals and request that the PTAB allow the intervention.

At the previous meeting, the Board voted to grant the request to intervene in each appeal, provided the request to intervene was filed within 60-days of the board of review notification of the appeal.

The CCBOR did not timely send notice to the taxing districts as required by Section 1910.40(f) of the PTAB's rules requiring boards of review to notify the taxing districts within 30-days of receipt of an appeal in which a change in assessed valuation of \$100,000 or more is sought. Section 1910.69(a) of the PTAB's rules provides for the default of a party for failure to comply fully with PTAB's rules, including Section 1910.40.

PTAB's board held this matter of sanctions over to this month so staff could contact the CCBOR to determine if the issue which caused the late notice was fixed.

7. Other Business:

a. Final extensions: PTAB's staff is requesting that the Board give authority to grant "final" extensions for a party to submit evidence to the Executive Director or his designee. This would only apply to the first "final" extension and be uniform across the state. If a party was given a "final" extension by staff, any subsequent "final" extension would need to be presented to the Board. To illustrate the proposal, item "g" of the motion portion of this agenda would be handled by staff, but if any other request for extension is filed, it would have to be presented to the Board. This change is being requested to free up the time of staff to work on other issues and move matters through discovery at a quicker pace. Our rules would authorize a hearing officer to grant an extension under 1910.67(h).
