The board of review explained that on September 30th, 2021, the appraiser who was to

prepare the report informed the board of review that he could not complete the assignment due to medical issues. A copy of the e-mail from the appraiser to the Chief County Assessment Officer was submitted.

The St. Clair County Board of Review was notified of the appeals on July 15th, 2021, and granted a 90-day extension to submit evidence with a due date of October 13th, 2021. By e-mail and a letter received on October 13th (no postmark date), due to a hefty workload and a small staff, the St. Clair County Board of Review requested a 60-day extension to evaluate the evidence submitted by the appellants and prepare its summation of value.

The St. Clair County Board of Review was notified of the appeal on July 15th, 2021, and granted a 90-day extension to submit evidence with a due date of October 13th, 2021. site. The appellant is requesting an assessment reduction of approximately \$1,860,000.

The Kane County Board of Review was notified of the appeals on July 22nd, 2021, and granted a 90-day extension to submit evidence with a due date of October 20th, 2021. By letters postmarked of October 14th, 2021, the Kane County Board of Review requested an extension of time to review and complete evidence to file.

Motion to Vacate Default

By letter dated November 6th, 2020, the Chicago Board of Education filed a request to intervene with Property Tax Appeal Board and requested a hearing. By letter dated November 19th, 2020, the intervenor was granted a 90-day extension to submit evidence with a due date of February 17th, 2021. On September 16th, 2021, the intervenor was found in default since no evidence was submitted by the established deadline. The intervenor requested that the default be vacated by e-mail to the PTAB Clerk on September 28th, 2021. Specifically, counsel argued appellant's appeal is based upon a claim of exemption, not upon the underlying valuation of the property. Therefore, the intervenor did not obtain any appraisal evidence. However, the intervenor would like to reserve the right to participate in and question any witness presented by the appellant at the hearing in this matter.

Motion to Reinstate

In an envelope postmarked August 20th, 2021, the Property Tax Appeal Board received these 2019 appeals from the appellant. The appeals were filed from decisions the Property Tax Appeal Board issued on July 20th, 2021, for the 2018 tax year as allowed by section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). On September 16th, 2021, the appeals were dismissed for being untimely filed. The appellant requested reinstatement asserting the appeals were timely filed on August 20th, 2021.

Motion to Reinstate

By enveloped postmarked date of April 27th, 2021, the Property Tax Appeal Board received a 2020 appeal from the appellants. On July 8th, the appeal was returned as incomplete because the appellants did not include a copy of the board of review decision to establish jurisdiction. By letter dated September 9th, 2021, the appeal was dismissed for failure to respond to the incomplete appeal. By letter postmarked September 15th, 2021, the appellants asserted they responded to the incomplete appeal on July 12th, 2021, by submitting a copy of the board of review's final decision by United States Mail. A copy of the board of review's final decision dated February 22nd, 2021, was submitted with the Motion to Reinstate. On New Trier Township letterhead, the appellants offered a signed statement asserting "[w]e were told that as owners of real property in New Trier Township who were dissatisfied with the results of our appeal to the Cook County Board of Review, that we had until April 30th, 2021 to file by mail our appeal to the Illinois Property

Tax Appeal Board due to the fact that there had been a fire at the New Trier Township office building and that the New Trier Township Assessor's Office has been closed in that building since the fire. Please accept this appeal as timely filed." Therefore, the appellants requested reinstatement asserting the appeal was timely filed by postmark of April 27th, 2021.

Motion to Reinstate

The appellant is self-represented and filed the appeal on March 11th, 2017. The board of review timely filed its evidence explaining the subject property is an owner-occupied dwelling that was the subject matter of an appeal before the PTAB in the 2015 tax year in which the assessment of the subject property was reduced based on an agreement of the parties. The PTAB's decision for the 2015 tax year was issued on April 21st, 2017. On April 27th, 2017, a Certificate of Error was approved, reducing the 2016 assessment of the subject property using the assessed value as established by the PTAB decision for the 2015 tax year adjusted by the 2016 township equalization factor.

By letter dated August 9th, 2018, the 2016 appeal was set for a hearing on November 26th, 2018. The appellant failed to appear for the hearing. By letter dated December 22nd, 2020, the appeal was dismissed for failure to appear at the hearing. (The ALJ assigned to the hearing noted in PTAB2000 that the dismissal letter was inadvertently not sent right after the hearing). By letter postmarked October 5th, 2021, the appellant stated it was recently brought to his attention that the 2016 appeal was dismissed due to a "no show." The appellant requested reinstatement due to not being notified. The appellant provided no response as to why he did not appear at the scheduled hearing.

Objection to Reinstatement

On December 3rd, 2019, the attorney of record was transferred from Michael Stone to Lena Henderson, both attorneys at Abbey Road Tax Consultants. By letter dated March 29th, 2021, the matters were set for hearing on June 24th, 2021. The appellant's counsel failed to appear at the hearing. At the hearing, the ALJ assigned to the appeal verbally informed opposing parties that the appeal would be dismissed for failure to appear. However, that same day the ALJ e-mailed all parties to disclose she was notified that Lena Henderson had passed away and the appeal would not be dismissed but postponed so the appellant could retain new legal counsel. By e-mail dated June 25th, 2021, the attorneys for the intervenors

objected to any continuances arguing that Ms. Henderson was not a solo practitioner and worked at a multi-lawyer firm specializing in property tax matters. The intervenors argued that Ms. Henderson's law partners had an obligation under the rules of professional responsibility to avoid neglect of her files by diligently transitioning them to other attorneys. For the property owner to have proper notice of the aforementioned events, by letter dated August 12th, 2021, dismissal notices were mailed to both Lena Henderson and the property owner, Strategic Properties of North America in New Jersey. By letter postmarked on August 25th, 2021, Harold J. Hicks of Madigan & Getzendanner filed a motion to substitute and requested reinstatement of the appeal. The motion to substitute was granted by order of the Board's Executive Director. The motion to reinstate the appeal was granted and served to all parties by letter dated September 8th, 2021.

By letter postmarked October 1st, 2021, the intervenors objected to reinstatement, arguing the Property Tax Appeal Board entered an Order of Dismissal on August 12th, 2021, well in advance of the appellant's Motion to Substitute. The intervenors argue that the Property Tax Appeal Board rules do not provide for a motion to reconsider the dismissal. The intervenors argued the appellant could have sought review under the Administrative Review Law, 735 ILCS 5/3101 *et seq.* Thus, the intervenors object to the reinstatement of the appeal.

Motion to Vacate Default

Between July 21st, 2021, and August 11th, 2021, the board of review was found to be in default for not submitting its "Notes on Appeal" or evidence in support of its assessment of the properties. The Cook County Board of review asserts it attempted to timely submit substantive, documentary evidence in support of its position, the "Notes on Appeal," with an indication that the board of review would stipulate or a fully executed stipulation. The board of review explained that its system stamps the electronic file for each docket with a date. A timer runs nightly at 8:00 PM that exports the corresponding evidence (PDF) to a folder, creating a

text file. The docket, primary pin, hearing requested, and the Notes sent date are stamped in a text file. Each subsequent docket is appended with the same field to the daily text file. The board of review presented a spreadsheet showing the dates that the board of review transmitted its responsive pleadings to the PTAB. Due to a "transmission error" from May 29th to May 31st, the Cook County Board of Review was unable to establish a connection with the PTAB's "remote server." Therefore, the board of review requested the PTAB vacate its finding of default; make the board of review submission a part of the record; amend its docket to indicate the board of review timely submitted evidence, and set the matter for hearing on the merits.

Motion to Vacate Decision

On December 15th, 2020, the Property Tax Appeal Board issued final decisions in these matters based on an agreement by the parties. The appellant and board of review entered into stipulation agreements with respect to the 2016 through 2018 tax years, agreeing that the correct assessment for the subject property was \$87,250. The stipulations were entered into on the belief that the assessment for the triennial was \$92,745 each tax year. However, this was incorrect, and the 2017 and 2018 assessments had already been revised by the board of review. As a result, the Cook County Treasurer issued open item real estate tax bills for the tax shortage. The appellant requests the PTAB vacate the decisions based on incorrectly assumed 2017 and 2018 assessments and were not contemplated by either the appellant or the board of review. Additionally, the appellant requests that the appeal be withdrawn.

Motion to file new appeals and rebuttal evidence untimely due to mailing error.

The appellants' counsel requested the Board accept the nine new appeals and rebuttal evidence for five appeals that were received late. The documents were timely mailed by certified mail on June 11th, 2021. However, an internal error was made with the mailing when the staff inadvertently put the law firm's mailing address on the envelope instead of the Property Tax Appeal Board mailing address. The attorney submitted a photocopy of the envelope that was supposed to be mailed to the PTAB depicting the law firm's mailing address and a postmark date of June 11th, 2021.

Motion - Request to Intervene

The following is a brief recitation of the pertinent facts and dates:

- 6/6/2019 – The appellant, through counsel, filed its appeal with the PTAB.
- 01/09/20 – The appellant was granted an extension until 3/9/20 to file its evidence.
- 3/5/20 – The appellant timely filed its evidence.
- 8/6/20 – The Cook County Board of Review was notified of the appeal, which seeks a reduction more than \$100,000 in assessed value.
- 9/2/20 – Date the taxing districts, including the movant, City of Chicago, were notified of the appeal per the CCBOR's certificate of notice sent to the PTAB.
- 11/2/20 – Deadline for taxing districts, including movant, to file intervention. Rule - 1910.60(d)(1)(A)
- 6/9/21 – The City of Chicago filed a motion to intervene claiming it never received notice of the appeal from the CCBOR.
 - The City of Chicago asserts that after receiving notice of the 2019 PTAB appeal for the subject property, the City engaged in an additional investigation regarding the appeal history for this property and discovered the existence of the 2018 appeal for the subject property. The City then contacted the Cook County Board

of Review to determine why the City never received formal notice of this appeal from the Board of Review. The City then promptly filed this Request to Intervene in the 2018 appeal. Attached to the Motion are affidavits from Richard G. Danaher, Chief Assistant Corp. Counsel, and Mark Roschen, Assistant Commissioner for the Department of Planning and Development for the City of Chicago, asserted that they did not receive actual notice of the appeal until an e-mail from Matthew Zenner on April 15th, 2021. Danaher asserted that if he had received notice of the 2018 appeal, he would have filed a written request to intervene.

- (07/21/21 – Daniel Pappano filed his appearance on behalf of the appellant because the appellant’s original attorney of record passed away.)
- 8/17/21 – The City of Chicago’s motion to intervene first appeared on PTAB’s agenda. The City of Chicago was represented by an Assistant Corporation Counsel (ACC). The ACC informed the Board that the CCBOR sent an e-mail to the City of Chicago informing the city of the appeal to an e-mail address of a former ACC. Therefore, the e-mail was not received by any current ACC or anyone else at the city.

After the August board meeting, the Executive Director ordered briefs on the matter with a final due date of October 26th, 2021. The appellant filed a brief on October 12th, 2021. The City of Chicago filed its brief and response on October 21st, 2021. The Cook County Board of Review did not file a response.
